On the evening of the 30th British officers appeared at the Base and requested the handing over to them of the above mentioned premises including the refrigerator and stoves.

Base 9 will transfer to LECCE, however, in view of the fact that the refrigerator and stoves are the private property of the officers, their return (or at least the return of the refrigerator) is requested.

MEMORANDUM TO: General Roatta, Chief of Staff.
Royal Italian Army.

I wish to acknowledge receipt of your document No. 123/AG. Prot. COGITTO; Alloggiamenti truppe anglo-americane, originating from Headquarters, Seventh Army.

The Allied Military Mission is aware of the acute situation in certain localities resulting from the requisitioning of public and private buildings. This is felt, however, to be the inevitable consequence of the building up of a large military force in an area comparatively poor in housing facilities.

The Mission is ready to investigate specific cases where the application of the requisitioning policy results in the taking of buildings particularly necessary to Italian enterprises. In such cases, however, the action of the Mission must necessarily be limited to inviting the attention of the Senior Allied Headquarters to the unfortunate effect of the requisitioning in question.

PERSONAL MEMORANDUM - No. 1

SUBJECT:- Requisitioning of Accommodation

To:- Sub Area Comds

1. Cases occur from time to time when the Italian authorities resist demands for the requisitioning of buildings, and unless this situation is handled firmly from the outset it will get out of hand.
2. The policy to be adopted is a simple one. If you are satisfied that it is necessary to acquire accommodation or storage to meet the reasonable requirements of the Allied Forces, then requisition must be insisted upon. Any refusal or delay on the part of Italian authorities to comply with the requisition, which cannot be settled locally, will be reported at once to District HQ.
3. It is left to you to decide what is reasonable and what is not. It is not our custom to inflict unnecessary hardship on the civilian population of any country in which we are operating, nor would it be common sense to deprive the Italian Armed Forces of property which is clearly required by them to carry out the operational and labour duties which we require of them. In appropriate cases e.g. the taking over of a hospital or barracks, I would expect you to consult the local representative of A.M.C. or your Italian Liaison Officer, and in any case of disagreement you will have to refer to District HQ. I will at once consult the Allied Commission or Military Mission to the Italian Army as required and let you have a decision.
4. To sum up, once it is decided that Allied requirements are paramount, no resistance by any Italian authority will be tolerated nor will procrastination be permitted.

With reference to your A 207 dated 21 Nov 43.

1. It is confirmed that the theatres "Verdi" and "Impero" have been requisitioned for the Allied Forces. The former ("Verdi") is really the Opera House and has not been used for months if not years. It took a week to clean.
2. Therefore the public have only been deprived of the Cinema "Impero". There are still two other places of amusement available for the local inhabitants. (a) A Variety Theatre and Cinema holding 650. (b) A Cinema for 250. The local authorities were requested to open the latter which has been closed for many months, and a weeks notice was given for the purpose when the "Impero" was requisitioned.
3. I realise that there might be some hardship inflicted on the local inhabitants and Forces if the "Impero" was taken over and only as a last resort was this carried out. There is no other suitable accommodation for an E.F.I. Canteen and even this "X" Cinema can only seat 350 instead of 600 which is what is required. I had an expert E.F.I. Committee down for the purpose of selecting a site and they worked in close co-operation with my staff and the Town Major. No other site could be found.
4. Before taking any action in the matter, I personally visited General Aliberti, Comando Militare di Brindisi who referred me to General Comanducci, Pressidio Militare, Brindisi, and the Mayor of Brindisi was fully consulted in advance of any action being taken. These responsible officials raised no objection whatsoever and in fact assured me most definetely that adequate facilities remained and I need not have any anxieties on the subject.
5. I appreciated the fact that some Italians would be disappointed at whatever requisitioning was undertaken and this is inevitable. The satisfaction now being given through the Cinema (Opera House) and E.F.I. Canteen to Allied Troops must fully justify the risk taken.
6. I would be grateful if this letter is shown to the District Commander in order that he may be fully informed in the matter.

Dear General Joyce:

I have been informed that your Military Authorities are about to requisition the premises of Manifatture Cotoniere di Napoli, Poggio Basco, ordering the almost immediate clearance of all cotton thread machinery installations, fortunately not damaged by bombings.

This is a concern which hopes to resume its normal activities shortly, giving employment to about 3000 workers; you cannot but realize the serious damage which would be wrought upon our already sorely tried industrial structure if this requisition should take place.

I strongly beg of you to intervene so that in the event of absolute necessity only half the establishment be occupied, that part where no machinery is mounted; for the other half needed, other premises located in the vicinity could be requisitioned.



Dear General Joyce:

The Allied Military Authorities have proceeded to requisition several wine establishments in Brindisi, which are at present full of newly made wine not yet ready for consumption.

Now, it is not possible to transfer this wine elsewhere, primarily because there is no other adequate place, with proper equipment, in Brindisi, and also because at this time the wine is yet in a state of fermentation and any necessary decanting to move it would almost certainly spoil it beyond remedy.

A voiding of the requisitions seems desirable; if this is impossible, they should be delayed. In any case, what I strongly recommend is that the industrial equipment of these firms (machines, motors, pulleys, belts, etc.) be not damaged, since they serve local industries which can be said to constitute the only means of employment of the city's population.

1. The Italian authorities have represented that, before load carrying vehicles are requisitioned by the Allied authorities, consideration should be given to the nature of the work they are performing.

Among other things, wishing to move to Portici, a stock of approximately 60,000 quintals of Superfosfora Minerale, uses mechanical means which result in serious loss in the handling of said stock, which today is very valuable because of the scarcity of this product and its need at the present time.

The intervention of the AMGOT has not had any effect whatsoever, when it was so informed by the Directors of the Society.



1. The plant SOCIETA MONTICATINI at Bagnoli is occupied as an Ordnance Motor repair shop under Peninsular Base Section control. Due to demolition damage and lack of guards the plant and stock of fertilizer material were both exposed to serious depreciation and loss prior to occupancy as an Ordnance Shop. Since occupancy the plant has been under guard and all reasonable precautions taken to prevent loss.

2. Approximately 25% of the fertilizer which was on hand has been moved by Ordnance Section, Peninsular Base Section to other locations as requested by local A.M.G. authorities. The remainder, is being moved to covered storage within the plant area which was selected and approved by the plant manager.

3. That part of the plant which contains the important machinery for producing fertilizer has not been disturbed and is accessible for any desired work of rehabilitation.

4. The above information which was furnished this Headquarters by Ordnance Section, Peninsular Base Section indicates that the fertilizer materials and the plant itself are being safe guarded and preserved rather than depreciated by the present occupants.





EDUCATIONAL PREMISES

Note for the Supreme Command

The reopening of the schools, which was arranged for the 11th October has met with insuperable difficulties in view of the almost total requisitioning of educational premises by the Armed Forces. It may be said that this state of affairs has rendered it impossible in many centres to recommence lessons, with results which can be imagined and which must be obviated at once.

The gravity of the situation is shown by the following figures (especially in the provinces of Bari, Brindisi and Taranto)

1	Province of Bari	Existing schools rooms	3005 requisitioned	2880
2	" of Brindisi		662	598
3	" of Lecce		1586	650
4	" of Taranto		1014	993

Whilst we hope to interest the Allied Military Mission in the grave question, we beg to point out to you the urgent necessity for the derquisitioning of part of the occupied establishments, in order that the schools, perhaps with some changes of time table and the more rational use of the premises rendered available, may be able to recontinue their vital functions.

The Educational authorities are at your disposal to indicate the minimum requirement of classrooms in each locality and in each building, according to whether the Armed Forces decide to free whole buildings, which can be used in turn by different institutions.

We would finally point out the necessity, indicated by the Prefetti, of the restoring the material and furniture, which were taken away, in order that the availability of the classrooms should not be rendered useless through lack of indispensable materials, and in order that the property of each establishment may be restored in full.

A reply stating what steps are being taken, will be appreciated.

1. The attached letter No. 2848/AC from the Civil Affairs Office for the Supreme Command, on release of educational premises from requisition, has been forwarded to this HQ by Col VALLONE, Italian Liaison Officer attached to HQ No 2 District. *

2. It is realized that a number of schools are at present occupied by troops of the Allied Forces and that this must inevitably create a problem for the Italian Educational Authorities. They should, however, be aware of the difficulties which are being met in finding accommodation for British, US and Italian Forces, and will appreciate that it is impossible at the present juncture to release any accommodation which has been already requisitioned.

3. 1. As you are aware, under the terms of the Armistice with the Italian Government, that Government is pledged to make available to the Armed Forces, such local resources and services as are required.
2. These instructions were contained in AFHQ signal 8860 dated 10 Nov 43. As however, there was no efficient and central Italian Government established at that time, it was not possible to adopt the above procedure for obtaining the various materials which were available in the country, and which were urgently required for the furtherance of the campaign.
3. In consequence, requisitioning procedure had to be adopted, and in a number of cases factories have been requisitioned in order that they should be able to continue in production. Where factories have been requisitioned, their operation has been controlled by the interested service at this HQ, and it has been necessary for the service concerned to undertake full administrative responsibility.
4. This operation of factories by the military has worked very satisfactorily. It adds however, a burden to the Armies which is not normally anticipated and which is certainly not envisaged in the terms of the Armistice. Further expansion of the Armies and extension of the area under Allied control will make it more difficult, and it is considered essential that the necessary machinery should be set up by the Italian Government as soon as possible, in order that responsibility for administration of essential factories be removed from the military.
5. It would be appreciated if you consider this question, and advise this HQ as to what steps are being taken by the Italian Government to fulfill their obligations under the Armistice.

Dear General MacFarlane,

71 Sub Area Command of Brindisi has intentions of requisitioning the entire building of the Casa di Reclusione (House of Reclusion) of Lecce.

This building contains much fixed machinery, mounted on reinforced concrete bases; they each weigh several quintals and are used for industrial shops, under endowment to the Institute (carpenter shops - smithies - shoe-making shops - tailoring - laundry). These shops are working on many current orders to furnish thousands of chairs, tables and benches for the Ministry of the Navy; "Z" nails for the Ministry of War, and this should be of interest also to Allied Headquarters; mountain boots and aviator boots for the Ministries of War and of the Air; clothing for numerous military commands. The laundry, besides, services all Armed Forces of Lecce and environs.

It does not seem advisable, in view of the above, to occupy the entire building, because it is impossible to establish elsewhere the industrial machinery of which some, like that for making shoes, are the only units now in existence in liberated territory able to fill orders in the least amount of time. The Ministry of Justice proposed, in the beginning, the giving up of the building, except for the carpentry shed, the smithy, the laundry and annexed store-room and some premises on the ground floor which are indispensable to the continuance of work and services. Afterwards, the Ministry of Justice proposed the entire building of the Carceri Giudiziarie (Judiciary Prison) of Lecce as a substitute.

This establishment has a capacity of 800 places, compared with the maximum capacity of 220 places at the Casa Penale, and it could be used for the Military Prison about to be set up, for which the requisitioning of the Casa Penale is requested.

The first proposal was not acceptable to Allied Headquarters because the reduced space of the Casa Penale was insufficient for its needs, the second proposal, instead, was accepted by the Allied Control Commission, which handled the matter.

Recently the Commission declared that it would take no interest in the matter, because it had received from the Military Command precise dispositions in the requisitioning of the Casa Penale, the proposal for cession of the entire premises of the Carceri Giudiziarie of Lecce not having found acceptance, and it turned over the matter to the Higher Command of Bari (Second District).

The Second District remitted the question for competence to the 71 Sub Area Command of Brindisi.

This last states it is following an order of AFHQ at Algiers.

In consideration of the difficulties which inject themselves in the proceedings for requisitioning and of the obvious damages which the State would suffer, in reference to the situation and to the considerations stated above, I beg of you, dear General, to explain to the Higher Command the existing state of affairs, with the understanding that the proposals already presented go no further, and that the Casa di Reclusione may be considered as of now at the disposal of the authorities which intend to proceed to requisition it, excluding, however, those above mentioned premises which house fixed or indispensable machinery for governmental production or orders.

The devastation of various parcels of ground and the occupation of the larger part of the premises, especially the library (of which the directors of the Station are in constant need), compel almost total suspension of the activities of this Institute, which flourished handsomely in the past.

In view of the above, I beg you, dear general, in the common interest--since the bettering of the agricultural situation is also an important factor in the cooperation proposed between us--to study the question of moving out the British unit which occupies the Station at present (section of COY, Signal Corps) and substitute it with an Allied office, possibly of an agricultural or economic character, with which we will be glad to cooperate by putting at their disposal all our experience and technical equipment of the Institute.

If such substitution cannot be made, at least the library and the director's office could be returned. Such a step would not inconvenience the occupying unit, because only a few men sleep in the two rooms at the present time, and they could easily find place elsewhere in the building.

Please accept my thanks for whatever you may be able to do in this matter.

SUBJECT: Living Premises of the Family LATERZA

1. I am informed that there is a possibility of the apartment at No. 19 Piazza Eroi del Mare, 4th floor, being requisitioned.

2. This apartment is occupied by Giuseppe and Franco LATERZA, together with their families consisting of eight persons, including three women and three children. This family has already been evacuated at short notice on a requisitioning order from their villa in Via 28 Ottobre, Cancellotto, No. 5, a fortnight ago.

3. The requisitioning of their villa constituted a political handicap to Allied interests as it had been earmarked as a meeting place for Count Sforza, Benedetto Croce and other political figures identified with present Governmental developments. These difficulties, however, were overcome when the LATERZA family managed to get a footing in their present flat at Piazza Eroi del Mare 19.

4. Over and above the political affinities of the LATERZA family and over and above the fact that the family has long been identified with constructive anti-Fascism, they are the managing proprietors of a printing and publishing establishment which has been requisitioned lock, stock and barrel for the work of the 15th Army and of P.W.B. Within this printing scheme the LATERZA brothers are included as supervising directors, as the printing work involved means that the machinery is running practically 24 hours a day. It is obvious that they must live within the town of Bari.

5. In view of the above circumstances I would urge that the LATERZA family be left undisturbed in order to carry out their duties on behalf of army and Government printing obligations.

This is in reply to your letter (No. 10031/OP) dated 2 January 1944. according to our understanding, as Allied Operation requirements forbid the present release of buildings recently requisitioned, Headquarters 71st Sub Area have made and are making every effort towards remedying the accommodation shortage. Measures in hand include the construction of walled-in billets, including sanitary facilities and kitchen, in the Railway Arches on the San Vito Road, the loan of additional British Army tents, the provision of materials to repair existing huts and assistance in collecting and re-erecting huts found to be available elsewhere in 51 Corps Area. These measures should ensure adequate accommodation for the additional military labour which is due to come to Brindisi.

We do not understand that accommodation for the 700 additional Naval personnel presents a problem. A fortnight ago, Admiral Rubartelli was ordered by the Comando Supremo to make available to the Italian Army the vacant huts in the SACA Compound. This order was set aside because it was stated that the huts were needed to house 700 sailors expected any day from Taranto. These men have still not arrived. The vacant billets are waiting for them, and Naval labour is still over 300 men short of the figure of 1000 which should have been maintained all along.

In view of the foregoing, it would appear that the billeting situation, critical as it is, is nevertheless adequate for the required number of deck laborers.

For your information the Palazzo Hotel at Santa Cesarea was formally requisitioned by this Headquarters through Headquarters 71 Sub Area on 31 October 1943 and the requisition form is held here.

Officers from this Headquarters will neither be billeted in the hotel nor relieved from billets therein without written authority from this Headquarters.
