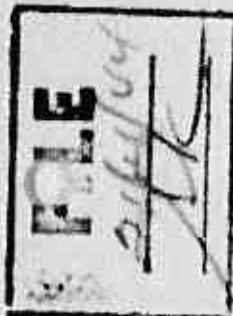

SUBJECT: - Return of Warlike Stores.

1. Reference H. 1., A.C.C. Hotline Order No. 2 dated 13 ~~June~~ ^{March} 1944, calling for return of Warlike Stores.
