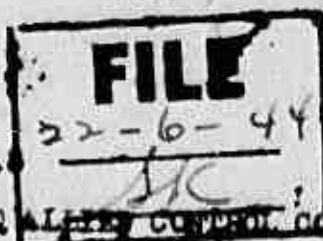

SUBJECT: Elimination of Unnecessary Correspondence.
