"3. For your information, on and after 1200 hours today (20 June 44) the designations of these two Headquarters will be as follows:

HEADQUARTERS, ALLIED MILITARY GOVERNMENT, REGION VIII - Located North of Rome.

REAR HEADQUARTERS, ALLIED MILITARY GOVERNMENT, REGION VIII - Located in NAPLES - Valturba Hotel.

4. The term Advanced Headquarters will no longer be used but any messages pending from forward to NAPLES for Region VIII will be for this (Rear) #1. In the same way all correspondence dispatched by you will continue to be sent to this location."
