DATE: 28 Sept. 43

1. In reply to your R 5/1056 dated the 9 Sep 43, the position is that geographically and economically the Republic of San Marino is part of Region 9 and not 5. Region 9 will therefore be responsible for this area.
2. Great Britain is at War with the Republic but not the U.S.A. It follows therefore that under AMG only British C.A.Os. should enter the Republic.
3. The position under Armistice C.C. does not at present arise as no armistice has been concluded with that great nation.
