2. I appreciate the cogency of the present duties of Major Wilcox, but when it is expedient I should be glad if he could be posted in Region VII when he could be replaced by another Officer.

3. Similarly Capt J. McKay, a C.A.P.O. serving in Sicily has been earmarked for promotion as Major and for posting to Region VII where his practical experience would be invaluable to the Planning Staff. I therefore strongly recommend the transfer of the Officer when it is possible.
