TO : G-3

1. Referring to letter from this section, 4 October 1943, subject, move of AMG personnel, it is requested that action may be taken without delay on paragraph 2 thereof, in the form of an appropriate direction to Movements and Transportation.

2. Movements and Transportation has informally advised that an advance party of 25 officers and 75 EM/OR's with transport as listed in previous memorandum could embark at Algiers on the 15th, moving via Bizerte to arrive Palermo about the 25th.

CONFIDENTIAL

TO : G-3

URGENT

1. Consequent on a meeting between the Chief of Staff and General Holmes this morning there has been a change of plan for the movement of AMG personnel to Italy. May the following 2 moves be approved and given a high priority.

2. (a) Advanced H.Q. Allied Commission are now required to move to Palermo on Thursday 7 October or as soon after that date as possible.

(b) This party now consists of 25 officers, 75 RM/ORs, 6 Humber saloons, 5 jeeps, 3 x 15 cwt, 4 x 3 tonners.

(c) This move would be much simplified if embarkation could take place at Algiers, but if it has to be from Bizerte 2 troop carriers would be required.

3. (a) It is proposed to make use of the movement arrangements referred to in my MES 370.5-9 of 1 October 1943 and cable 2916 of 4 October 1943, to move a portion of No. 4 Region AMG to Taranto.

(b) This party consists of 40 officers, 50 RM/OR, 17 vehicles and 2 m/c's.

(c) They have been promised highest priority by 15 Army Group.

4. Both the above moves have become very urgent owing to the progress of operations.
