SUBJECT: Maintenance Personnel Region 6.

TO : JACS

1. No official and final instructions with regard to the above have yet been issued. It is, however, anticipated that rations will be drawn through American Units in SARDINIA, and will therefore be American type rations.

2. If this is in fact to be the case the following arrangements will probably be made with regard to the extra entitlement of British personnel.

(a) S and T free issue (e.g., air mail letter card, cigarettes, etc.)

(i) It is suggested that one or two months supply be taken by the rear party of Region 6.

(ii) S and T will probably arrange for suitable quantities of the above to be sent over from time to time, with American rations in bulk.

(b) E.F.I. Supplies.

(i) These must be paid for at the time of issue from depots in North Africa and no credit can be given.

(ii) It is suggested that at least one months supplies be taken by the rear part of Region 6.

(iii) Arrangements for subsequent supplies present some difficulty, owing to the very great danger of pilferage if supplies are dispatched through M.F.O. or other agency. It is therefore considered that these supplies will have to be entrusted to a particular individual proceeding to SARDINIA, either by sea or by air. There will no doubt be frequent visits

SUBJECT MGS Holding Centre.

There are several hundred British and American officers at Tizi Ouzou in our Holding Centre there and a continual turnover, some coming from England and the States and others going into the field. It has been repeatedly noticed that these officers find considerable difficulty in understanding the system of military supply channels and administration in this theatre. It would, therefore, be of the greatest assistance if you could find time to visit Tizi Ouzou and give a lecture explaining on broad lines how the organisation works. We have already had the advantage of visits from some of you staff and I know a talk by you would be greatly appreciated. I gather General Adcock is now away but we should like also for him to address the school two or three weeks later when there will have been a considerable change in the personnel.

A lecture could be laid on any time. If you prefer after dinner there are quite comfortable quarters for the night.

1. It is desired to bring the position as regards typewriters at this H.Q. to your notice, in the hope that means may be found to improve matters.
2. The number of typewriters at present available for use in these offices is 8, and, at present, these have to be shared by 42 clerks, so that the machines have necessarily to be kept in a pool.
3. In these conditions there are serious difficulties and delays in producing typed matter, which in turn militate against the prompt and efficient execution of planning duties and result in insufficient priority being accorded to matters of great urgency.
4. A fresh contingent of 240 British Other Ranks and a further party of American Enlisted Men, both parties including a considerable number of clerks, - are expected to arrive at this H.Q. by the end of September.
5. Unless there is a substantial increase in the number of typewriters by that date, work will be still more delayed and it will not be possible to utilise to the full the clerical capabilities of the new arrivals.
6. It is therefore, earnestly requested that 25 additional typewriters be made immediately available for these offices. This would permit of a limited distribution to Headquarters Staffs of Regions and would very greatly accelerate the rate of progress and improve the general efficiency of the organization.
7. May this representation be accorded high priority, as this lack of typewriters is hampering organization at every turn and threatens to produce a complete breakdown.
