BIGOT HUSKY. PERSONAL FOR MILLER FROM SPEED

1. EXPECT SECURE AUTHORITY CONTINUANCE OF NORTH AFRICAN RATE COLONIAL ALLOWANCE IN HORRIFIED AND ALSO MALTA AS FROM DATE OF OPERATION. FURTHER INSTRUCTIONS WILL BE ISSUED SOON. HORRIFIED WILL BE DECLARED FIELD ALLOWANCE AREA.
2. TO AVOID INFLATION HORRIFIED WE ARE CONSIDERING DESIRABILITY OF REDUCING STILL FURTHER AMOUNT OFFICERS FIELD ADVANCES AND LIMITING WEEKLY DRAWING OF ORS AND FORBIDDING APPEAR WITHDRAWALS ABROAD. NO RPT NO ADVANTAGE IN DOING SO IF IN FACT DRAWINGS AND FIELD ADVANCES ALREADY LOWER THAN ANY REASONABLE LIMIT WE COULD FIX.
3. TELEGRAPH URGENTLY VIEWS AND WHETHER CONSIDER SIMILAR ACTION MALTA DESIRABLE.
