AMCOT - 15 ARMY GROUP.15AC/7871/A/9AORDERS FOR DUTY OFFICER.

1. His tour of duty shall extend for a period of 24 hours, commencing at 0600 hours daily.
2. He will inspect the mess' breakfast, lunches and suppers, at the times notified in Camp Routine Orders, and will report and attempt to remedy any complaints made.
3. He will, between 1000 hours and 1200 hours, make a tour of the H.Q. area inspecting all billets, cookhouses, ablutions, latrines, etc., and will report on their state of cleanliness and efficiency.
4. He will inspect the guard and all sentries between 2300 hours and 0600 hours.
5. He will remain in the H.Q. Officer's Room in the H.Q. office building from 2000 hours on the day on which he commences duty until 0600 hours on the day on which he finishes his tour of duty, except when required to be absent therefrom by other duties under these orders when he will notify the Duty Clerk of his whereabouts.
6. He will deal with all matters arising outside ordinary office hours. If unable to do so, he will cause the officer required or concerned to be fetched. He will report all such matters together with the action taken in each case.
7. He will deal with all unusual incidents or matters referred to him during his tour of duty and will report the action taken.
8. He will not leave the H.Q. during his tour except on duty, when he will arrange a relief. He will notify the name of such relief to "A" Branch, the Camp Commandant and the Staff Captain (Supervising Officer), prior to leaving the H.Q. as aforesaid.
