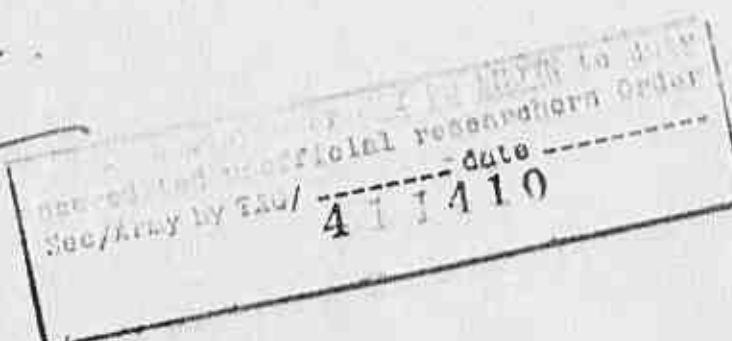

THE FOLLOWING MESSAGE, NUMBER 2305 JULY 11, FAN 161 IS QUOTED FOR YOUR INFORMATION:

THE COMBINED CHIEFS OF STAFF HAVE APPROVED THE FOLLOWING INSTRUCTIONS REGARDING CURRENCY ACCOUNTS AND RECORDS AS A SUPPLEMENT TO THE DIRECTIVE FOR MILITARY GOVERNMENT FOR HUSKY CABLED TO YOU ON 31 MAY, TEN JUNE AND 25 JUNE 1943. THE SUPPLEMENTARY INSTRUCTIONS FOLLOW:

PARA ONE. APPROPRIATE RECORDS WILL BE KEPT (A) IN WASHINGTON, (B) IN LONDON, AND (C) AT THE ALLIED MILITARY FINANCIAL AGENCY'S HEADQUARTERS OR OTHER DESIGNATED AGENCY IN THE FIELD OF OPERATION, OF ALL RECEIPTS, IN EXPENDITURES AND TRANSFERS OF SPECIAL CURRENCIES OBTAINED OR EXPENDED IN THE HUSKY OPERATION. SIMILAR RECORDS WILL ALSO BE KEPT OF THE DISPOSITION OF ALLIED MILITARY LIRA POSTAGE STAMPS UTILIZED IN THIS OPERATION. THE ALLIED MILITARY GOVERNMENT WILL FURNISH SUCH MONTHLY REPORTS AS MAY BE NECESSARY TO THE BRITISH AND US TREASURIES.

THE TERMS "SPECIAL CURRENCIES" WILL FOR THE PURPOSE OF THIS DIRECTIVE INCLUDE: (A) US YELLOW SEAL DOLLARS AND US SUBSIDIARY COIN, (B) BRITISH MILITARY AUTHORITY NOTES AND BRITISH SUBSIDIARY COIN, (C) ALLIED MILITARY LIRA NOTE, (D) OVER IMPORTED LIRA CURRENCY, WHATEVER THE SOURCE (E) LIRA FUNDS CONFISCATED AND MADE AVAILABLE FOR ALLIED EXPENDITURES WITHIN THE AREA, (F) NORTH AFRICAN FRANCS OR ANY OTHER FOREIGN CURRENCY OR ALLIED MILITARY NOTES NOT LISTED ABOVE.

PARA TWO. THE US ARMY WILL ACCOUNT FOR ALL BMA NOTES IN THE SAME MANNER AS IT ACCOUNTS FOR ALL YELLOW SEAL DOLLARS.

PARA THREE. ANY TRANSFER OF YELLOW SEAL CURRENCY FROM US ARMY TO BRITISH ARMY ACCOUNT OR FROM THE AM FINANCIAL AGENCY TO BRITISH ARMY, OR US ARMY ACCOUNT, WILL BE RECORDED IN TERMS OF YELLOW SEAL DOLLARS.

PARA FOUR. THE US TREASURY WILL PREPARE, PRINT, AND PACKAGE AM LIRA CURRENCY NOTES AND AM LIRA POSTAGE STAMPS IN ACCORDANCE WITH REQUIREMENTS STATED BY THE US MILITARY AUTHORITIES. THE COSTS INCIDENT THERETO WILL BE BORNE INITIALLY BY THE US ARMY. THE BRITISH ARMY WILL BE LIABLE TO THE US ARMY FOR ITS SHARE OF THE COSTS ON A BASIS TO BE DETERMINED LATER.

PARA FIVE. THE US TREASURY WILL RELEASE FOR SHIPMENT AM LIRA CURRENCY AND STAMPS TO THE US MILITARY AUTHORITIES, AS REQUESTED. THE AMOUNTS RELEASED TO THE US MILITARY AUTHORITIES WILL BE RECORDED BY THE US TREASURY AT FACE VALUE IN TERMS OF LIRA. THE RECORDING OF SUCH LIRA IN TERMS OF DOLLARS OR STERLING FOR BOOKKEEPING PURPOSES SHALL BE LEFT FOR SUBSEQUENT DETERMINATION AND ADJUSTMENT, EXCEPT AS HEREINAFTER INDICATED.

PARA SIX. THE US MILITARY AUTHORITIES WILL CONSIGN ALR AM LIRA CURRENCY AND STAMPS TO THE AM FINANCIAL AGENCY WHICH ACTING ON BEHALF OF AND FOR THE ALLIED MILITARY GOVERNMENT WILL ASSUME RESPONSIBILITY FOR ISSUANCE. THE AM FINANCIAL AGENCY WILL KEEP CAREFUL RECORDS BY VALUES AND DATES OF

FOR MILITARY GOVERNMENT FOR HUSKY CABLED TO YOU ON 31 MAY, TEN JUNE AND 25 JUNE 1943. THE SUPPLEMENTARY INSTRUCTIONS FOLLOW:

PARA ONE. PARA TWO. THE US ARMY WILL ACCOUNT FOR ALL BMA NOTES IN THE SAME MANNER AS IT ACCOUNTS FOR ALL YELLOW SEAL DOLLARS.

PARA THREE. ANY TRANSFER OF YELLOW SEAL CURRENCY FROM US ARMY TO BRITISH ARMY ACCOUNT OR FROM THE AM FINANCIAL AGENCY TO BRITISH ARMY, OR US ARMY ACCOUNT, WILL BE RECORDED IN TERMS OF YELLOW SEAL DOLLARS.

PARA FOUR. THE US TREASURY WILL PREPARE, PRINT, AND PACKAGE AN LIRA CURRENCY NOTES AND AN LIRA POSTAGE STAMPS IN ACCORDANCE WITH REQUIREMENTS STATED BY THE US MILITARY AUTHORITIES. PARA FIVE. THE US TREASURY WILL RELEASE FOR SHIPMENT AN LIRA CURRENCY STAMPS TO THE US MILITARY AUTHORITIES, AS REQUESTED. THE AMOUNTS RELEASED TO THE US MILITARY AUTHORITIES WILL BE RECORDED BY THE US TREASURY AT FACE VALUE IN TERMS OF LIRA. THE RECORDING OF SUCH LIRA IN TERMS OF DOLLARS OR STERLING FOR BOOKKEEPING PURPOSES SHALL BE LEFT FOR SUBSEQUENT DETERMINATION AND ADJUSTMENT, EXCEPT AS HEREINAFTER INDICATED.

PARA SIX. THE US MILITARY AUTHORITIES WILL CONSIGN ALR AN LIRA CURRENCY AND STAMPS TO THE AM FINANCIAL AGENCY WHICH ACTING ON BEHALF OF AND FOR THE ALLIED MILITARY GOVERNMENT WILL ASSUME RESPONSIBILITY FOR ISSUANCE. THE AM FINANCIAL AGENCY WILL KEEP CAREFUL RECORDS BY VALUES AND DATES OF THE CURRENCY AND STAMPS ISSUED TO (A) THE US ARMY, (B) THE BRITISH ARMY, AND (C) THE ALLIED MILITARY GOVERNMENT.

PARA SEVEN. LOCAL LIRA FUNDS AND ASSETS SEIZED OR TAKEN OVER WITHIN THE AREA OF OPERATIONS WILL BE DEPOSITED WITH THE ABOVE AM FINANCIAL AGENCY AS SOON AS POSSIBLE. CAREFUL RECORD AS TO AMOUNT AND SOURCE WILL BE MAINTAINED. IF SUCH LIRA FUNDS ARE MADE AVAILABLE TO EITHER THE AMERICAN OR BRITISH ARMIES FOR LOCAL EXPENDITURES, THE TRANSACTION WILL BE RECORDED AS AN ADVANCE FROM THE GENERAL POOL OF LIRA CURRENCY AVAILABLE TO BOTH ARMIES. AND THE AMOUNT SO ADVANCED WILL BE CHARGED TO THE ARMY RECEIVING IT. AS IN SECTION 3 BELOW. ON THE OTHER HAND ALL GOLD, FOREIGN CURRENCIES, FOREIGN SECURITIES AND OTHER FOREIGN EXCHANGE ASSETS SEIZED OR TAKEN OVER BY THE ALLIED ARMIES WILL BE IMPOUNDED WITH THE AM FINANCIAL AGENCY AND WILL BE HELD PENDING SETTLEMENT AT A LATER DATE.

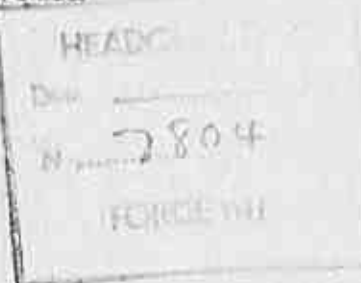

The Combined Chiefs of Staff have approved the following instructions regarding currency accounts and records as a supplement to the directive for Military Government for HUSKY cabled to you on 31 May, 10 June and 25 June 1943. The supplementary instructions follow:

1. Appropriate records will be kept (A) in Washington, (B) in LONDON, and (C) at the Allied Military Financial Agency's Headquarters or other designated agency in the field of operation, of AIR receipts, expenditures and transfers of special currencies obtained or expended in the HUSKY operation. Similar records will also be kept of the disposition of Allied Military Lira postage stamps utilized in this operation. The Allied Military Government will furnish such monthly reports as may be necessary to the British and US Treasuries.

The terms "special currencies" will for the purpose of this directive include: (A) US yellow seal dollars and US subsidiary coin, (B) British Military Authority Notes and British subsidiary coin, (C) Allied Military Lira Note, (D) other imported Lira currency, whatever the source, (E) Lira funds confiscated and made available for Allied expenditures within the area, (F) NORTH AFRICAN FRANCES or any other foreign currency or Allied Military Notes not listed above.

2. The US Army will account for all BMA Notes in the same manner as it accounts for all yellow seal dollars.

3. Any transfer of yellow seal currency from US Army to British Army account or from the AM Financial Agency to British Army, or US Army account, will be recorded in terms of yellow seal dollars.

4. The US Treasury will prepare, print, and package AM Lira currency notes and AM Lira postage stamps in accordance with requirements stated by the US military authorities. The costs incident thereto will be borne initially by the US Army. The British Army will be liable to the US Army for its share of the costs on a basis to be determined later.

5. The US Treasury will release for shipment AM Lira currency and stamps to the US military authorities, as requested. The amounts released to the US military authorities will be recorded by the US Treasury at face value in terms of Lira. The recording of such Lira in terms of dollars or Sterling for bookkeeping purposes shall be left for subsequent determination and adjustment, except as hereinafter indicated.

6. The US Military authorities will consign all AM lira currency and stamps to the AM Financial Agency, which acting on behalf of and for the Allied Military Government will assume responsibility for issuance. The AM Financial Agency will keep careful records by values and dates of the currency and the stamps issued to (A) the US Army, (B) the British Army, and (C) the Allied Military Government.

7. Local Lira funds and assets seized or taken over within the area of operations will be deposited with the above M Financial Agency as soon as possible. Careful records as to amount and source will be maintained. If such Lira funds are made available to either the American or British Armies for local expenditures, the transaction will be recorded as an advance from the General Pool of Lira currency available to both Armies, and the amount advanced will be charged to the Army receiving it, as in section 9 below. On the other hand all gold, foreign currencies, foreign securities and other foreign exchange assets seized or taken over by the Allied Armies will be impounded with the AM Financial Agency and will be held pending settlement at a later date. Nothing in this section will be interpreted as applying to funds in the physical possession of the Prisoners of War.

8. The British Treasury will report to the US Treasury the amount of Italian Lira currency obtained outside the area and made available for the operation. The British Military Authorities will report such Lire as are turned over to their forces, to the Allied Military Financial Agency, which will consider the amount as an augmentation of its currency reserve, and immediately record it as an advance to the British Military Forces. It is agreed that for all purposes of accounting and conversion the Lire as utilized will be identical with the Allied Military Lire prepared by the US Treasury.

9. The US Army will, when it obtains Allied Military Lire, from the Allied Military Financial Agency for expenditures in the area for pay of troops and other expenditures, that place normally be charged ETO its appropriation, set aside in an earmarked account (with the US Treasury). The dollar equivalent at the decreed rate of exchange and the relevant US War Department appropriation will be thereupon debited accordingly. The UK War Officer will deal in like manner with amounts certified as pay, etcetera, for British troops.

10. Expenditures in the area for and by the Allied Military Government in terms of Lire, as distinct from Allied Military expenditures, outlined in section 9 above, will be effected without specific dollar or pound sterling equivalent payments into earmarked accounts.

11. The British Treasury will report to the US Treasury the amount of BMA Notes made available to the British Forces, and the amount on hand as of a date later to be agreed upon. Similarly, the US Treasury will report to the British Treasury the amount of yellow seal dollar notes made available to the US Forces, and the amount on hand as of a date later to be agreed upon.

12. Mutilated and worn out currency will be withdrawn from circulation. Such BMA Notes and yellow seal dollars will be held in the custody of the AM Financial Agency pending further decision. AM Lire Notes and Italian Lire Notes so designated, will be held by the AM Financial Agency pending the working out of a satisfactory method of destruction, with an adequate records system for subsequent identification of notes destroyed.

13. Expenditures of the operation will be recorded in terms of (A) dollars, (B) sterling, (C) Lire, or (D) other currencies. These categories of expenditures will be kept separate and shall not be lumped in terms of a common unit. The allocation of the cost of military occupation as between the American and British Treasuries on the one hand, and the country of occupation on the other, will be a matter for negotiation and agreement between the US and British Governments. Discussion to the distribution of military occupation expenses, will be undertaken by the representatives of the US and British Governments upon receipt of the first extended financial report from the appropriate military authorities in the field.

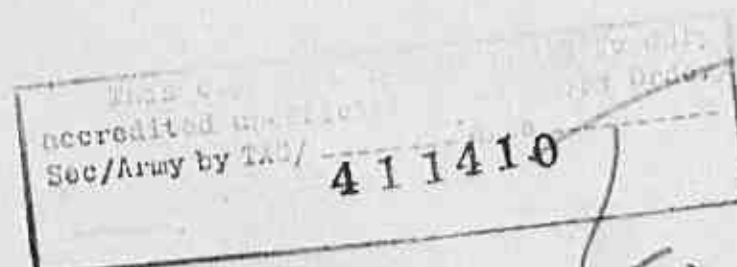

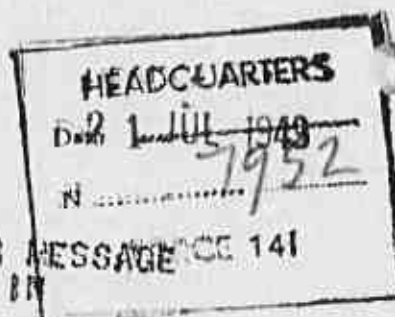

Later paragraphs of supplemental instructions regarding currency accounts are repeated as requested, "Paragraph 9, reference your W 4907, dated 15 July 1943. The US Army will, when it obtains Allied Military Line from the Allied Military Financial Agency for expenditures in the area for pay of troops and other expenditures that would normally be charged to its appropriation, set aside in an earmarked account (with the US Treasury) the dollar equivalent at the decreed rate of exchange and the relevant US War Department appropriation will be thereupon debited accordingly. The UK War Office will deal in like manner with accounts certified as pay etcetera for British troops.

10. Expenditures in the area for and by the Allied Military Government in terms of lire, as distinct from Allied Military expenditures, outlined in section 9 above, will be effected without specific dollar or pound sterling equivalent payments into earmarked accounts. By earmarked accounts is meant bookkeeping transfer by the US Army fund its Congressional appropriation into a special account to be held by the Treasury Department, of the dollar equivalent at the decreed rate of exchange for all lire, or other lire, currency or credits, obtained from the AFPA when such funds are to be used for the pay of troops, and other expenditures that would normally be charged to the congressional dollar appropriation US Army.

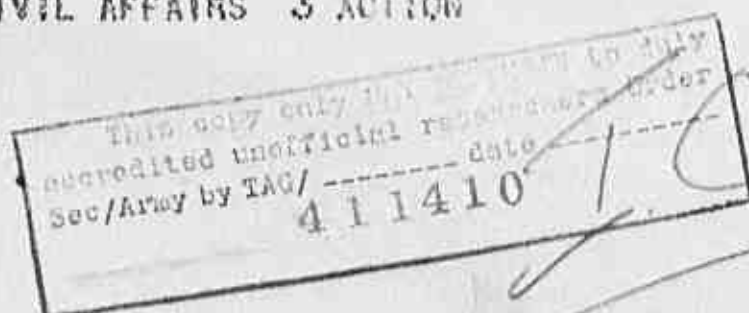

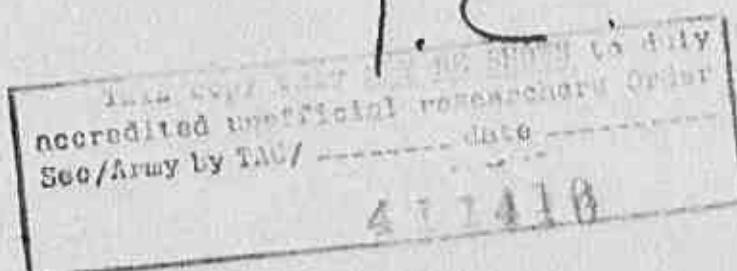

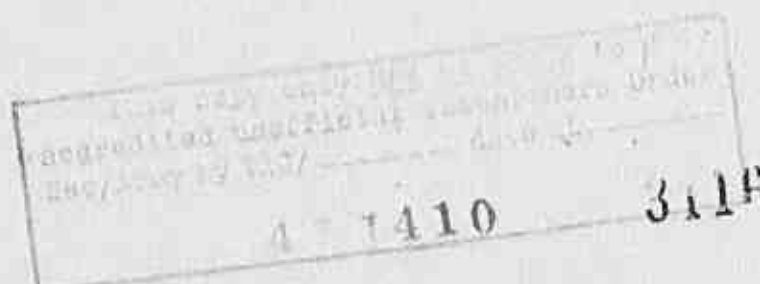
