PARA ONE. APPROPRIATE RECORDS WILL BE KEPT (A) IN WASHINGTON, (B) IN LONDON, AND (C) AT THE ALLIED MILITARY FINANCIAL AGENCY'S HEADQUARTERS OR OTHER DESIGNATED AGENCY IN THE FIELD OF OPERATION, OF AIR RECEIPTS, IN EXPENDITURES AND TRANSFERS OF SPECIAL CURRENCIES OBTAINED OR EXPENDED, IN THE HUSKY OPERATION. SIMILAR RECORDS WILL ALSO BE KEPT OF THE DISPOSITION OF ALLIED MILITARY LIRA POSTAGE STAMPS UTILIZED IN THIS OPERATION. THE ALLIED MILITARY GOVERNMENT WILL FURNISH SUCH MONTHLY REPORTS AS MAY BE NECESSARY TO THE BRITISH AND US TREASURIES.

THE TERMS "SPECIAL CURRENCIES" WILL FOR THE PURPOSE OF THIS DIRECTIVE INCLUDE: (A) US YELLOW SEAL DOLLARS AND US SUBSIDIARY COIN, (B) BRITISH MILITARY AUTHORITY NOTES AND BRITISH SUBSIDIARY COIN, (C) ALLIED MILITARY LIRA NOTE, (D) OVER IMPORTED LIRA CURRENCY, WHATEVER THE SOURCE, (E) LIRA FUNDS CONFISCATED AND MADE AVAILABLE FOR ALLIED EXPENDITURES WITHIN THE AREA, (F) NORTH AFRICAN FRANCS OR ANY OTHER FOREIGN CURRENCY OR ALLIED MILITARY NOTES NOT LISTED ABOVE.

PARA TWO. THE US ARMY WILL ACCOUNT FOR ALL BMA NOTES IN THE SAME MANNER AS IT ACCOUNTS FOR ALL YELLOW SEAL DOLLARS.

PARA THREE. ANY TRANSFER OF YELLOW SEAL CURRENCY FROM US ARMY TO BRITISH ARMY ACCOUNT OR FROM THE AM FINANCIAL AGENCY TO BRITISH ARMY, OR US ARMY ACCOUNT, WILL BE RECORDED IN TERMS OF YELLOW SEAL DOLLARS.

PARA FOUR. THE US TREASURY WILL PREPARE, PRINT, AND PACKAGE AN LIRA CURRENCY NOTES AND AN LIRA POSTAGE STAMPS, IN ACCORDANCE WITH REQUIREMENTS STATED BY THE US MILITARY AUTHORITIES. PARA SEVEN. LOCAL LIRA FUNDS AND ASSETS SEIZED OR TAKEN OVER WITHIN THE AREA OF OPERATIONS WILL BE DEPOSITED WITH THE ABOVE AM FINANCIAL AGENCY AS SOON AS POSSIBLE. CAREFUL RECORD AS TO AMOUNT AND SOURCE WILL BE MAINTAINED. PARA EIGHT. THE BRITISH TREASURY WILL REPORT TO THE US TREASURY THE AMOUNT OF ITALIAN LIRA CURRENCY OBTAINED OUTSIDE THE AREA AND MADE AVAILABLE FOR THE OPERATION. THE BRITISH MILITARY AUTHORITIES WILL REPORT SUCH LIRA AS ARE TURNED OVER TO THEIR FORCES, TO THE ALLIED MILITARY FINANCIAL AGENCY, WHICH WILL CONSIDER THE AMOUNT AS AN AUGMENTATION OF ITS CURRENCY RESERVE, AND IMMEDIATELY RECORD IT AS AN ADVANCE TO THE BRITISH MILITARY FORCES. THE US ARMY WILL, WHEN IT OBTAINS ALLIED MILITARY LIRA, FROM THE ALLIED MILITARY FINANCIAL AGENCY FOR THE EXPENDITURES IN THE AREA FOR PAY OF TROOPS AND OTHER EXPENDITURES, THAT PLANE NORMALLY BE CHARGED TO ITS APPROPRIATION, SET ASIDE IN AN EARMARKED ACCOUNT (WITH THE US TREASURY). THE DOLLARS EQUIVALENT AT THE DECREED RATE OF EXCHANGE AND THE REVELANT US WAR DEPARTMENT APPROPRIATION WILL BE THERE UPON DEBITED ACCORDINGLY. THE UK WAR OFFICER WILL DEAL IN LIKE MANNER WITH AMOUNTS CERTIFIED AS PAY, ETCETERA, FOR BRITISH TROOPS. PARA TEN. EXPENDITURES IN THE AREA FOR AND BY THE ALLIED MILITARY GOVERNMENT IN TERMS OF LIRA, AS DISTINCT FROM ALLIED MILITARY EXPENDITURES, OUTLINED IN SECTION NINE ABOVE, WILL BE EFFECTED WITHOUT SPECIFIC DOLLAR OR POUND STERLING EQUIVALENT PAYMENTS INTO EARMARKED ACCOUNTS.

PARA ELEVEN. THE BRITISH TREASURY WILL REPORT TO THE US TREASURY THE AMOUNT OF BMA NOTES MADE AVAILABLE TO THE BRITISH FORCES, AND THE AMOUNT ON HAND AS OF A DATE LATER TO BE AGREED UPON. SIMILARLY, THE US TREASURY WILL REPORT TO THE BRITISH TREASURY THE AMOUNT OF YELLOW SEAL DOLLAR NOTES MADE AVAILABLE TO THE US FORCES, AND THE AMOUNT ON HAND AS OF A DATE LATER TO BE AGREED UPON.

PARA TWELVE. MUTILATED AND WORN OUT CURRENCY WILL BE WITHDRAWN FROM CIRCULATION. SUCH BMA NOTES AND YELLOW SEAL DOLLARS WILL BE HELD IN THE EUROPEAN CUSTODY OF THE AM FINANCIAL AGENCY PENDING FURTHER DECISION. AM LIRA NOTES AND ITALIAN LIRA NOTES SO DESIGNATED, WILL BE HELD BY THE AM FINANCIAL AGENCY PENDING THE WORKING OUT OF A SATISFACTORY METHOD OF DESTRUCTION, WITH AN ADEQUATE RECORDS SYSTEM FOR SUBSEQUENT IDENTIFICATION OF NOTES DESTROYED.

PARA 13. EXPENDITURES OF THE OPERATION WILL BE RECORDED IN TERMS OF (A) DOLLARS, (B) STERLING, (C) LIRA, OR (D) OTHER CURRENCIES.

THESE CATEGORIES OF EXPENDITURES WILL BE KEPT SEPARATE AND SHALL NOT BE LUMPED IN TERMS OF A COMMON UNIT. THE ALLOCATION OF THE COST OF MILITARY OCCUPATION AS BETWEEN THE AMERICAN AND BRITISH TREASURIES ON THE ONE HAND, AND THE COUNTRY OF OCCUPATION ON THE OTHER, WILL BE A MATTER FOR NEGOTIATION AND AGREEMENT BETWEEN THE US AND BRITISH GOVERNMENTS. THE UK WAR OFFICER WILL DEAL IN LIKE MANNER WITH AMOUNTS CERTIFIED AS PAY, ETCETERA, FOR BRITISH TROOPS.

PARA TEN. EXPENDITURES IN THE AREA FOR AND BY THE ALLIED MILITARY GOVERNMENT IN TERMS OF LIRE, AS DISTINCT FROM ALLIED MILITARY EXPENDITURES, OUTLINED IN SECTION NINE ABOVE, WILL BE EFFECTED WITHOUT SPECIFIC DOLLAR OR POUND STERLING EQUIVALENT PAYMENTS INTO EARMARKED ACCOUNTS.

PARA ELEVEN. THE BRITISH TREASURY WILL REPORT TO THE US TREASURY THE AMOUNT OF BMA NOTES MADE AVAILABLE TO THE BRITISH FORCES, AND THE AMOUNT ON HAND AS OF A DATE LATER TO BE AGREED UPON. SIMILARLY, THE US TREASURY WILL REPORT TO THE BRITISH TREASURY THE AMOUNT OF YELLOW SEAL DOLLAR NOTES MADE AVAILABLE TO THE US FORCES, AND THE AMOUNT ON HAND AS OF A DATE LATER TO BE AGREED UPON.

PARA TWELVE. MUTILATED AND WORN OUT CURRENCY WILL BE WITHDRAWN FROM CIRCULATION. SUCH BMA NOTES AND YELLOW SEAL DOLLARS WILL BE HELD IN THE CURRENCY CUSTODY OF THE AM FINANCIAL AGENCY PENDING FURTHER DECISION. AM LIRA NOTES AND ITALIAN LIRA NOTES SO DESIGNATED, WILL BE HELD BY THE AM FINANCIAL AGENCY PENDING THE WORKING OUT OF A SATISFACTORY METHOD OF DESTRUCTION, WITH AN ADEQUATE RECORDS SYSTEM FOR SUBSEQUENT IDENTIFICATION OF NOTES DESTROYED.

PARA 13. EXPENDITURES OF THE OPERATION WILL BE RECORDED IN TERMS OF (A) DOLLARS, (B) STERLING, (C) LIRA, OR (D) OTHER CURRENCIES.

THESE CATEGORIES OF EXPENDITURES WILL BE KEPT SEPARATE AND SHALL NOT BE LUMPED IN TERMS OF A COMMON UNIT. THE ALLOCATION OF THE COST OF MILITARY OCCUPATION AS BETWEEN THE AMERICAN AND BRITISH TREASURIES ON THE ONE HAND, AND THE COUNTRY OF OCCUPATION ON THE OTHER, WILL BE A MATTER FOR NEGOTIATION AND AGREEMENT BETWEEN THE US AND BRITISH GOVERNMENTS. Prisoners, like civilians, indicate profound hatred of GERMANS. Prisoners say all ITALIANS would surrender if GERMANS were not shooting ITALIANS who come over carrying (1) white flag.

3, Thus 200 ITALIANS, soldiers with packed belongings, met AMERICAN landers at GELA. Civilians report armed clashes between ITALIAN-GERMAN soldiers at SANTA CONO, shootings of ITALIANS by GERMANS at MAZZARANO and GERMAN laying of mines behind ITALIANS at BUTEVA, cannot confirm and doubt all 3 reports. Interrogating prisoners at LICATA felt special guard necessary protect GERMANS WHITTAKER.
