Subject: Cooperation with other Army Units

AMGOT HQ. SICILY

To : All S.C.A.O.s

18 October 1943

1. A complaint has reached this office alleging that an AMGOT Civil Affairs officer had issued written authority to certain Italians, who were in the process of forming a Bomb Disposal Group, authorizing them to make use of certain supplies located in a U.S. Army Ordnance Dump. This act was wholly unauthorized.
2. Too much emphasis cannot be laid upon the necessity for cooperation with other units of the Allied Armies.
3. Each C.A.O., or other AMGOT official, before he takes any steps which might effect other Army units, should consider carefully what effect his action is likely to have on that Army unit. Before the action is taken, the necessary contact should be made to insure that no misunderstanding will result.
4. It is requested that all AMGOT personnel in your province be advised of the contents of this memorandum.

1. Several requests for authority to re-establish the Prefect's Council and the Provincial Giunta have been received by these Headquarters.
2. You are advised that each S.O.A.O. may authorize or direct the re-establishment of these bodies, or either of them, if he considers it wise in his particular province to do so.
3. However, as in the case of other important political posts, prominent Fascists will not be permitted to serve.
4. In accordance with General Administrative Instructions No. 19 (ANGOT/4037/L) dated 21 Sept. 1943, the functions of these bodies, if re-established, will be purely advisory and not legislative.

SUBJECT: Reorganization of Provincial and Communal Administration.

TO : Chief Staff Officer - AMGOT HEADQUARTERS.

1. With the appointment of a liberal-democratic Prefect for Palermo Province it has been possible to proceed with the revival of those organs of local government which preceded the advent of Fascism in Italy.

2. Ordinarily the Prefect, on appointment, may nominate his Capo Gabinetto and Segretario Particolare who, normally, should be civil servants on the roll of the Ministero dell'Interno by whom their appointment is approved. Under present emergency conditions AMG thro S.C.A.O's may find it desirable to approve appointments from outside the civil service.

3. Giunta Provinciale Amministrativa

The formation and functions of this body are regulated by a series of laws and regulations which date from 1865. It is composed of 10 members with the Prefect or his substitute as President, and includes from the Prefecture, two Consiglieri, a Deputy Prefect-Inspector and the Chief Accountant. The remaining members are chosen from experts in legal, administrative or technical affairs, nominated by the Prefect and approved by the S.C.A.O. acting for AMG.

4. Consiglio di Prefettura is composed of the Prefect or his substitute, who presides, and two senior Councillors of the Prefecture. Its powers and functions are regulated by specific laws and the Prefect may request the opinion of the Council on any matter. Included in its functions is the approval of accounts of communes and charitable institutions.

5. Deputazione Provinciale. In place of the Rettorato, the province now has a President and a deputazione Provinciale. The president is head of the provincial administration and of the Deputazione Provinciale. A decree has been drafted to regulate the duties and powers of the President and the Deputazione which consists of 10 unpaid members nominated by the Prefect for approval by AMG. In provinces of less than 600,000 inhabitants this number is reduced. A copy of the draft Decree will be submitted to Legal Division for examination and approval.

6. Sindaci. In place of "Podesta" the democratic title of "Sindaco" is now adopted for mayors throughout the province. As the time has not yet come to reinstate the electoral system, appointments are made with the concurrence of C.A.O.'s subject to the approval of the Prefect who then issues the regular Decree.

7. Giunta Comunale. Normally this body consists of 10 assessori (aldermen) in addition to the Mayor in towns of over 250,000 inhabitants. For towns with over 60,000 population the number is reduced to 8, to 6 when the population is more than 30,000, to 4 for over 3,000 inhabitants and to 2 for the smaller communities. It is considered advisable under the present exceptional circumstances that the number of assessori may be increased at S.C.A.O.'s discretion.

The draft decree previously referred to also specifies the duties and powers of Sindaci and the Giunta Comunale.

8. In the selection of the members of the above organs consideration has been given to all shades of political opinion with the exception of extremists, and especially to labour. In the Giunta Comunale of Palermo there are three workers and in the communes it is intended that 50% of each Giunta shall consist of peasant or labour representatives.

9. In Palermo all the foregoing civil services with their respective heads are already operating and throughout the province the communes are appointing their Giunta Comunale many of which are actually functioning along with the Sindaci.

10. It is hoped that these brief notes may prove useful in forming a uniform policy for all Sicily.

1. The Chief Legal Officer has reported that you desired more definite advice as to the authority which you, as R.C.A.O., may exercise in various respects.
2. At present you are attached to the tactical forces and under the command of the C.S. 5th Army. You, therefore, have full power of decision, with approval of the tactical commander, without reference to this Headquarters. It will be the responsibility, however, of your staff officers, representing the various special divisions - legal, finance, supply, etc. - to see that you are advised as to AMGOT policies as laid down in the AMGOT Manual and in the various instructions which have been issued from this headquarters.
3. Staff officers from this HQ will visit you from time to time. You will, of course, inform them as to action which you are taking in your region. If any action appears to deviate from general AMGOT policy you will be informally advised by them.

SUBJECT:- Delegation of Power from G.O.C.

1. I annex the two proposed orders for the signature of the G.O.C. 15 Army Group, delegating certain powers to you. I believe it important to have them signed for the following reasons:-

(a) The first order delegates the power to appoint and remove administrative and judicial officials and other government functionaries, employees etc. There are many officials who were previously appointed directly from Rome. I have no doubt of the Military Governor's power to exercise such powers but I doubt whether you could properly exercise those powers without a specific delegation.

1. It is realized that the volume of detailed enquiry and administrative direction issued from this H. . probably causes strain and dependency to S.O. .Os who have inadequate clerical staff and an ever decreasing officer-staff. At the start of an administration it is inevitable that there should be a large amount of this type of correspondence, but control is and has been kept on it.
2. Though close scrutiny and detailed directions at the outset may have the immediate effect described by you, it is considered that they should tend to greater efficiency on the part of Italian officials later on when they have to work on their own to a far greater extent than they do at present.
3. It is understood that the post of Mayor has always been held by a local man and that it is part time and unpaid; furthermore, that an outsider would find it very difficult to get any cooperation. You may have taken these factors into consideration when asking for mayors - if so please give some idea of the pay and conditions of service and this H. . will endeavour to select one.

1. I would submit that one of the obstacles to the development of the indirect system in provincial administration is the volume of detailed enquiry and administrative direction which is issued from HQ, Palermo.
2. If an Italian organisation is scrutinised as closely as the returns required would necessitate, and its procedure is governed by directives as detailed as those received, the officials concerned are bound to get into the habit of referring any action to be taken to the AMGOT officer in charge and not unnaturally feel that it would be unwise to take the responsibility for a decision themselves. They are mostly reluctant to take on any responsibility and their reluctance is certainly strengthened by this administrative development.
3. The rather peculiar circumstances in this province make the selection of candidates for office an insuperable problem. I should be glad if a dozen suitable mayors could be sent to me at an early date.

1. As the second month of occupation nears completion, there are unmistakable signs that our administration is not as well advanced as it should be at this time. Supply problems remain unsolved except on a hand-to-mouth basis and there is an unevenness in administration between the provinces. Efforts are being made to correct the difficulties by contact between HQ personnel and the field.

2. It is my view that such difficulties are dependent or attributable to the failure in most localities of the S.C.A.O.s and their subordinates to rely sufficiently on the Italian administration. Ours is a military government of indirect control and it is essential, not only to conserve our personnel but to get the job properly done, that the most competent Italian personnel available be drawn in to the administration and put to work. At this time there should be no vacancies in the office of Sindaco in any important commune and candidates for the office of prefect should have been found in most provinces, and submitted to this HQ for approval.

3. Italian personnel must, of course, be carefully chosen. However on the basis of the investigation that has already been completed you should be pretty well aware of the reliable elements in your province. A political check of civil servants and office holders by means of a questionnaire is to be commenced shortly of which you will be further advised.

MEMORANDUM TO: Chief of Staff.

1. Civil Situation: In effecting military government in Sicily, AMGOT officers are utilizing the old civil officials who operated under Fascism, except when those officials are taken into custody by the CIC because of their Fascist activities. AMGOT officers are instructed to continue the old tax system in order to collect funds to partially support local government. The old tax system patently favors the richer elements of the population. Allied government is also utilizing the old system of collecting a portion of the produce raised, for storage in public warehouses and later public sale. This means that the old system is being carried out by the old personalities under the authority of the Allied Government. While it is recognized that this is a temporary measure, the officers who have been charged with the administration of the various communities have been given no directives outlining the over-all system of government and taxation which Sicily is finally to have. The civilians, after an initial period of hope, find no change in their government and no promise of a change.

2. Effect on Combat Troops: The growing disillusionment of the civilian population which so warmly welcomed the Allies will, unless something is done to check it, affect combat efficiency of Allied armies. In their enthusiasm Sicilians have so far given valuable information concerning the enemy, even to include the Italian Army. Information regarding enemy troops, installations, headquarters, Fascist Party records, hidden stocks of arms and food, as well as Fascist leaders, has been volunteered to American troops. Even the enemy troops before us have been disaffected and have deserted to return to their homes, to live under what they believe will be better conditions. If the Allies do not show themselves interested in more than conquest of the country, the assistance of the civilian population along lines outlined above may be expected to decrease. Unapprehended Fascists are likely to become active. The disillusionment will spread ahead of our troops and will undoubtedly be seized upon by Axis propagandists, and the resistance of Italian elements will be strengthened.

3. Recommendations: It is recommended that II Corps CIC personnel and AMGOT officers attached to II Corps and its component divisions be permitted to spread a propaganda of future hopes along the lines outlined below. It is further recommended that AMGOT officers, in meeting practical problems, be permitted to act along lines paralleling this propaganda when such action is necessary to solve particular local problems.

It is desirable to read the belief that:-

- a. The administration that held office under Fascism will be replaced as rapidly as suitable replacements can be found in the local population. AMGOT should make an early concerted effort to find these.
- b. The favoritism of the present tax system will be done away with, and the present landholders' freedom from taxation on his produce and retailers' freedom from taxation on material goods will be abolished.
- c. The system of collecting agricultural products from the producers will be supplanted by one under which the individual will have control of the sale of his products under a maximum price scheme.
- d. The present price and wage fixing of AMGOT should emphasize and enforce the higher wage scale before the higher price system.
- e. Any modification of the above suggestions which will achieve the same result, but be in greater conformity with eventual plans of AMGOT, would of course be satisfactory.
