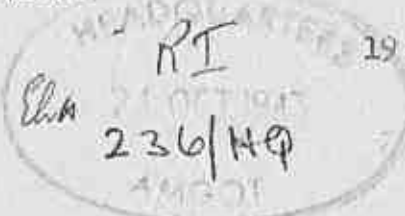

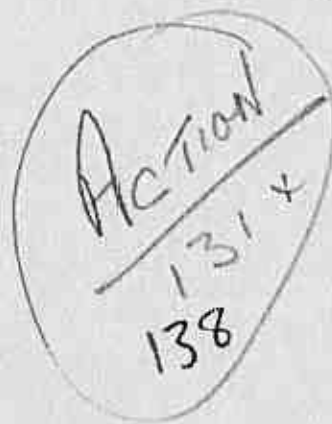
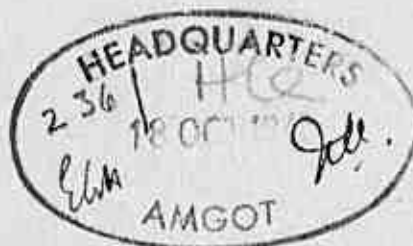

Art 52 of Hague Convention stipulates that requisitions may be made only if they are necessary for the army of occupation. They must not be made in order to supply the belligerent's general needs and much less to furnish an officer's mess in some other country.

Strictly speaking furniture should always be bought or hired.

Germany's policy of requisitioning in occupied Europe has been rightly criticised in all the allied Press, it would certainly seem strange if we, British, went one furniture and actually exported the movables from a country with whom we have concluded an armistice, without paying for them.

1. Please advise Lt Col POLETTI that all paper was frozen by AMGOT Hq because of the acute paper shortage in Sicily. This paper is used for the printing of Proclamations, Ration Cards, the AMGOT "Bible", daily Orders, Gazettes and other forms needed by the various departments, which puts a heavy onus on the existing supply.

2. Most of this paper had to be found by devious means. In many cases quantities of this paper was transported out of town, either because of the fact that there was the danger of it being damaged through Allied bombings, prior to our occupation, or for the purpose of trying to evade declaring such stocks to our Authorities.

3. Having tracked down many of these deposits, in and out of town, it was decided that the best solution would be to freeze these stocks by requisitioning them. This would save a great deal of money, since we would not be charged for the paper, but only for any printing done for our account.

4. Any other agency of AMGOT having need for this paper needs only advise us of the type and quantity of paper for their specific purpose, and we will unfreeze said quantities. In such a way an accurate check can be kept, and any misuse may be prevented.

5. If this system of control has in any way inconvenienced the operation of Lt Col POLETTI's office, we will be very glad to remedy the situation if only he will make known his needs, and in that manner whatever paper we have under our control will be at his disposal.
