I beg to inform you that in compliance with the provisions contained in Proclamation No.1 of the Allied Command of July 29 - I am consigning to the Military Authorities, in two sacks all the weapons from this office with the list hereto.

I have been informed now that such weapons do not exist in the barracks, having been carried away by American troops.

Since it is harmful to the interests of justice, in so far as said weapons constitute the proof of an offence, I beg of you to investigate this action, reserving me the right to retain them again until the relative proceedings are defined.

Likewise, I say that besides the said arms I also find missing a revolver, IONJOM (my property) which I had also consigned with the expectation of having it back for self-defence.

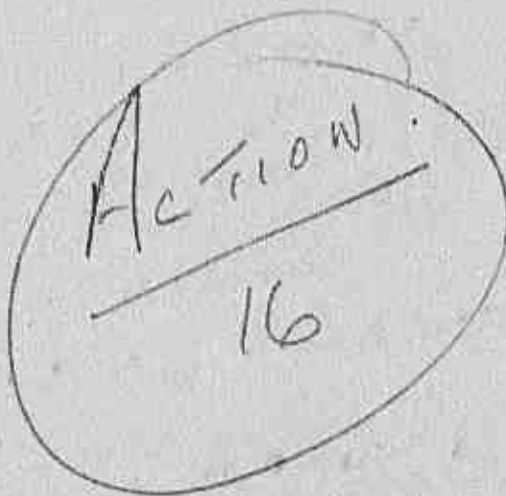

1. The use of firearms may become a real danger and it is essential that immediate action be taken to avoid, this possibility.

2. Weapons not authorized by Army Regulations are being carried by military personnel. Requests are being submitted for use of firearms by civilians. It is unnecessary to emphasize the danger to Military Government later if regulations respecting the use of firearms are permitted to be violated.

3. The small calibre automatic pistols of Italian make are unsuitable for police purposes and extremely dangerous to handle. Accidents have already been reported.

4. It is recommended that the attached draft of memorandum issued to SCAO's be approved and distributed.

(2) Can you also supply this office with a record of personal firearms confiscated.

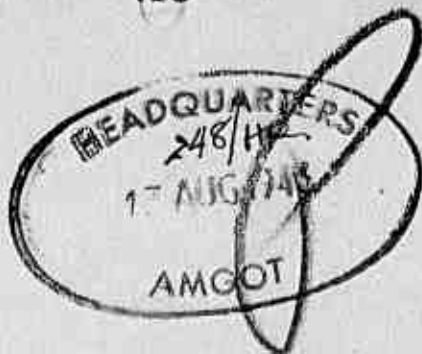

TO : CCAO, AMGOT, 15th Army Group
SUBJECT: Pilfering of Arms Deposited with Carabinieri.

1. In accordance with orders from AMGOT private citizens have deposited with the local Carabinieri stations their private firearms.
2. We have received many reports of unidentified American soldiers entering Carabinieri stations and demanding that they be given arms from these deposits. Usually the demands are for small pistols.
3. To give the Carabinieri some evidence of authority for refusing such demands a signed copy of the enclosed order has been furnished to the Agrigento Group Commander for each Carabinieri station.
4. One American soldier, who signed a receipt as James F. McCullagh, reported to be a major, took some twenty-one firearms, a sabre and a box of cartridges from the 2d Station in Agrigento. A Staff Sergeant, signing himself, M. G. Robbins, Jr. took three revolvers from the station at Siculiana, and a Pfc. Philip Johnson did the same. The original receipts are enclosed. These men could not be identified locally.
5. On the night of August 6th in Agrigento, two unidentified soldiers stopped a Carabinieri, demanded to see his pistol, and when he produced it, they took it and gave him an American five dollar bill.
6. Nineteen pistols were taken from the Sciacca station during the week, but Major Ashworth, CAPO, recovered eight from a detachment of troops bivouacked nearby.
7. It is requested that drastic orders be issued to curb such incidents.
