



Reference attached letter No. AMGOT/1013/PS dated 25/9/43.

1. I have to refer to the establishment of Clerks at this H.Q.
2. At the present time we are at least 25 Clerks(British) deficient on the present W.E. and the prospects of getting any trained British clerks in the very near future is very remote.
3. The majority of the British clerks at present employed are neither typists or stenographers and all divisions are in urgent need of stenographers. I have personally tried to get civilian stenographers and whilst there are quite a number at present on our register, none can speak English and therefore are useless as far as we are concerned. As far as the Public Safety Division is concerned, it is absolutely essential in the interest of security that either British or American stenographers are employed.
4. In order to ease the situation as a temporary measure, I earnestly request that application be made to A.F.H.Q. for the temporary employment at this H.Q. of 20 stenographers (WACS).
5. I understand that a new WAC Company has arrived in Algiers and are awaiting assignment.
6. The matter in regard to the supply of stenographers to Divisions is now serious and unless something is done in the very near future the efficiency of the H.Q. as a whole will be seriously affected.

In the Civil Police Section serious delays are caused, especially in reference to the classification and disposition of civilians detained by Allied authority. There are nearly 1,200 individuals concerned. Each one involves certain records, rolls and other clerical and administrative work.

The clerical assistance and facilities at the disposal of this Division are inadequate to handle the situation in a prompt and satisfactory manner. May I request that arrangements be made to correct this situation even on an emergency or temporary basis.

At the moment, the Civil Police Section is in urgent need of an additional two good typists, two typewriters and one stenographer.

The inadequacy of clerical personnel within the Division as a whole is causing considerable delay in our work and renders it impossible for me to relieve these emergencies internally.


