1. Military needs for the moment dictate that HQ No 1 District should remain at CATANIA, but it is obvious that liaison between HQ, AMGOT, and HQ, No 1 District, which should be constantly maintained, will be a matter of some difficulty. Moreover, it is unlikely this HQ will move to PALERMO until such time as that town has been vacated by US troops.

2. Therefore, in order to improve liaison between AMGOT and this HQ, I propose to assign to my US Liaison Officer, Colonel William Clark, the duties of Liaison Officer between our two headquarters, and I would be glad if you will give him the necessary facilities to perform this task when he visits you.
