NOTICE BOARD INFORMATION

IT IS IMPORTANT THAT YOU SHOULD READ THIS

59. Transfers to the Military Provost Staff Corps from Units at Home.

1. Applications for transfer to the M.P.S.C. are required from N.C.Os. serving at home.

2. All N.C.Os. who are finally selected after a probationary period for transfer will serve in the rank of serjeant. There are good opportunities for promotion to higher ranks.

Additional pay at the rate of 6d. a day will be issued to all N.C.Os. (except tradesmen) serving as serjeants in the M.P.S.C.

3. Applicants must possess the following qualifications:—

- (a) hold at least the war substantive rank of corporal;
- (b) be in possession of a second-class certificate of education or equivalent civil qualification;
- (c) be experienced instructors in one or more of the following:—physical training, weapon training (including light machine gun), foot drill, gas, section leading, map reading;
- (d) be efficient disciplinarians;
- (e) be of not less than "Very Good" character;
- (f) be of medical category A(X)1, A(X)2, A(X)3, A.4, A.5, B.1, B.2, B.2A, or B.5;
- (g) be non-tradesmen, and not employed on specialist duties.

4. Applications from N.C.Os. with provost experience who do not fulfil all the conditions in para. 3 above, will be considered.

5. N.C.Os. of the R.A.C. and Recce. Corps and those serving in units mobilized or mobilizing for service overseas are not permitted to apply.

6. N.B.I. No. 7 is hereby *cancelled*.

60. Refund of Insurance Contributions—Personnel Enlisted or Enrolled Overseas.

Regulations have been made which relieve soldiers, auxiliaries of the A.T.S. and members of V.A.Ds. who have enlisted or enrolled outside the British Islands on or after 3rd September, 1939, of their liability to insurance under the National Health Insurance and Contributory Pensions Acts during their war service. (The term British Islands means Great Britain, Northern Ireland, Isle of Man and the Channel Islands.)

These regulations also apply to nursing officers of Q.A.I.M.N.S.(R.), the T.A.N.S. and its Reserve who are insured as other ranks.

All men and women concerned will cease to be compulsorily insurable with effect from the date of their enlistment or enrolment and can claim a refund of the whole amount of the pensions contributions deducted from their army pay since that date. In order to obtain this refund and prevent the further deduction of pensions contributions from their pay, they should at once submit their claims, stating the name of the country in which they enlisted or enrolled, to their C.Os.

Men and women who were insured for health and/or pensions purposes at the time of joining for service, and who are now relieved from compulsory insurance under these regulations should, if they wish to maintain their insurance under the normal rules for voluntary contributors, write to the Ministry of Health, Insurance Department, Blackpool, Lancs., from which further information can be obtained.

You may not get all the warmth you would like this winter; your physical fitness will help you to do with less.


There will always be enough fuel for cooking, and for drying your wet clothes.

Coal is the scarcest fuel of all. So use coke wherever you can. It will do well in open fires if you take a little trouble with it after you have started the fire with coal. Use all the coal dust you can once the fire is going. Add it to the fire carefully—don't chuck it on in heaps and put the fire out.

1. The following allotment has been made by A.F.H.Q., for heating buildings occupied solely by Military personnel, offices, bathing facilities, messes, workshops where precision work is undertaken, Unit Recreation Rooms, Cafetaria & Institutes for all British forces in No.1 District, and U.S. Troops drawing British Rations.

COMD BRITISH TPS PALERMO 50 TONS PER MONTH. (To cover all personnel drawing British Rations in Western Sicily).

It is emphasised that wherever possible wood or liquid fuel will be used in lieu of coal, in order to ensure a low consumption of the latter.

2. Fuel will NOT be used for heating sleeping accommodation.

3. Scale of issue for use as above depends on availability of stocks, but where issues are approved the scale will not exceed $\frac{1}{2}$ lb coal, or equivalent per man per day.

4. Units requiring coal will submit indents based on $\frac{1}{2}$ lb coal per man per day stating period for which required, type of heating and No. of personnel concerned to this H.Q. for approval.
