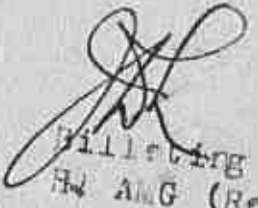

TO: Lt. Col. ROSS VERNON

The morning while I was inspecting the premises located at 15 Via Giosachino Di Marco, I was informed by the sergeant on duty, (Sgt. Barber) that one of the civilians working on the above mentioned address, employed by this headquarters for cleaning purposes, was injured by a fallen rock.

One of the jobs assigned in said premises was to open 3 windows which had been cemented by the owner, and while the civilian in question was removing the debris a stone fell on his head injuring him.

The injured persons name is: Pietro CANNELLA;

I spoke to the above person, and he informed me that he was brought to the Hospital and there he was treated and received 2 stitches on the head.

He seemed a bit pale but returned ~~me~~ to work this afternoon; he looked fit and able to do that type of work.
