DIRECTIVE ON TRANSFER OF CERTAIN TERRITORIES JUST RECEIVED FROM ACC.
THEY SEND TEXT OF 3 DOCUMENTS OF WHICH SUMMARY FOLLOWS:

NEW A. PROCLAMATION BY MILITARY GOVERNOR. 1. WITHOUT PREJUDICE TO CONTINUED STATUS OF TERRITORY AS "OCCUPIED", TO POSITION AND POWERS THERE IN OF ALLIED FORCES, OR TO RIGHTS OF ALLIED C IN C IN REGARD THEREFO, PROCLAMATIONS AND ORDERS WILL BE TERMINATED AT CERTAIN DATE. GOVERNMENT THEREAFTER TO BE EXERCISED BY ITALIAN GOVERNMENT SUBJECT TO INSTRUCTIONS OF ACC. 2. ALLIED C IN C MAY CANCEL ANY ACT OF ITALIAN GOVERNMENT OR RESUME GOVERNMENT IF REQUIRED BY MILITARY EXIGENCIES OR INTERESTS OF PUBLIC ORDER OR GOOD GOVERNMENT. 3. NOTHING HEREIN SHALL AFFECT RIGHT OF ALLIED C IN C TO DO ALL NECESSARY FOR SECURITY, OPERATIONS, ETC., OF ALLIED FORCES AND TO ISSUE PROCLAMATIONS ON ITALIAN AUTHORITIES AND PEOPLE, OR OF THE ACC TO TAKE ACTION NECESSARY FOR EXECUTION OF ARMISTICE.
