TO : R.C.A.C., Region I

1. Attached is a memorandum received from Colonel Maxwell, MGS, with enclosure relating to certain individuals in the Provinces of Messina and Catania who are alleged to be Fascists.

2. The group mentioned from Messina have been the subject of previous reports. There seems to be sufficient evidence to indicate that despite the opinions of S.C.A.C. Messina and his Executive Officer, the continued association of this group with AMG officers is undesirable. S.C.A.C. should therefore be instructed to eliminate them from any connection official or otherwise with the Military Government. If the allegations of black market activities can be substantiated, prosecution should be instituted. You should also consider whether, on a check of their political records through the SCHEDA'S and otherwise, they should be interned as active or leading Fascists.

3. Will you investigate the individuals named in Catania and take appropriate action. If the allegations with respect to Sig. Paterno are substantiated he should be removed.

4. Please report action taken.

1. Presumably your request is directed to para. 5 basic letter.
2. While it is the firm view of this Division that in view of the facts elicited, the R.C.A.O. of Region II should be unequivocally supported, the fact is that evacuation of civilian internees to N. Africa is contrary to the policy established by 15 Army Group in its directive, dated, I believe, 14 June, 1943. I am of the opinion likewise that AFHQ has this policy, and I seriously doubt if an exception would be made in the instant case.
3. 15 Army Group contemplates the establishment of an internment camp at Certoza di Padula, Province of Potenza, to which all cases dealt with by them and requiring internment will be shipped. It is proposed that this camp will be under the jurisdiction of District No. 2.
4. Public Safety Officer, 15 Army Group, has been consulted, and we are in accord that the 6 persons referred to should be turned over to nearest Field Security Service.
5. If the R.C.A.O. literally means "deportation" as a form of punishment, as distinguished from evacuation for security purposes, then I submit that it is beyond his jurisdiction and would in any event require the sanction of AFHQ. As to the latter point, consultation with Legal Sub-Commission would seem to be desirable.

SUBJECT: Interference with Region II by Badoglio Government

TO : Advanced HQ A.C.C., Brindisi

1. Reference is made to letter of this office dated January 1, 1944 on the subject of the appointment of alleged Fascists and the contents thereof.
2. As part of the purge of Fascists in Potenza Province, a committee of AMG officers and Italian officials and civilians reviewed the records of 221 individuals. Forty-nine serious cases were found. The SOAO recommended that six of these men be deported to Africa and that the other forty-three be given "confino," that is be ordered to change their residence and be kept under close supervision by the Carabinieri.
3. Information of these recommendations reached the Badoglio Government, which through its Ministry of the Interior, sent the attached letter to the Questore at Potenza directing that these men be sent to the Apulian provinces as listed.
4. Since this would remove them entirely from AMG control, as well as because the order has no validity, the SOAO has, of course, directed that it be ignored and those not held for deportation will be sent to Calabria.
5. Attached is a copy of a letter delivered to the Provveditore Agli Studi of Matera Province on or about 21 December, ordering a certain Dr. Nicola Minervini to assume the presidency of the Liceo Ginnasio of Matera on 1 January. This order was issued without prior consultation of any sort with any AMG official in Region II.
6. It is suggested that the head of the Government be informed that dealings and communications of this character between the Government and Italian officials in occupied territory are not countenanced and must be discontinued.

This committee investigated 221 persons charged with being Fascist leaders who had committed offences against Italian laws, but who had escaped prosecution through protection given them as members of the Fascist Party. Reference your letter (not at the moment in my hands) on above
subject.

(1) In forwarding to you reports that I had heard of dismissed personnel being appointed to positions on the Badoglio Government, I deliberately abstained from giving names, or sources of information, or from making any comments, as I did not know if you wished me to make any investigations, and was expecting to hear from you on the matter. As you now say that the matter is being taken up on a higher level, I feel that it is necessary for me, in order to avoid misunderstanding, to explain the matter further.

(2) The allegations, with names and specifications, were made to me by an Advocate Milillo, who is sometimes employed by the Legal Staff here, and considered by them as very reliable sources, using the course of an official conversation on other matters. He stated the allegations as facts, which he said were causing much unrest locally. I made no comment whatever to him, but took a note of the statements after he had gone.

(3) In the one case which pertained to my field, I later made further investigations. I discovered that the dismissed Provveditore of Pescara (by name Cassano Vico Felice) had returned to Pescara for his belongings and had stated to the Provveditorato Staff, including the new Provveditore, Inolani Nello, that he had interviewed the Ministry of Education of the Badoglio Government and that he was about to be put on the Ministry of Education himself. He stated this as a fact.

(4) I have made no further investigations, since I did not know if I was authorized to do so. I did, however, pass the reports on to you for your information in a personal and confidential letter.

(5) Will you please say if you wish me to take any further action.

TO : Administrative Director.

1. This is a matter of first importance and delicacy which may require high level policy and action.
2. In the first place, however, petulant, threatening and objectionable as Signor Reale's letter is to Prefect Tamburro it must be pointed out that Prefect Tamburro should not sign himself Prefetto del Regno as he apparently did but simply as Prefect. This is the practice followed in Region I.
3. Signor Reale has, in my opinion, acted improperly in regard to the following:
 - A. Addressing Prefect Tamburro as 1^o Secretario in view of his approved appointment by A.M.G.
 - B. In writing at all to the Prefect.
4. RCAO. Region I puts the position with clarity, and I would only add to it by stating it is already well known to this Sub-Commission that considerable jealousy exists between the career and the non-career officials.
5. There is no provision as indicated in Signor Reale's letter (closing Paragraph) and Signor Reale should be called upon to explain what he means by this.
6. I regard, in serious degree, the letter and attitude of Signor Reale, and it seems to me questionable whether in view of it, he should continue to hold office.
7. I also draw your attention to the second paragraph of the letter of the SCAO. Matera in regard to Signor Moscato and Signor Vitto. These officials should be screened at an early date, a further report submitted, and if the SCAO is correct in his statements and appreciation, these officials should be removed from office.
8. To summarize - I recommend that:
 - A. All Prefects in Region be instructed to sign themselves as Il Prefetto.

- B. Signor Reale should be called upon to explain why he addressed a letter at all to a Prefect appointed by A.M.G. and to explain moreover the tone of his letter, particularly his closing paragraph.
- C. That Signor Moscato and Signor Vitto should be further reported on in order that a decision may be taken as to their continuance in office.

To : Chief, AMG, MILCOV, Provincia Building, Naples. ✓

1. As part of the purge of Fascists in Potenza Province, a committee of AMG officers and Italian officials and civilians reviewed the records of 221 individuals. Forty-nine serious cases were found. The SCAO recommends that six of these men be deported to Africa and that the other forty-three be given "confino", that is be ordered to change their residence and be kept under close supervision by the Carabinieri.

2. Information of these recommendations reached the Badoglio Government, which through its Ministry of the Interior, sent the attached letter to the Questore at Potenza directing that these men be sent to the Apulian provinces as listed.

3. Since this would remove them entirely from AMG control, as well as because the order has no validity, the SCAO has, of course, directed that it be ignored and those not held for deportation will be sent to Calabria.

4. In view of the favor reported to be shown to ardent Fascists by the Italian government, it is perhaps significant that they want to gather such a choice lot of miscreants under their direct control.

5. A copy of my letter to the Allied Military Mission at Brindisi is attached.

To : Chief, Allied Military Mission (TERR AMG, 15 Army Group)
(Attention: Lt. Col. Montfort.)

1. The attached letter from the Italian Ministry of the Interior is the most recent example of attempted interference with AMG in Region II which has come to hand.
2. The persons named in it are Fascists who, after careful investigation by an AMG committee, are deemed to merit "confino" or deportation.
3. This unwarranted and discourteous attempt by the Italian ministry to inject itself into these proceedings is resented and has been reported to the Chief, AMG. The Italian order will, of course, be ignored.
4. Still another instance of this continual assumption of authority by the Italian Government is the transfer of the head of the Matera R. Liceo to Potenza as of December 1st without even the courtesy of informing AMG of the fact, let alone conferring with it in advance.
5. Since I have received no acknowledgment or action upon several letters of protest against similar acts in the past two months, I am constrained to withdraw the privilege granted by me on October 30th for officials of the Italian Government to visit Region II to gather information, and I hereby request you to inform the Government that any of its officials desiring to enter this region will henceforth be required to obtain specific permission from this Headquarters. I am also directing the censors to return all official mail from that Government addressed to civilian officials in this Region, and to intercept any mail from such officials in this Region addressed to that Government. A copy of this order is attached for your information.

Translation

From the letter read. from you dated 15 Nov. it is noted that you sign in the capacity of Prefect of the Realm. I am compelled to remind you that your actual legal status does not permit you to use ^{legally} any title other than "First Secretary". It is known that when in sudden and exceptional circumstances one assumes functions of high rank, this situation must also apply to official acts deputed to a functionary and signed "For".

This elementary judicial principle must also be a necessity in every functionary, for the sake of correctness and discipline.

The case under review has nothing to do with any authority outside your administration.

Also, you must explain, in due course, why you hold office without having asked for or received the prior consent (preventive assent) of the Government, which behaviour shows an ill-informed and incorrect desire to follow a career and in any case is alien to sound balance essential in every functionary.

Subject: Non recognition of Prefect.

1. The letter of the Undersecretary of Interior addressed to Prefect. Tamburro of Matera Province, handed you to-day, indicates that the Italian Government does not recognize appointments made by AMG. In addition the Prefect has received several friendly warnings from Puglia to the effect that his continuing to consider himself as Prefect will result in possible banishment from Matera when the Italian Government takes over.
2. It has been reported that Sig. Giovanni Moscato, removed from the office of Prefect by us on Nov. 18, is now President of the Council of Ministers and that Dr. Felice Vito, removed as provveditore agli studi because of his connection with the Fascist Party, is now serving the Minister of Education.
3. These factors are preventing our appointees from acting in our behalf with free minds and it is recommended that some assurance be given them that their faithful service under AMG will not be the cause for punitive action in the future.

1. The efficient Prefect found at Matera upon the arrival of AMG was transferred to Lecce upon the request of the Badoglio government with the approval of Maj. Gen. Lord Rennel, during October. After several weeks trial the Vice-Prefect, Signore Giovanni Moscato, was found to be inefficient, was removed and returned to the territory under control of the King. It is reported that he has since been appointed an Undersecretary in the Badoglio government.

2. Upon the recommendation of the provincial S.C.A.C., Dr. Guido Tamburro, then Chief of the Provincial Cabinet and Commissioner of the city of Matera, was appointed Prefect, (subject to final approval by higher AMG authority. Dr. Tamburro is a career official with a family dependent upon his earnings. He has informed the Provincial S.C.A.C. that officials of the Badoglio government, in conversation and correspondence, have intimated to him that he was jeopardizing his career by occupying the position of Prefect and discharging its duties efficiently and in accordance with AMG instructions.

3. I am enclosing a copy of a letter received by him recently. The tone of this letter is certainly threatening and objectionable.

4. Certainly we cannot expect loyal cooperation from Italian officials appointed by us if they are laboring under the constant threat that when control passes from AMG they will be punished for having obeyed our orders.

5. Information is requested as to whether there is any basis for the statement in the next to the last paragraph to the effect that Dr. Tamburro must explain why he holds office without having asked for or received the prior consent of the government; if so, what are the exact facts and limitations upon AMG authorities to appoint officials.

6. If there is no basis for Signore Reale's statements, it is respectfully requested that strong representations be made to stop any such undermining of our authority and to obtain guarantees that the all too few Italian officials who have carried out our orders with energy and efficiency will not be punished for doing so.

1. Attached is a copy of a letter delivered to the Provveditore Agli Studi of Matera Province on or about 21 Dec, ordering a certain Dr. Nicola Minervini to assume the presidency of the Liceo Ginnasio of Matera on 1 Jan. This order was issued without prior consultation of any sort with any AMG official in Region II. It is one of a series of similar actions taken by various officials of the Badoglio Government.

2. Because of the number of these incidents, I am forced to the conclusion that these officials are either totally ignorant of the fact that Allied Military Government, rather than the Badoglio Government, is in charge of public administration within Region II, or they choose deliberately to ignore that fact.

3. I will be obliged if you will inform the Badoglio Government that all communications from it with regard to public affairs in Region II must be handled through the R.C.A.O. of Region II if they expect the slightest attention to be paid to them. Any official acting upon instructions received directly from the Badoglio Government will be severely punished.

4. The order in question will be ignored, as have all those which have preceded it, and Dr. Minervini should be informed that if he enters Matera Province, he will be escorted back to Apulia.
