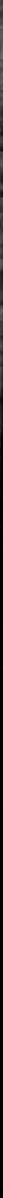

 THE FOREGOING AIMS. IT WAS FURTHER AGREED THAT THE PRESENT

SITUATION DOES NOT ALLOW THE IMMEDIATE SOLUTION OF THE INSTITUTIONAL
 QUESTION, BUT THE CONGRESS CONSIDERED THAT THE FIRST ABOLITION
