IN CASE YOU HAVE NO TRACE OF MESSAGES UNDER REFERENCE FOLLOWING ARE PARAPHRASE OF EACH.

REFERENCE OUR 5 OF 11 AUGUST, AND AMGOT 15 AG PPT SCGV C. 7TH ARMY 788 OF 28 SEPTEMBER. (A) OUR MESSAGE 5 OF 11 AUGUST. STATED THAT A PETITION HAD BEEN RECEIVED FROM DOCTOR LUDOVICO MORONI, EX PREFECT OF RAGUSA, THEN IN CAMP IN THIS COUNTRY ON BEHALF HIMSELF AND FRANCESCO GLAUDIET, EX MAYOR OF MODICA, AND SALVATORE PIETRO MARTINO FOR THEIR RELEASE AND REPATRIATION ON GROUNDS THAT THEY GAVE EXTRA HELP TO ALLIED FORCES AND THAT NO REASON FOR THEIR ARREST AND DEPORTATION. YOUR OBSERVATIONS AND RECOMMENDATIONS WERE REQUESTED.

(B) AMGOT 15 AG MESSAGE. THIS STATED ENQUIRIES SHOWED MORONI'S ARREST JUSTIFIED, BUT THAT ON AVAILABLE EVIDENCE PREPARED ACCEPT RELEASE AND REPATRIATION OF GLAUDIET. 431
FURTHER STATED THAT NO PARTICULARS OF MARTINO.

2. FOLLOWING FURTHER PARTICULARS OF MARTINO HAVE BEEN OBTAINED. ADDRESS WAS 95 VIA CORRERA, MODICA, SICILY. OCCUPATION MANAGEMENT OF ICE CREAM BAR AT 17 VIA MARCHESE, TROFESCHI, MODICA. THE INDIVIDUALS ORATIO MODICA AND AVELLO, LIVING IN VIA MEDICA, MODICA, CAN GIVE INFORMATION EVIDENCE REGARDING MARTINO.

3. PLEASE STATE WHETHER YOU ARE NOW PREPARED TO SANCTION MARTINO'S RELEASE AND REPATRIATION.
