1. The War Department has directed that one capable enlisted man be appointed to act as unit correspondent, in addition to his other duties, in each army, corps, division, group, regiment and separate battalion or comparable unit of the Army Air Force, for the new magazine, "Outfit", which is being published in New York by the Information and Education Division.

2. Immediate action will be taken in all commands to comply with paragraph 1 above. Names of designated correspondents will be forwarded through channels and consolidated by intermediate headquarters for submission to the Information and Education Officer, MTOUSA, by 1 December 1944.

3. Material for publication is to serve the interest of general hospital patients in their old outfits and should, therefore, include designation of units and individuals and full reports of combat and other activities, but not APO numbers. Material will be cleared at the source and forwarded through Information and Education channels to the Information and Education Officer, MTOUSA, who will transmit it through the Public Relations Officer, MTOUSA, after clearance has been given by the Theater Censor.

1. Unit newspapers, when carefully edited and attractively produced, have great orientation and educational value.
2. Publication of such media must be guided by the circulation and contents of Stars and Stripes, Yank and other orientation papers so that there will not be needless duplication and resultant waste of paper, stencils and other materials, which are critical of supply.
3. To avoid overproduction, not more than one copy of each issue of each unit publication will be printed for each five individuals. A limitation of four sheets of mimeograph paper per individual per month in each unit publishing a unit paper is established. Initially, these limitations do not apply to Stars and Stripes and Yank. The mimeograph paper ration may be used in weekly or monthly issues. Issuance of mimeograph stencils and other supplies will be based on the mimeograph paper allotments.
4. Major commands will assemble complete data on requirements for paper, stencils and other materials for the six-month period starting 1 September 1944. Consolidated estimates will be reported to reach the Commanding General, SOS MATOUSA, by 25 August 1944.
5. Each unit publication will mail two copies of each issue to the Morale Services Officer, SOS MATOUSA, for review, editorial assistance and advice.
6. Publications, other than Stars and Stripes and Yank, which use newsprint in offset or letterpress reproduction will submit their estimated requirements through the Morale Services Officer, SOS MATOUSA, for coordination with Stars and Stripes and Yank.
