1. An initial supply of WD AGO Form 71, 5 June 1944 (Combined Office and Report of Entry on Active Duty), is being distributed to this theater in connection with appointments in the Army of the United States. Units may obtain this form from their normal replenishing agency.

2. The oath of Office will be executed and the Report of Entry on Active Duty will be accomplished on WD AGO Form 71 in all cases where appointees are ordered to active duty in commissioned grade on the same day as the oath of Office is administered.

In cases where circumstances prevent appointees from executing the oath of Office on the actual date of being ordered to active duty, the oath of Office will be executed on WD AGO Form 71, but the Report of Entry on Active Duty will NOT be accomplished on this form. In such cases, a separate Report of Entry on Active Duty will be prepared and accomplished. A sample copy of the separate Report of Entry on Active Duty form is attached.
