3. Attached hereto is a list of Zones and the provinces depending upon them. This headquarters maintains a Courier Service to each Zone. The Zones in turn are responsible for delivery to their own provinces.
4. Therefore, if this misdirecting of correspondence originates at your Message Center, it would be appreciated their attention be drawn to this fact.

2. Might steps be taken at your headquarters, please, to notify all couriers and drivers that mail, on reaching Hq ACC, Rome, should not be left with anyone other than regularly authorized Message Center personnel.

MEMORANDUM:

TO : Postal Officer, APO #394

1. The problem has recently arisen of the handling of packages from personnel of the forward regions, i.e., the payment of postage therefor, insurance, etc.

2. The present arrangement is a loose and informal one and may quite conceivably lead to difficulties or abuses. At present packages are simply handed to the courier and the money in payment for the postage therefor sent through Message Center. On frequent occasions, they have arrived without the money to pay for the postage or vice versa. This throws an undue responsibility on the courier, message center personnel and the respective postal sections.

3. I should like to have a standard procedure set up whereby these matters can be handled securely.

4. Will you draw up a S.O.P. on this in cooperation with the British NCO and see me about it.

3. In the case of the mail from "Direzione Generale Della Sanita' Pubblica Della Sicilia", the position is somewhat different. It appears to be for consideration whether, in view of the existence of regular civilian mail facilities, military official mail routes and facilities should be employed for the transmission of material of this nature.
4. If it is desired, by reason of the importance of the activities of the civilian agency involved, to give certain of their communications ADIS service to Rome - such such communications should be sent under cover of a letter requesting onward transmission.

1. I have personally investigated the mail situation of Reg. VIII, and the British Postal Officer informs me that the British air mail is still arriving in this theater from England, not less than two days and not more than four days.

a. Furthermore, I was told that a British Lt. Blair had signed for Region VIII mail to come to a base in Rome without the knowledge of our British mail orderly in ACC, consequently, he did not call for Reg. VIII mail at the British in Rome APO in Rome.

2. We picked up a large number of Reg. VIII British air mail at the British APO this morning of which much of it was post marked back to 21 June, 1944.

Subject: British Mail

Date: 9 July 1944

It would be of great assistance if attention could be directed to the delivery of British Mail. This Region has been established in the same town for over 14 days and a courier service is in being to ROME yet the British mail coming through is very small and quite erratic.

Air mail letters from England (which are on a paid basis) now appear to take 17 days or more to come through and arrive hap-hazard - they contain phrases which indicate that the paid air letters home, are also arriving uncertainly.

Figures released in the Press show there have been over 10,000 casualties, killed and injured, from flying bombs in the South of England in the last few weeks, there is therefore, cause for anxiety when the Post is delayed or very irregular.

Anything that can be done to eliminate postal delays and uncertainties, from and to, NAPLES via ROME would be much appreciated.

MEMORANDUM:

TO : Executive Officer, (Colonel Clough)

1. Attention is invited to the attached copy of a letter from Headquarters, Region VIII.
2. Investigation discloses the following:
  - a. Mail for Region VIII (American and British) is received from Naples.
  - b. This mail is picked up several times a week by a truck dispatched by Region VIII to this Headquarters for that purpose.
  - c. Outgoing mail from Region VIII goes down to Naples on the courier, together with the mail from this office.
  - d. Region VIII does not hold a British censor stamp which causes a small delay at the APO in Naples, inasmuch as all British mail must be censor-stamped.
3. It is suggested that, as soon as practicable, an alternate-day run of a truck be laid on from this office to Region VIII, so that daily service might be provided. This, it is believed, would eliminate a good part of the delay. May this be given early consideration.
4. The original letter from Colonel Kirkwood has been passed to the Postal Officer, for investigation, and report to this office.
5. A copy of reply to Colonel Kirkwood's letter is also attached.

SUBJECT: Mail Service to Region VIII

TO : Regional Commissioner, Region VIII

1. Acknowledgement is made of your letter of 9 July, subject, British Mail.

2. The position with respect to British mail is as follows, so far as handling by this Headquarters is concerned:

a. Mail for British personnel is received daily at this office.

b. British mail for Region VIII is passed from the British Mail Room here, to the American APO, who bag it with the mail for American personnel of Region VIII.

c. All mail for Region VIII is picked up by the Region VIII truck which calls at this Headquarters on alternate days.

d. Outgoing British mail from Region VIII is passed to the British APO at Naples by the next courier after receipt. (A courier which carries personal mail leaves this office daily at 0900 for Naples.) At the British APO it is censor-stamped, and put forthwith into British mail channels.

3. The following sources of delay, so far as this office is concerned, are indicated:

a. The fact that mail for Region VIII is picked up on alternate days, rather than daily.

b. The fact that Region VIII does not hold a British censor stamp, which necessitates stamping of all outgoing mail at the British APO in Naples.

4. The following remedial action has been taken:

a. Application has been made to the Executive Officers for the establishment of an alternate-day truck run from this office to Region VIII, which will insure daily mail service, combined with the existing facilities.

b. The letter from your office has been passed to the Postal Officer, APO 394, at Naples, with instructions to investigate and report any possible sources of delay at that end.

c. It is urged that Region VIII make application direct to the

Chief Base Censor, GMP, for the issuance of a British Censor Stamp, which will obviate the necessity (and delay) for stamping outgoing mail at Waples.

5. Any further comments or suggestions from your office as to how this situation might further be improved would be very much appreciated.

1. Acknowledgment is made of your 5037/Camp of 26 May 1944, with enclosed P/741/1167 of 26 May 1944, addressed to you from Postal Directorate, Hq, AAI, CMF.

2. Apparently the position is substantially as follows:

a. The letter in question was received by 15th Army Group AAG, as per para 2 of basic letter.

b. AAG Liaison, at Hq AAI, at which the postal records of 15th Army Group AAG are now held, state that they received the letter, but "on instructions" forwarded it to Hq, AAG, Naples, for disposition, inasmuch as they had at that time no adequate address for the officer to whom the letter was directed. They state further that "a receipt slip was attached to the letter, but this has not been returned to this section."

c. The postal records of the British Mail Room/APO 394, Hq, AAG, do not disclose any record of receipt of this item.

3. It would appear that correct postal practice would involve the obtaining of a receipt from the Army Post Office by the then 15th Army Group Postal ECO, upon the forwarding of the letter to Hq, AAG, since the letter was registered. Accordingly, if not obtained, the responsibility would appear to lie with the 15th Army Group. Since the personnel appear to be the same, it is therefore suggested that direct contact be had with AAG Liaison, Hq, AAI, who are familiar with the situation.

4. I regret that this office has not been more helpful in the matter, but so far as can be ascertained, the letter never reached this Headquarters.



Dear Sir,

In writing to you I wish to request the investigation of articles totaling to the amount of \$250. in value, which I have mailed in the conformity of all postal laws.

Receiving word today from my Irish wife has called these things to my attention again.

- Ladies 21 Jewel Movement wrist watch
- Make - Bulova
- Case - Solid gold
- Rose-colored Illuminous Dial
- Value \$60. Price \$60.
- (Watch number on way from jeweler in United States)

Mailed within ~~the~~ postal regulations and laws on December 9th 1943 at 133rd Inf. Reg., Post office APO 34. Arrived at customs office in British Isles sometime during first two weeks of April. Amount of Br. customs tax £ 4-4-0., paid before package was received. Package did not contain watch after money was paid to Postal authorities. This package was not and could not be sent from the theater here in Italy, without describing the articles within the package, on Customs Declaration Cards, which were placed on the outside of package showing what the package contained. The package was signed or rather censored by an officer of this Reg. (who is still here) who can definitely say that the watch was in the package at time of mailing. Knowing that the package couldn't be registered through Am. post offices because it was being sent to Br. Isles, I naturally took the chance on its getting there. I believe that the watch was taken from the package either by U.S. postal men or by British postal men after the transfer of Am. mail to Br. for further transportation to the Br. Isles. This no doubt was in the Naples area or city, in Italy. The Br. Customs Officer charged £ 4-4-0 to the receiver of the watch when the package did not contain the watch after it was opened. This leads me to believe that the Br. Customs is at fault because they charged receiver of package £ 4-4-0 for something which had either been taken out before it reached their offices or after it reached them; which goes to show they failed to investigate the package as to its contents before pricing their Customs tax. There is a law on such articles coming from one country to another which is under postal regulations. How could they charge an individual for a package which contained nothing, £ 4-4-0 when the package was empty when £ 4-4-0 was paid?

If they claim to have investigated the package and then put the customs tax upon the article, then they failed to put the watch back in the package. In either case they are at fault, one, for not investigating package and, two, for charging customs on an article that was not received. I know that the Declaration tags of Customs are taken off a package when it reaches Customs office and

is stamped to the effect that it's been there and payment received before delivery. So the watch was not taken from the time it left Customs office until it reached receiver but was taken by Br. Customs or Br. postal men in Naples. Can you help the matter any for me? Do you need the number of said watch before anything can be traced on its disappearance? Or shall I just add it on my profit and Loss list?

Registered Numbers on articles sent to Br. Isles July 1943. Failure to reach receiver.

Registered No. 95 - July 14, 1943, Field Post Office No. 500 (at that time in Tunis, N. Africa.) Package never received.

Registered No. 877 - July 28, 1943, Field Post Office No. 500 - Tunis, N. Africa.

These articles valued at \$190. Priced at \$190. Never were received by the person.

If you could, would you please check this matter for me? At the present I'm in a position where I can't look after it. I'm so sorry I can't get away from here, and I'd take care of it myself with an M-1 rifle.




