1. Very few non-expendible items are included as previously captured Italian equipment is now being returned to the Italian Medical Services. The position requires reviewing at a later date. It is not urgent.

2. All items whose existing stocks will last 15 months or more are omitted.

3. All items whose existing stocks are insufficient for 6 months are marked + and it is recommended that these be taken as the basis of the first consignments and Appendix "A" be accepted as the official demand.

4. Sera and vaccines are not included as facilities exist for local manufacture of T.A.B. and T.T. Issues of typhus vaccine have already been made.

Reference AFHQ signal 58167 cite FHMED of 29 Feb and FATIMA signal 1484 of 1 March, attached are the phased demands for medical supplies for the Italian Armed Forces for submission through staff channels to G-1 Br.

1. Very few non-expendible items are included as previously captured Italian equipment is now being returned to the Italian Medical Services. The position requires reviewing at a later date. It is not urgent.

2. All items whose existing stocks will last 15 months or more are omitted.

3. All items whose existing stocks are insufficient for 6 months are marked + and it is recommended that these be taken as the basis of the first consignments and Appendix "A" be accepted as the official demand.

4. Sera and vaccines are not included as facilities exist for local manufacture of T.A.B. and T.T. Issues of typhus vaccine have already been made.

5. Mepacrine is not included as a separate demand for 45,000,000 tablets has already been made. RASC supplies are not included.

6. Narcotic drugs are included as they are considered necessary. They have been marked with red pencil and if not approved, may be deleted.

7. Insulin, sulphonamides and anti-syphilitic drugs are most urgently required.
