O'DWYER RETURNING TO ASK AID TO ITALY

Brings Report to Roosevelt on Alarming
Mortality and Food Shortage Con-
ditions

Highest Rate is in the First Year ---
Tuberculosis Victims Reach 200 per 1,000

ROME, Sept. 4 -- The situation in Italy with regard to food, public health and mortality has become so alarming that Brig. Gen. William V. O'Dwyer, Chief of the Allied Control Commission's economic section, left Rome today on a dash back to Washington to place facts and figures before President Roosevelt.

Both he and other high officials here feel that not only humanitarian considerations of first rate importance are involved but that the whole test of whether we can give an example in Italy of the American way of life is in jeopardy.

The figures are so terrifying that they can be allowed to speak for themselves. It should be kept in mind that the Allies armies began the conquest of Italy on Sept. 3, 1943, and entered Rome on June 4, 1944.

The infant mortality rate for Italy for children in their first year per 1,000 for live births in the years 1931 to 1935 average 104.7. From 1936 to 1940 it was 102.8. The figures for Rome alone (it is naturally impossible to get all-Italy figures now) for June, 1943, was 287 per 1,000 and for June 1944, 393; for July 1943, 269 and for July, 1944, 438.

POLETTI ALLOCATES MILK

So alarming was this situation that the Office of Col. Charles Poletti Allied Military Government Chief of the Rome area, has arranged to allocate milk destined for children between the ages 1 to 5 years to babies under 1 year, which has brought the latter's death rate down but obviously brings up the question what is now going to happen to children between 1 and 5. 4597

The general mortality trend is also upward, figuring from last year to this. For instance, in June 1943, in Rome 1,373 persons died against 2,535 in June, 1944. Similar figures for July are 2,032 and 2,321.

The tuberculosis death rate in Rome from January to July, 1944, was 3,450 as compared with the pre-war rate of 1,200. It is estimated that people are now dying of tuberculosis in Italy at the rate of 200,000 annually as compared with the pre-war rate of 60,000.

An AMG Rome health officer said about two months ago that the incidence of tuberculosis in Rome was about 200 per 1,000.

Here is the food situation. Before the war the average Italian individual consumed about 2,900 calories daily without alcohol and 3,100 with. During the first eighteen months of war the Italian basic ration in Rome was 1,391 calories daily. During the next twelve months it was 1,129. For nine months before the entry of Allied troops it reached an all-time low of 304.50.

VITAL NEEDS ESTIMATED

Since the Allied occupation a basic ration of 664.77 calories daily has been allowed.

It is estimated that the vital needs of the population are a basic ration of 1,400 calories with available ration foods to bring the daily total up to 2,700.

As things are now it is officially estimated that the average Italian has lost five to ten pounds in weight. In short, it is officially admitted that the Italian diet has caused a general loss of weight in population, an increase in general and infant mortality, an increase in the tubercular rate and a general increase in mortality to all diseases.

If the present basic ration is not increased there is no doubt in the minds of Allied medical and health authorities that existing mortality rates will show a continued increase.

SUBJECT: Medical Supplies.

TO: Acting Chief Commissioner.

Since by ACC/3078/13/VE of 3 Aug. about 270 tons part of the supplies on order for the period 1 Jul-31 Aug have arrived. If it is an overall proportion of the whole order it should be sufficient for about two months. The immediate crisis is over but local shortages may occur until distribution is effected and that depends upon transport.

The situation will be improved as to the future if an application, which I have made to A.I. for release of the Agellini Chemical Works at Ancona, is successful. These works are at present in the occupation of Germans. Raw material is available (German in origin) and if they can be got going, it will save future shipping space and provide a local source of supply and put people back to work.

SUBJECT : Medical supplies

TO : Chief Commissioner,
Allied Control Commission.

1. The Director of Public Health Sub-Commission informs me that supplies for the period 1 July 1944 to 31 December 1944 have not as yet been received, even in part.

This non receipt of supplies, a partial shipment of which should have arrived in early July will unquestionably result in unfavorable criticism from many sources.

2. The director of Supply Branch, Public Health Sub-Commission learned, while in Washington, D.C. 6 June to 20 June 1944, that final approving action on this requisition was taken during that period and that first shipments would not be made until about 11 July from the U. S. A. Recent radio from AFHQ indicated first expected shipments medical supplies will be during period 19-26 August.

3. A small reserve has prevented serious shortages to date but the public health Sub-Commission cannot assume responsibility for distribution of medical supplies which do not arrive for the maintenance period involved. Even after arrival of these supplies a considerable period must of necessity elapse before they can be delivered to final using destination due to present transportation problems.

INSTRUCTIONS FOR ALLOCATION AND ASSIGNMENT
OF CAPTURED ENEMY MATERIEL

Circular Number 63, this headquarters, 1943, is hereby rescinded. The following instructions outline the organization, and prescribe in general the procedure to be followed in the allocation and assignment of serviceable and repairable captured enemy materiel.

1. Definitions.

a. Captured Enemy Materiel. For the purpose of this directive all equipment, stores, and supplies previously belonging to all arms and services of the Ground Forces of the enemy. (Equipment, stores and supplies previously belonging and peculiar to Naval and Air Forces of the enemy will be dealt with in accordance with directives to be issued by C-inC Mediterranean Naval Forces and CG, MAF).

b. Italian Materiel. All Italian materiel belonging to all arms and services of the Italian Ground Forces and in the possession of the Italians at the time of the armistice is considered as Italian materiel and, except as otherwise directed by this headquarters is reserved for the use of the Italian Army under the direction of the Army Sub-Commission, Allied Control Commission.

2. Organization.

a. The responsibility for the assignment of serviceable and repairable captured enemy materiel and the maintenance of necessary records pertaining to such materiel and supplies is placed upon a Special Staff Sub-Section of the Quartermaster Section this headquarters, known as Captured Enemy Materiel Section (previously called Captured Enemy Materiel Executive Committee). It is an integrated section consisting of American and British officers.

b. Captured Enemy Materiel (C.E.M.) Sub-Section representing C.E.M. Section this headquarters will be attached to Headquarters of Armies, Districts, Areas, and Base Sections whenever the presence of captured enemy materiel renders it necessary.

c. The instructions contained herein are not to be interpreted in any way as relieving Commanding Generals of Armies and Areas of their responsibility for collecting, sorting, classifying, safeguarding and evacuating captured enemy materiel in accordance with existing instructions to specified parks, dumps, etc.

3. Duties and Responsibilities.

a. G-3 (Org), this headquarters.

- (1) Formulates and assigns priorities for captured enemy materiel.
- (2) Processes all communications with higher authorities.

b. Quartermaster C.E.M. Section, this headquarters.

- (1) Formulates policies for the operation and controls C.E.M. Sub-Sections at subordinate headquarters.
- (2) Calls for, receives, and collates all reports from C.E.M. Sub-Sections at subordinate headquarters.
- (3) Lists separately serviceable and repairable materiel and obtains allocation instructions from G-3 (Org).
- (4) Receives all demands for allocations of captured materiel and processes such demands to G-3 (Org) for allocation instructions.
- (5) Issues disposition instructions based on G-3 allocations.

c. C.E.M. Sub-Sections at other headquarters.

- (1) Forwards to this headquarters (C.E.M.) lists of captured enemy materiel. These lists will, as far as practicable differentiate between serviceable and repairable materiel, and will normally be prepared by the special staff or service concerned.
- (2) Advises and cooperates with Special Staff or Service on matters pertaining to the collection, classification, listing and servicing of captured enemy materiel.
- (3) Makes inspections of dumps or parks containing captured enemy materiel to determine whether instructions for collection, sorting, classification, and safeguarding are being followed.
- (4) Renders reports called for by higher authority.
- (5) Obtains and processes disposal orders on serviceable and repairable captured enemy materiel from Quartermaster C.E.M. Section this headquarters. (For disposal of Salvage (British) or unserviceable materiel (U.S.) see paragraph 4 below).

4. Procedure for collection and Disposal of Salvage (British definition) and unserviceable materiel or scrap (U.S. equivalent). This will continue under normal procedure. The basic document in the case of United States forces is Circular Number 18, Headquarters MATOUSA, 1944.

5. Demands for Captured Enemy Materiel. These will be addressed to C.E.M. Quartermaster Section, this headquarters, through the following channels:

Inside the Theater

For Intelligence Research through G-2; this headquarters.
For Operations through G-3 Operations, this headquarters.
For Training through G-3 (Trg), this headquarters.

Outside the Theater

For Intelligence Research through G-2, this headquarters.
For all other purposes through London Munitions Assignment Board.

6. Removal of Materiel or Supplies. When an agency or supply service is allocated captured enemy materiel or supplies, it must assume the responsibility for identifying materiel or supplies for which they have approved allocation instructions and to arrange for their removal from area, park, or dump in which located, and for their preparation for shipment within the theater or for destinations outside the theater. (AG 400.93-1-D-0)

1. The Italian Ministry of War have been consulted on the taking over of 7607, Italian Station Hospital in PALESTRO, and are greatly in favour of the proposal.
2. It is recommended that the proposals contained in para.3 of AG 383/76(I RMD) dated 14 Feb 44 be adopted, and the personnel of the hospital be released outright to the Italian Government subject to the normal security demands. This is essential both from the undesirability of mixing P.W. and Co-Belligerents, and because of the already serious shortage of Italian Army doctors.
3. It is further recommended that FIVE Italian Ambulances be returned for the use of the Hospital. This is considered most important, as none are available from the mainland, where already there are not sufficient for requirements.
4. If the above proposals are agreed, the Medical Directorate of XII Italian Corps (SICILY) will arrange to take over the Hospital which will then be under command XII Italian Corps.

Dear General.

In answer to your CC/P/279 of 12 May.

I have made enquiries about the two Frigidaires and they do not appear to have arrived on this side.

As, presumably, they were loaded in N. Africa and required to be delivered to French HQ in NAPLES I do not think they are likely to have come to an East coast port. It is more likely they were off-loaded at NAPLES, and they may still be there. Without more definite information as to date and port of loading and how the packages were consigned and marked it is difficult to try and trace them.

As their provision was probably arranged by AFHQ at ALGIERS, I suggest that Gen Clark (CAO) or Gen Lewis (ICAO) at AFHQ be asked to trace from their end. Meanwhile I have instructed my Medical branch to watch out for their arrival here, and ensure they are despatched to French HQ at NAPLES.

1. The Chief Commissioner's report for March 1944, Para. 55 states that the work of the Typhus Control Service is now to be handled by the Rockefeller Foundation and the Italian civilian medical and lay group.
2. It is regretted that the March report of the Public Health Sub-Commission, Para. B, 1, lays itself open to this interpretation.
3. It is a fact, however, that the Typhus Control Service is still the responsibility of this Sub-Commission and is headed by Lt. Col. Williams, the Deputy Director of the Sub-Commission. He is still the Director of the Typhus Control Service activities, but in these activities is relying more upon the services of the Rockefeller Foundation and Italian agencies and less upon the services of ACC medical men, who have been released for other spheres of activity.
4. It is trusted that this explanation will clarify the situation.

The Director of Public Health informs me that he has discussed the question of getting out more Red Cross workers from the United Kingdom with Mr. Jefferson (ARC), who feels, as does Brigadier Parkinson, that we should not ask for more than we are able to employ at once and considers that at the moment eight are all that are required to supplement those already in the field.

The type of worker required is one who has had experience of community organization and who is accustomed to team work as this training is essential for the work required among the Italian people.

As more Red Cross workers with these qualifications will be required, not only in this theater of war but in others in the near future, it would be well if such training was included in the course of instruction of Mobile Units who may be called on to proceed overseas.

It is generally agreed that the many activities connected with Welfare have only been made possible through the complete cooperation and help which has been given by the Red Cross workers in the field.

*** "I believe that my recent letter to you has already stated that we were notifying Dr. Soper that the International Health Division was accepting the invitation to work in Italy on malaria and typhus control and he will doubtless plan the details of our relationships. It is a great satisfaction to know that he will be working with such good friends of ours, including yourself, Brigadier Parkinson, and Colonel Russell. The whole plan, as far as we understand it, seems an ideal entrance by the Division into the war and postwar work in Europe. Needless to say, we are enthusiastic at this early beginning under such good auspices. The problem now is to find the required personnel and assign it as quickly possible. We have already arranged for Dr. Kumm to come home from Colombia, establish his family here, and leave for Italy toward the end of June. Mr. Knipe, who is now in Mexico, will be available at about the same time."

I believe Dr. Sawyer's comment regarding "post war work in Europe" will be of especial interest to you because of the long range aspects of malaria and typhus control programs inaugurated under ACC.

- 1 Cases of Small Pox have occurred in both Naples and Taranto. The following is a summary for your information of the position and of the steps taken.
- 2 NAPLES. 16 cases have been reported of which in 11 cases the diagnosis has been confirmed. 5 suspects cannot be found, over half of these cases have occurred in the Toledo Area west of the Via Roma.

Supplies of vaccine have been provided and the Municipal Medical Officers have been strengthened by teams lent by the Typhus Control Branch. It has not been possible to trace all contacts. The publication of an order for general vaccination is under consideration.
- 3 TARANTO. 5 cases have occurred, all are in hospital. 46 contacts have been traced, vaccinated and quarantined. Extra vaccine and medical assistance has been supplied. Mass vaccination is in progress.
- 4 The Italian Government have issued an order containing medical instructions for control, notification etc, which is applicable to the whole of unoccupied Italy and among other matters provides:
 - a for vaccination of Italian nationals employed in contact with Allied Forces.
 - b for vaccination of children attending primary and secondary schools.
 - c for isolation and vaccination of suspects, and
 - d for voluntary vaccination of others with some degree of propaganda to induce persons to volunteer.

SUBJECT: Medical Stores and Distribution in Sardinia.

TO : Military Government Section,
Allied Force Headquarters.

1. I have delayed replying to your MCS: 014.4-8 of 8 March 1944 until I could extract all the information available.

2. My Executive Commissioner has seen Mr. Coahie who tells him that he had no intention of implying to you that there was anything seriously wrong but he felt that he had to draw your attention to the fact that medical supplies had been landed in Sardinia and had not yet been distributed. He admitted that it would have been far better had he reported the matter directly to this Commission who could have given him information which would have modified his views, and he now regrets that the matter should have assumed such large proportions.

3. However, it is necessary to answer the points raised by him and the implications made by you that the state of affairs is very wrong. First of all I should like to state that the story about the deaths occurring owing to a lack of medical supplies is untrue. In particular the deaths reported from Nula have been carefully investigated and are now reported by the Medico Provinciale to have totalled six, all of whom died from natural physical causes. The Medico Provinciale reports that it is most improbable that the presence or absence of medicines would have effected the result of the illness and that his commune is close to Benetutti where there is a pharmacy which had reasonable supplies of essential medicines.

4. The delay in distribution of stocks of medicines from the "James Randall" was due to the fact that no price list had arrived with the drugs and that the eventual price list was made out in US currency and US weights, dosages were in US terms and some of the drugs were in a form not familiar to Italian doctors. All the necessary conversion tables, translations and instructions to Italian doctors had to be prepared by Capt. Brooke. The Regional Commissioner, who was aware of the delay and approved of it, rightly states that to have made an empirical broadcast distribution of the "James Randall" shipment without tables and price lists would have been quite unjustifiable and would have involved gross inefficiency and serious waste of very precious supplies.

5. The Regional Commissioner considered that distribution should not be made until he had discussed the matter with the Medical officer in charge of Medical Supplies for this Commission. This officer was unfortunately delayed in Tunis until 28th February.

6. That the officer in charge was unaware of the nature of the supplies was due to the fact that no ship's manifest or shipping list was sent with the supplies and that every case had to be opened in order to prepare a detailed inventory.

7. The Medical Officer in charge of Medical Supplies for this Commission was in agreement with the Regional Commissioner.

8. I think there was delay in distributing these supplies. It is possible that the supplies could have been distributed to the satisfaction of Mr. Goshie and other critics but not necessarily to any great amelioration of the health of the island. Had they been so distributed a scandal would have arisen on the question of finance and undoubtedly a great waste would have occurred.

9. It is very easy on a short visit to pick up criticisms of administration without knowledge of all the facts. It is dangerous to disseminate such criticisms without discovering the facts.

10. I should like you to know that the course taken by Brigadier Dunlop has my approval, that the medical supplies are now being distributed and I should like you to realise the difficulties attendant on the distribution in Italy of unpriced, and to the local population, unknown drugs, without causing loss, waste, and financial difficulties that take many months to overcome.

BRIGADIER P. PARKINSON:

"Italy and the surrounding islands are highly malarious in many parts. Especially Sardinia, among the islands. It has been a problem in the past -- it will be very much greater now, with the destruction of pumps and the blocking of canals. It seems to me that we must have complete cooperation if we are going to get anywhere. ACC AIG forward areas are responsible for the civilian side of control, but malaria knows no bounds and it is important for the troops to be kept free from malaria. Many of you know that at the landing on the beach at Salerno, there were too many cases of malaria. We are going to try to prevent anything like that again. A great deal of that has been thrown out of joint up for controlling malaria. During peace time in Italy there was a set-up by lack of personnel, transport, equipment, etc. We have got to do all we can to get the civil control agencies going as quickly as possible. I think that malaria control can be divided into long and short term programs. I think we should adopt wherever possible, short term programs in the months to come. Short term programs may become long term programs in the end. Try to carry things out up to the end of autumn without trying to establish permanent measures for the next year to come."

Malaria Conference (8 Apr 44)

COLONEL RUSSELL:

"We certainly all agree that the malaria problem this year will be an acute one. The density of the mosquito vectors will be increased because breeding places have been increased. Gametocyte carriers will be more numerous and contact will be more intimate among the general population. I think it is quite true that we must defeat malaria this year or it may seriously delay military operations. It seems to me we all agree on this point. Now, the technical part of malaria control is not a problem. The great difficulty this year, as I see it, is one of organization and coordination. I wrote down the other day a list of allied military entities interested in the control of malaria. There are 41 on the list -- not counting some 42 civilian malaria committees. Obviously, there must be cooperation and coordination of programs.

"The Allied Control Commission recently set up a Malaria Control Service with functions as follows:

"(a) To assist the Senior Civil Affairs Officers and the Regional Commissioners of ACC in restoring civilian malaria control agencies and in directing their activities.

"(b) To coordinate civilian and military control programs as far as possible so that they will give maximum help to the military effort.

"(c) To carry out certain practical and essential field experiments. The insecticide called DDT promises to be very helpful in the control of malaria. It seems possible that through the Malaria Control Service of ACC it might be possible to do some field experiments which would be of practical help to the Army. The Rockefeller Group may be able to help out in this field.

"The staff of the Malaria Control Services consists of the director, one medical officer, one engineer and one entomologist. We want to be called upon for help where military problems impinge on civilian or vice versa. We are all in the Army and are a part of the war effort. Our aim is not malaria control next year, it is malaria control this season, with particular reference to the war effort."

CAPTAIN BRAND:

I believe that the area south of the Tusciano River can be adequately cared for around major military installations by the 23rd Malaria Control Unit."

Captain Brand stated that he did not think he was getting as much civilian help as was needed. It was decided that Captain Hill and Major Davidson would meet with Captain Brand early next week to delimit the boundaries between Paestum and Salerno.

Captain Hill stated that in his area they had some difficulty keeping their pumps supplied with oil and that as yet they have no definite boundaries. Captain Hill further stated that he hoped there would be no objection if they went over boundaries as long as the objective was effectively obtained on both sides.

At this point the supply of oil through the ACC CIP was discussed. Colonel Russell mentioned that there might be some difficulty transporting oil to the different areas, but that in Army areas probably a truck would be available to transport this oil. ACC has already provided oil for civilian use at central supply points, where it is held by the CIP (Comitato Italiano Petroli).

Colonel Russell also noted that military installations are subject to move without previous notice. ACC wants to have civilian agencies ready to continue the work that has been started. Therefore, ACC would like to be fully informed as to what programs are in effect so that if the military moves on ACC can attempt to see that the work continues.

Colonel Crichton agreed on the above point and mentioned that some of the pumps were not functioning because they have either been damaged or lack oil or electrical power. He mentioned the fact that he spoke with Colonel Arnest concerning the current to the pumps in the region of Sessa and that Colonel Arnest would try to assist in the matter.

The electrical power problems in both the 5th Army and PBS sectors were discussed and it was decided that if power was needed in certain sections a request would be put into writing and submitted to the proper authorities. Captain Hill stated that there was a shortage of pumps in his area.

Lt. Colonel Parr stated that in the province of Sessa during peace time there had been a very good malaria control organization. The doctor in charge of that organization is still there and would like to have the Army help him restart the organization. Colonel Parr mentioned a budget prepared by the Italian doctor requesting money (1 million lire). Colonel Russell said that if such a budget were approved money would be available. Colonel Russell emphasized the importance of stimulating civilians to do work for themselves, so as to save manpower for the armies.

Captain Bowen (5th Army) described conditions in his area. Civilian labor work will be confined to towns until at least the first of May. COLONEL RUSSELL:

"Colonel Griffin of the Medical Supply Service, ACC, reports that oil supplies have been distributed on a regional basis where they are now being handled by CIP. I understand that we are to have as much oil as we need this summer."

COLONEL CHALKE:

"I would like to bring out a point about Paris Green. I gather that there will be no Paris Green for civilian use. The policy, as I understand it, is that Paris Green would not be available for malaria control for the protection of civilians, but would be for the use of the Allied Forces. But what about the civilian laborers working in cooperation with the Army?"

Malaria Conference (8 Apr 44)

It was stated that while there was no official ACC supply of paris green, but in some regions there were small civilian stocks remaining over from last year. Where civilian work was for direct protection of military installations, paris green might be used.

The labor problem was discussed and it was pointed out that there is a definite standard wage scale for the Theater. Laborers working 8 hours a day on a 24-hour day basis with quarters are served 3 meals a day. Day laborers for the Army receive a noon meal for which 7 lira are deducted from their wages.

Under the present set-up Italian contractors have no method of getting Army rations for their men.

Captain Brand stated that at the paris green plant, laborers have been asking for meals to be served to them. He thought the difficulty there lies with the contractors who hired the civilian laborers and offered them higher wages (100-125 lira) a day instead of feeding them.

TRANSPORT

The malaricologist in the Foggia area has reported an Air Force Service Command directive providing for the transport of civilian labor to and from their work. It was agreed that in any area transport would not be a serious problem but that elsewhere considerable ingenuity would be required to provide necessary transportation.

COORDINATION

It was decided that a central information bureau might well be established at the office of the ACC Malaria Control Service, Room #5, in the Post Office Building. Copies of all reports might be sent to this office from which information could be disseminated to those who desired or required it, with due regard for military security.

1. Your suggestion that the Rockefeller Foundation continue its collaboration with the Allied Control Commission in the control of Typhus and undertake the investigation of methods for the control of Malaria meets with my full approval. However, the approval of the General Director of the Rockefeller Foundation Health Commission in New York is necessary before definite commitments can be made.

2. My approval is based on the assumption that the Rockefeller Foundation has available the necessary technical personnel which can be assigned to this area and that the Allied Control Commission will secure authorization for transportation for such technical personnel to come out from the United States.

3. There are now three Foundation staff members here available for continued service; one doctor, one bacteriologist, one entomologist. On the basis of preliminary discussions of the proposed program with the Deputy Director of the Public Health Sub-Commission and with the Director of the Malaria Section of the same Sub-Commission, it seems that provision should be made for an immediate increase of staff by the addition of

- Two doctors
- One Engineer (Malariaologist)
- One Entomologist

4. It is proposed to transfer the operating headquarters of the Typhus Field Unit of the Health Commission from North Africa here. This will involve securing shipping space for certain office and laboratory supplies now in North Africa.

5. It is understood that the program undertaken by the Rockefeller Foundation is an integral part of the activities of the Public Health Sub-Commission of the Allied Control Commission which will be responsible for approving the general plan of action and undertaking to make available necessary supplies, transportation and subordinate personnel.

6. Attached herewith is a proposed cable to the home office of the Rockefeller Foundation requesting approval of the proposed program. It is requested that this be forwarded through official channels.

1. As cases of typhus in Naples and district are now occurring only sporadically it is considered that it would be opportune for some of the staff to undertake research work with a view to increasing the knowledge of and improving the technique of handling this disease.
2. It is hoped that you will be able to obtain the consent of the Rockefeller Foundation to your remaining in Naples for this purpose.
3. It is considered desirable that investigations should also be undertaken with regard to malaria and its control in which case an increase of your staff may be necessary; if so, will you please let me have your views on that point.

MEMORANDUM:

TO : Administrative Directorate.

Reference the two questions on Public Health raised yesterday, given below is the information for the Chief Commissioner:

- (a) Italian law demands notification of Typhus by a doctor, but if the doctor is not called in, the case remains unreported. Steps have been taken to get the Prefettura to publish a decree imposing on heads of families the responsibility of notifying to the communal authorities any case of fever lasting two days or over. Col. Crichton reports that this decree has not yet been published, but he is making every effort to expedite it and hopes it will be promulgated in a short space of time.
- (b) Concerning the question of Red Cross property the following information has been obtained:
The Red Cross Hospital at Siracusa, Sicily was taken over by the Army. It was not properly conducted by the Red Cross and after being put into condition by the Army it was not returned to the Red Cross. The Director of Public Health, Italian Government, informs this office that certain supplies and equipment were taken from a Red Cross Hospital train at Foggia by the Army and the material used to equip three of our trains. He has no further information.

1. A Typhus Control Board was established in accordance with instructions issued under this HQ 3095/A1 dated 11 Jan 44 as reconstituted by 3095/A1 dated 21 Feb 44, and a Malaria Control Board was proposed under this HQ 3095/8/A1 dated 15 Feb 44.

2. There are, however, other important aspects of Preventive Medicine which can with advantage be discussed by a representative body of this nature, in order to achieve co-ordination and the production of a unified policy. It has been decided, therefore, to form a Hygiene Advisory Board, which will take over the functions of the Typhus and Malarial Control Boards and will, in addition, be concerned with questions of Hygiene and Preventive Medicine.

3. The Board will be composed of the members of the Typhus and Malaria Control Boards, whose responsibilities will remain as defined in the above quoted memoranda, together with any other Military or Civil representatives whom the Board may decide to co-opt.

4. The Board will advise the C.A.O., A.C.M.F. (Adm. Ech) on all matters of policy relating to Hygiene and Preventive Medicine as well as on questions of Malaria and Typhus, and will report to him as often as is considered necessary.

5. Meetings will be convened by the Chairman and will be held at such intervals as are considered necessary.

SUBJECT: Venereal Disease.

TO : Vice President,
Administrative Section.

1. I attach copies of letters addressed to Chief Administrative Officer, D.P. A.C.P. and Regional Commissioners on the subject of venereal disease.

2. I should be grateful if the strongest representations could be made to the Minister of Interior and the Minister of Justice in order that directions may be given from the Italian Government to give effect to the Italian law on prostitution in the most drastic manner.

3. Our present experience is that the Italian medical authorities play their part well in the prevention of venereal disease but there is no doubt that the Law, which is comprehensive, is not being effectively administered either by the Carabinieri or the Courts.

4. I would ask that special instructions be given by the Minister of Justice that cases affecting prostitution should be dealt with rapidly and that severe sentences should be imposed.

2. The Italian law with regard to prostitution, procurement, and solicitation, is sufficiently comprehensive and severe to reduce the evil to a minimum provided that the law is properly and firmly administered.
3. It is the duty of Regional Commissioners, whether in A/C or in territory under the Italian Government, to see that the laws against prostitution are administered rigorously and effectively.
4. In order to attain this end Regional Commissioners will see that the full details of the Italian law are brought to the notice of the military Provost authorities in order that the military Police may know what is an offence and what is not. Regional Commissioners will also ensure that the Carabinieri enforce the law in co-operation with the military Police, and finally, they will ensure that Allied military Courts and Italian Courts deal with such cases severely and rapidly.
5. Provided a concerted drive is made by the Allied Military and Italian Police, by the Allied Courts and Italian Tribunals, and provided that Regional Commissioners instill into their provincial staffs the menace to the Allied Forces which the spread of venereal disease is now causing, and provided that

5. Provided a concerted drive is made by the Allied Military and Italian Police, by the Allied Courts and Italian Tribunals, and provided that Regional Commissioners instill into their provincial staffs the menace to the Allied forces which the spread of venereal disease is now causing, and provided that Regional administrative staffs see that the law is applied, much can be done to reduce the instance of disease and assist the Allied troops. Every effort will be made by Regional Commissioners to see that the medical staff, both Allied and Italian, fulfil their duties with regard to the inspection and control of prostitutes.
6. Regional Commissioners will be asked from time to time to go beyond the law and to take extraordinary steps such as the interning of clandestine prostitutes, etc., but provided the law is strictly administered there should be no need to go beyond it.
7. It is of paramount importance that Regional Commissioners should do their utmost to assist the Allied troops in this matter.

TO : Chief Administrative Officer,
Headquarters, A.C.M.G.

I refer to your ACPM/3073/A(0) dated 1. Mar. 44.

1. The Chief Commissioner is most anxious to co-operate in the prevention of venereal disease amongst Allied troops and I am directed by him to say that everything will be done both in areas under Military Government and territory under Italian Government to assist the troops.

2. In the opinion of the Chief Commissioner, the law, both A.M.G. and Italian, is sufficient as it stands. Pimping, prostitution, solicitation, are offences under Italian law which are administered by both Italian and Allied Military Courts and the Italian law deals with the matter as comprehensively as possible.

3. The weakness at the present moment lies in the knowledge by Allied Military Police of the offences under Italian law and in the application of that law by the civil police and the courts of justice. It appears to the Chief Commissioner that in these respects much improvement could be made and it is his intention to issue a directive to Regional Commissioners instructing them in areas under A.M.G. to see that the Allied Military Courts deal severely with all cases affecting the morals of the troops and in the territory under the Italian Government to advise the Italian courts to do the same. A strong representation will also be made to the Minister of Justice in the Italian Government and it is hoped that this will have the desired effect. At the same time the Commissioner feels sure that you will agree that basically the prevention of venereal disease lies in the degree of discipline amongst the troops themselves.

It was agreed that they come in the same category as troops stationed in Naples and it was recommended that subject to the strict enforcement of the following rules, Naval and Merchant Seamen be allowed to enter Naples. The position to be again reviewed on 10th. March.

(a) Organised shore parties in charge of an Officer or Petty Officer may visit Naples during the day up to 1800 hours.

(b) They will not enter any buildings or houses other than those set aside solely for the use of the Allied Forces.

(c) Before disembarking, a statement will be read out to each party, which will explain the dangers of contact with civilians in a city in which cases of Typhus are occurring.

(d) All trucks will be dusted with Insecticide Powder before leaving the dock area.

(e) Only inoculated personnel will be allowed ashore.

4. Transport. Lieut. Col. Williams stated that 6 Ambulances and troop carriers had now been made available from British sources and 16 of the vehicles loaned by P.H.S. were being retained - the remaining vehicles had been returned.

5. U.S. Typhus Commission. The Board unanimously agreed that a cord be made in the minutes, of its great appreciation of the work done by the Typhus Commission in bringing the typhus epidemic under control. The excellent organization set up by the Commission greatly facilitated the assumption of Control Measures by the Allied Control Commission. It was decided to inform Brig-Gen. Fox of this minute.

Teams are being sent out to these camps regularly by the Typhus Commission. Colonel Bishop said that refugee control was the least efficient aspect of the Typhus Control problem.

4. The present position of the Epidemic.

In view of the impending withdrawal of the United States of America Typhus Commission, the continuing epidemic in Naples City and the spread of Typhus outside Naples, following permanent staff essentially and urgently required to control epidemic in addition to staff available locally - 20 Medical Officers, five Sanitation Officers and 10 non-technical Administrative Officers. Eight of the Medical Officers must be bi-lingual. In addition minimum of 45 first class vehicles consisting of jeeps, command cars and weapon carriers and six ambulances fit for rough work also urgently required. Total staff at present employed on Epidemic consists of 65 Officers and Doctors and 500 Civilians with inadequate transportation which PBS advises will be withdrawn 10th February.
