COLONEL JACKMAN opened the proceedings by reviewing the history of Allied Force Records Administration, which is charged with the responsibility of:

- (1) Assembling all combined British-American records created in the theatre.
- (2) Reproducing such records by means of microphotography.
- (3) Maintaining such records, after microfilming, to ensure availability for answering enquiries pertaining thereto.
- (4) Transferring such records, at the proper time, to designated agencies of the governments of the United Kingdom or the United States, in accordance with the directives of the Combined Chiefs of Staff

These responsibilities, COLONEL JACKMAN pointed out, include, but are not confined to, Allied Commission Archives.

It was recalled that on the basis of proposals submitted in HAF 1128 by Allied Force Headquarters to the Combined Chiefs of Staff, the letter, in FAN 672, had authorized the Supreme Allied Commander to make necessary arrangements with the British and American Embassies in Rome for the transfer to the Embassies, at the end of the military period, of responsibility for Allied Commission Archives, and for transfer of necessary personnel and equipment to complete the microfilming project. In so far as the microfilming project is concerned, Allied Force Microfilming and Records Depot could not be transferred to the control of the Embassies unless provisions are made for the completion of its commitments, other than those pertaining to Allied Commission Archives, after the transfer takes place.

COLONEL JACKMAN at this point referred to AGWAR Cable W 34414, dated 31 October 1946, to CONGENMED, which is quoted as follows:

"Disposition ALCOM archives refer FA 672 is subject.

"1. State advises that while it concurs in proposal to transfer ALCOM archives to joint custody of US and UK Embassies at ROME, it can NOT provide personnel for arrangement and microfilming of documents and incidental custody during completion this work. State assumes that US military personnel and equipment now utilized in this work under direction ALCOM will continue in some capacity after dissolution ALCOM until completion.

"2. CCS authorize SACMED to arrange transfer responsibility for archives and of necessary personnel and equipment to complete microfilming to US and UK Embassies at end of military period.

"3. Present plan for transfer residual ALCOM functions contemplates that maintenance and disposition of ALCOM will be responsibility of G-3, AFHQ.



"4. War plans reply to state referring to FAN 672 and giving assurance that US personnel and equipment now utilized in arranging and microfilming archives will continue to be employed on project until completion.

"5. Your comments requested together with views regarding appropriate administration provisions which should be made to maintain such personnel after dissolution ALCOM and approximate time to complete project for use on a basis for reply."

It was stated by COLONEL JACKMAN that reply could not be made to this cable until agreement had been reached among the present conferees on the question of the future of Allied Force Records Administration itself and the Allied Force Microfilming and Records Depot. At this point a simple chart was produced to show AFRA's conception of the organization that would be placed under the control of the two Embassies at the end of the military period. This chart is reproduced below:



It was emphasized by COLONEL JACKMAN that a completely self-sufficient organization, under this plan, would be transferred to the Embassies at the proper time, and that the respective military attachés would not need to be concerned about administrative and technical details. The military character of the records (other than those of Allied Commission), and the fact that Allied Commission records (although generally non-military in content) are the creation of a military establishment, constitute a strong argument for the establishment of direct contact between the military attachés and the Combined Chiefs of Staff, on all aspects of this program.

BRIGADIER CARR raised a question on the expectation of life of Combined Chiefs of Staff, and COLONEL JACKMAN indicated that they are a permanent body as far as is known at the moment. MR. GREENE and MR. HANDEY both confirmed the fact that the military attaché is a member of the Ambassador's diplomatic staff,

in either case, but indicated that there would be no objection to direct contact with Combined Chiefs of Staff as had been proposed.

LIEUTENANT MUNDEN commented on the proposed organization, mentioning that it had received the informal sanction of G-5, AFHQ, and of the British and American political advisers at AFHQ. It had been agreed by all these that provisions should be made to complete the work of Allied Force Records Administration following the end of the military period. The Advisory Group (referring to the chart) would take over, at the proper time, all undischarged responsibilities, and would carry on AFRA's present functions. The microfilming unit would continue the present work of Allied Force Microfilming and Records Depot, minus its custodial or archival functions, which would be combined with corresponding functions of Allied Commission to form the Archives Unit.

LIEUTENANT MUNDEN also stated that the organization, once it passed to the control of the Embassies, would complete the filming and proper disposition of such AFHQ and other combined records as cannot be released for microfilming until the end of the military period. MR. HANKEY asked how long it would take to complete the microfilming of the combined records (including those of Allied Commission) after the end of the military period, and COLONEL JACKMAN stated that with the present equipment 2½ years would be required to complete the filming of Allied Commission records alone, and that from 6 to 8 months would be required to complete the filming of the other combined records. CAPTAIN LEE commented, and CAPTAIN LEWIS confirmed, that practically no AFHQ records for the years 1945 and 1946 have been filmed. LIEUTENANT MUNDEN added that other large groups of combined records are yet to be accessioned, such as those of 13 Corps, Rome Area Allied Command, and Allied Screening Commission.

Referring to the proposed organizational chart, MR. HANKEY stated that the British Embassy would not have a military attaché until the Peace Treaty with Italy is signed, but COLONEL JACKMAN reported that the proposed organization would not become effective until the end of the military period. However, AFRA's contention was that the success of the programme as proposed would rest on the existence of military attaché offices in the two Embassies. MAJOR KUSSEML stated that he felt strongly that matters affecting these combined records should be kept in military channels, and that the British and American military attachés should be able to go to the Combined Chiefs of Staff without going through diplomatic channels. COLONEL WILLEMS then stated that he considered that the organization could not be set up in any other way. He considered that in the United States Embassy there would be no difficulties in the matter of channels of communication, but added that he hoped that the whole project would come to the embassies as an organization already complete and self-sufficient. COLONEL JACKMAN agreed that the organization should be complete in respect to qualified and experienced personnel, supplies, equipment and funds when it goes to the Embassies.

MR. HANKEY gave his opinion that the British Ambassador would have no objections if a member of his staff (the military attaché) should be directly responsible to the Combined Chiefs of Staff, in so far as this project is concerned;

and MR. GREENE stated that he did not foresee any difficulties in that connection on the part of the American Embassy. COLONEL JACKMAN suggested that the whole picture would be clarified if the Combined Chiefs of Staff would delegate the proper authority to the military attachés, and COLONEL WILLEMS assented to this view.

LIEUTENANT MUNDEN now referred to the agenda and suggested that an agreement be reached at this point to the most important matter under consideration. This could be most simply expressed as follows: SAC has been authorized, by FAN 672, to make the necessary arrangements with United States and British Embassies for transfer of responsibility for Allied Commission Archives and for transfer of necessary personnel and equipment to complete the microfilm project at the end of the military period. It now remains to secure authorization from the Combined Chiefs of Staff to transfer to the Embassies, at the end of the military period, all other undischarged responsibilities pertaining to records of a combined British-American character.

MAJOR TROUNSON then commented that the object of the proposal, then, would be to sell the Embassies something not previously contemplated, but COLONEL JACKMAN stated that on the contrary it was proposed to set up a completely self-sufficient organization that would relieve the Embassies of administrative and technical details. LIEUTENANT MUNDEN added that it might be said that the idea is not as new as it appears to be; that AFRA had always recognized the fact that the microfilming depot must complete all its commitments; and that the present discussion seemed to indicate that both the British and American Embassies have assumed that they might be called on to take over the whole program along lines now proposed. Few, if any, additional personnel would be required to handle all the work, as now proposed, and in any event the present technical equipment plus the equipment now being requisitioned, would be sufficient to see the whole project through. COLONEL JACKMAN confirmed this statement, and added that AFRA is now making an estimate of supplies and equipment and spare parts to run this program for its entire life.

COLONEL JACKMAN at this point asked whether the conference would endorse the proposal, to be submitted by SAC to Combined Chiefs of Staff, that all undischarged responsibilities of Allied Force Records Administration be transferred to the Embassies at the end of the military period. BRIGADIER CAHR (for Allied Commission), MAJOR CHAPMAN and CAPTAIN CANNINGS (for Allied Commission Archives), COLONEL WILLEMS and MR. GREENE (for the U.S. Embassy), MR. HANLEY (for the British Embassy), and MAJOR TROUNSON (for G-5, AFHQ) all agreed to this proposition, and indicated their approval of the organization proposed, to operate under the supervision of the military attachés of the two Embassies. (MR. HANLEY, toward the end of the proceedings, made it clear that the agreement of the British Embassy was subject to the approval of the proper authorities in London; and MR. GREENE, speaking for the United States Embassy, stated that the position of the United States Embassy was contingent upon the approval of the proper authorities in Washington.)

On the question of responsibility for the personnel and maintenance costs of the project, after the end of the military period, COLONEL JACKMAN stated that AFRA will draw up a detailed organisational and functional chart to lay before the Embassies at the earliest possible date. MR. HANKEY suggested that he would like to know all these details, but agreed with COLONEL JACKMAN that it will not be possible to appreciate the whole personnel picture until the responsibilities of AFRA (to include the microfilm depot) are considered at the same time and on the same basis as those of Allied Commission Archives.

COLONEL WILLEMS stated that he considered that the people in the programme at the end of the military period should be in a civilian status, and the conference seemed agreed on this point, except, as MAJOR RUSSELL stated, there should be a minimum number of military officers at the advisory level, because the records in question are military records and the commitments affecting these records are military commitments.

The conference agreed unanimously that the costs of the whole undertaking, once it passes to the control of the Embassies, should be borne by such departments of the United States and United Kingdom Governments as should be determined by those governments. All were agreed, however, that these departments should be the War Department and War Office, in view of the military character of the records.

CONCLUSIONS

As the results of the discussion, the conference agreed upon the following points:

1. At the end of the military period all undischarged responsibilities of Allied Force Records Administration should be transferred to the United States and British Embassies.

- a. These responsibilities should include, in addition to those pertaining to Allied Commission Archives, the reproduction and proper disposition of certain other combined records (including principally the still-active records of Allied Force Headquarters that cannot be released until the headquarters is inactivated).
- b. The respective military attaches of the British and American Embassies would assume responsibility for the completion of the entire program, with the reservation that major policies affecting the use and ultimate disposition of Allied Commission Archives would be formulated by the Embassies on a separate basis.
- c. The contemplated organization would be completely self-sufficient and would comprise the present microfilming unit and one archives unit, both of which would operate under the immediate control of an allied administrative and technical group responsible to the respective military attaches of the British and American Embassies. This group would take on present functions of Allied Force Records Administration and would be composed of administrative and technical persons thoroughly familiar with all aspects of this program.

2. The costs of the whole undertaking, after the end of the military period, should be borne by such departments of the United States and United Kingdom Governments as determined by those governments. As all of the records concerned have been created by military organizations, it should be recommended that these departments be the War Department and the War Office.

- a. Allied Commission and Allied Force Microfilming and Records Depot should submit to Allied Force Records Administration, through DR. WILSON (AFRA representative to ALCOM), at the earliest possible date, proposed organizational and functional charts.
- b. Allied Force Records Administration should prepare detailed plans of overall organization and cost analyses, as a basis for further discussions with the Embassies.

With reference to these agreements, action as follows was subsequently taken:

1. AFRA drafted signal for despatch to the Combined Chiefs of Staff, subject to the approval of SAC. This draft was approved by BRIGADIER CARR, COLONEL WILLEMS, MR. GREENE and MR. HANNEY. The final version incorporating changes desired by these individuals and by G-5, AFHQ, is attached hereto (Annex "A").

2. AFRA drafted signal (replying to AGWAR W 84414) for despatch to AGWAR, subject to approval of SAC. This draft was approved by BRIGADIER CARR, COLONEL WILLEMS, MR. GREENE, and MR. HANNEY. The final version incorporating changes desired by these individuals and by G-5, AFHQ, is attached hereto (Annex "B").

1. Subject is reproduction and disposition of combined British-American records.

FAN 672 authorized Supreme Allied Commander to make necessary arrangements with United States and British Embassies for transfer of responsibility for Allied Commission Archives and for transfer of necessary personnel and equipment to complete microfilm project at end of military period.

2. Allied Force Microfilming and Records Depot, operated by Allied Force Records Administration, has just begun the microfilming of Allied Commission records. This project alone will require over two years for completion with present equipment and does not take into account other Allied Force Records Administration commitments, which cannot be entirely discharged prior to the end of the military period.

3. It therefore appears desirable to transfer also to the British and American Embassies, at the end of the military period, all other undischarged responsibilities pertaining to the duplication of records of a combined British-American character and the appropriate disposition of such records per year directives in FAN 630. Included in these additional responsibilities would be the microfilming of certain active records of Allied Force Headquarters and subordinate allied commands that cannot be released for microfilming until those headquarters are inactivated.

4. United States and British Embassies in Rome, have agreed, subject to concurrence by proper authorities in Washington and London, to the undermentioned proposals to become effective upon dissolution of AFHQ and withdrawal of military forces in Italy.

a. The respective military attachés of the British and American Embassies would assume responsibility for the completion of the entire Allied Force Records Administration programs including the Allied Commission records, and would maintain direct contact with the Combined Chiefs of Staff in order to complete the programs, with the reservation that major policies affecting the use and ultimate disposition of Allied Commission Archives would be formulated by the Embassies on a separate basis.

b. The contemplated organization would be completely self-sufficient and would comprise the present microfilming unit and one archives unit, both of which would operate under the immediate control of an allied technical and administrative group responsible to the respective military attachés of the British and American Embassies. This group would take on present functions of Allied Force Records Administration and would be composed of technical and administrative persons thoroughly familiar with all the aspects of this program.

c. The cost of the whole undertaking would be borne by such departments of the United States and United Kingdom Governments as determined by those governments. As all these records were created by military organizations, recommend these departments be the War Department and War Office.

5. This Headquarters is now preparing detailed plans of organization and cost analyses as a basis for early discussion with the Embassies. In as much as no final decisions can be reached pending your approval of plans described herein, request your decision at earliest possible date.

Disposition of ALCOM Archives refer your W 04414 of 31 October in subject.

1. Present plans now tentatively approved by United States and British Embassies in Rome and submitted \_\_\_\_\_ November in \_\_\_\_\_ for approval of Combined Chiefs of Staff envision future organization to discharge, after the end of the military period, all remaining commitments of Allied Force Records Administration. These responsibilities would include, in addition to those pertaining to Allied Commission Archives, the reproduction and proper disposition of certain combined British-American records other than those of Allied Commission, including principally still active records of Allied Force Headquarters that can not be released until the Headquarters is inactivated. It is not believed that the personnel and equipment requirements would be appreciably increased to provide for the discharge of these additional responsibilities. The contemplated organization would be complete and self-sufficient and would operate under the supervision of the military attaché.

2. You are assured that substantially the same key United States personnel would continue to be employed on this project until its completion some three years hence, but plans now afoot will recommend change to civilian status of all except a few officers whom it is desired to retain in military status at top level provided that present War Department redeployment requirements could be waived.

3. The estimate of approximately three years to complete this project is based upon ~~quantity~~ of present microfilming equipment and considers the fact that over two years will be required to microfilm Allied Commission records alone.

4. In order to clarify administrative picture for your information herewith are presented essential details. Allied Force Records Administration formulates all procedures and directs all microfilming and records disposition work under policies established by Combined Chiefs of Staff. These functions include but are not confined to the Allied Commission project. Allied Force Microfilming and Records Depot reproduces combined records for the entire theater and houses and services and ultimately disposes of such records. These administrative provisions would not be affected by dissolution of ALCOM but would disappear at the end of the military period unless provisions are made for their continuation.

5. Should Combined Chiefs of Staff approve plans for transfer to the Embassies at the end of the military period of the undischarged Allied Force Records Administration responsibilities completely new organizational cost tables will be prepared in consultation with the Embassies. It is therefore requested that State Department be so informed with a view towards withholding final action until these plans are approved.

MEMORANDUM: TO MAJOR REYNOLDS.

SUBJECT : Screening of AIGCM Records and the Records of Subordinate Provinces and Regions.

1. Basic Assumptions.

- A) Documents are discarded because they lack permanent value for administrative, historical, or legal research.
- b) In as much as the microcopy in each instance must be a faithful reproduction of the file series, the discarded material must be destroyed when its useful reference period is ended.
- c) The effect of (a) and (b): documents not worth filming are not worth keeping.
- d) No document is discarded that sets a precedent, that establishes or defines a policy, that directs or outlines a procedure, or that possesses importance in so far as the mission, responsibility, organization, and functions of the agency are concerned.
- e) With the exception of classes of material that may be discarded, as enumerated in paragraphs 2 and 3 below, no document covering any transaction of AIGCM or of its subordinate agencies is discarded. "Transactions" in this sense may bear upon matters of: -

Legal affairs  
Mining  
Postal affairs  
Public Health  
Public Safety  
Public works and utilities  
Monuments and fine arts  
Agriculture  
Communications  
Economics  
Education  
Engineering  
Finance  
Labor  
Transportation

2. Material to be discarded.

- a) Duplicates found in the same folder (destroyed forthwith)

- b) Routine acknowledgments of receipt of communications.
- c) Mimeographed or otherwise processed (included printed) documents originating with higher headquarters, provided no notes are made thereon to change the character of the document from "non-record" to "record".
- d) Letters of transmittal.
- e) Carrier notes of routine or perfunctory character.
- f) Improperly classified material that, upon investigation, does not appear to be of sufficient value to reclassify.

3. "Typical" representation of material otherwise discarded.

Files consisting entirely of periodic reports in series (whether statistical or narrative), of routine special reports or memoranda all of which are uniform in appearance and content, and of completed forms maintained for bookkeeping or accounting purposes, are discarded provided that: -

- a) No damage results to the structure of the file series of which material so discarded is a part.
- b) The information contained in the material so discarded has been consolidated elsewhere in the files of the same agency, or exists in the form of more final and more usable papers or reports.

Files eliminated or discarded in this manner are represented by a typical selection, for purposes of the microcopy. The samples chosen for filming are introduced by the following remarks:

The attached \_\_\_\_\_ documents are presented as "TYPICAL" of the contents of this folder and sufficient for filming for historical research reasons. The balance of the documents from this folder are filed in the companion "discard" folder.

Specific examples of this technique:

- a) Property issue receipts, tally-ins and tally-outs, and other routine property records, when evidence exists elsewhere in the files of property clearance, or when other records reveal total property accountability.
- b) Certain documents in legal files concerning apprehension, trial, and disposition of all types of misdemeanor cases, if and when consolidated court records reflect all this information (exception being made of exceptional cases

requiring special judicial procedure, such as murder,  
rapes, and other major felonies).

Cost of Screening.

Archives stated that the cost of Screening was necessarily lower than that of Microfilm since the staff was considerably less and no machinery costs involved.

It was agreed that present set-up for Microfilm preparation should continue, AFRA agreeing to make periodical reports to OCS upon those items deemed unnecessary to film.

C) Review of Microfilm.

It was agreed Microfilms would be forwarded periodically by the Sections concerned to AG Dept. Washington and British Cabinet Office in accordance with instructions.

2. Transfer of Archives Staff to Embassies.

E.C. said this matter could now be discussed in some detail. Polad (A) stated that a suggested staff for Archives had already been put forward to the Ministries but that up to now no reply had been received.

Mr. Malcolm said that he would not press the case for moving this Section; Mr. Wesley Jones stated he could not consider the question until the R.F. files had been settled. Mr. Malcolm agreed.

5. RUK Files.

The Executive Commissioner said that RUK files were considered on the same level as the files at present being handled by the Joint Diplomatic Research Section. He suggested that they should be handled by that section with AC staff and all work in the same building. Lt. Col. MINUTES OF EXECUTIVE COMMISSIONER'S MEETING - 11 JUNE 1946.

1. Minutes of Last Meeting.

(a) - 1 (a). Food Situation. Col. Walton (Econ Sec) said there was little alteration. Although the situation was critical the indications were that there was no threat of famine. A very good crop, estimated to be in the region of six million tons, was expected. UNRRA were endeavouring to persuade the Italian Government not to make the mass retention greater than it was last year.

(b) - 1 (c). Coal Situation. Col. Walton reported no change from last week. 300,000 tons of coal were still expected for arrival in June. Should arrivals exceed the anticipated figure there would be an increase in allocation.

(c) - 1 (e). C.I.P. Col. Walton said the position regarding POL was unchanged. There was an armistice in the CIP strike, it having been agreed that negotiations would not take place until after 15 June.

(d) - 1 (f). Archives. Col. Walton had spoken to Major Harrison about non-acceptance of files and was satisfied there had been a misunderstanding. The matter was now in order. Ex C said he had arranged a meeting on Archives to-day.

(e) - 3. Allied Seramen. Brig. Carr (CA Sec) stated that a telegram had been sent to AFHQ suggesting that the clause protecting Allied merchant seamen should be omitted from the new armistice terms.

(f) - 4. Derequisitioning of Hotels. Ex C said a letter had been prepared for AFHQ which was based on a letter received from the Italian Hotels Union. The formation of a Central Organisation was suggested, consisting of Allied Officers and representatives of the Italian Government and Genio Militare. This organization would lay down the policy for requisitioning and deal with appeals against requisitioning of property. There was some discussion and Brig. Carr considered that it would be difficult for a Central Organization to control this matter and that hotels should be dealt with separately from other requisitioned property.

(g) - 5. Reinstatement of Insurance Company Officials. Ex C stressed the importance of getting this matter settled quickly and

(c) - 1 (e). C.I.F. Col. Walton said the position regarding FOL was unchanged. There was an armistice in the CIF strike, it having been agreed that negotiations would not take place until after 15 June.

(d) - 1 (f). Archives. Col. Walton had spoken to Major Harrison about non-acceptance of files and was satisfied there had been a misunderstanding. The matter was now in order. Ex C said he had arranged a meeting on Archives to-day.

(e) - 3. Allied Seaman. Brig. Carr (CA Sec) stated that a telegram had been sent to AFHQ suggesting that the clause protecting Allied merchant seamen should be omitted from the new armistice terms.

(f) - 4. Derogation of Hotels. Ex C said a letter had been prepared for AFHQ which was based on a letter received from the Italian Hotels Union. The formation of a Central Organization was suggested, consisting of Allied Officers and representatives of the Italian Government and Genio Militare. This organization would lay down the policy for requisitioning and deal with appeals against requisitioning of property. There was some discussion and Brig. Carr considered that it would be difficult for a Central Organization to control this matter and that hotels should be dealt with separately from other requisitioned property.

(g) - 5. Reinstatement of Insurance Company Officials. Ex C stressed the importance of getting this matter settled quickly and directed Col. Walton to take up at once with the Italian Government.

2. Exposition by Brig. Gen. Hamblen. Ex C announced that Brig. Gen. Hamblen was preparing an exposition on the work of G-5 on the occasion of the visit by Field Marshal Montgomery to AFHQ. He had asked VPs and Heads of Sections for a short memorandum and would like to have this by 15 June so that he could brief Brig. Gen. Hamblen.

3. Future of AC. Ex C stated that although there had been a full conference yesterday, the actual future of AC was still undecided. A staff-study on the subject was being prepared by AMQ.
4. Transport for Zone Sec Officers. Col. Walton said that two of his officers had to make many trips around HME and were having great difficulty in obtaining transport. Ex O (B) said these officers could have a car assigned to them on a daily basis provided the vehicle was needed for essential and official business. Ex C stated he would give a ruling later on this matter.
5. Responsibility for Displaced Persons. In answer to Col. Findley (Disper S/C) Ex C said that the future of displaced persons was covered by the Civil Affairs agreements. There was some discussion on this and the needs of the Civil Affairs agreements were examined. Ex C said that in fixing future responsibility, the financial commitments of the Italian Government must be taken into account. He would discuss further with Col. Findley.
6. Medical Personnel. Col. Findley reiterated the scarcity of Allied medical personnel in Disper camps. Ex C asked Brig. Carr if Col. Friselle could help.
7. Italian Air Lines. Ex O (A) raised the question of maintenance of Italian air lines when Liaison Groups had ceased to function. Ex C said that an extension to BOLZANO was necessary and Air Forces S/C must be warned that Liaison Group help would soon come to an end. It was necessary to keep the lines in operation for Disper S/C and the Italian Government. Ex C suggested that AC (DIE) should take over the responsibility and directed Ex O (A) to take action.
8. Reduction of Civilian Employees. Ex O (A) stated that a letter had been sent to Heads of Sections stressing the need for reduction in numbers. Replies had been received that staff now retained was essential.
9. Public Relations Officer. Ex C thanked Major Lebacoz, the retiring Public Relations Officer, for all the good work he had done, and welcomed his successor, Capt. de Massi. Ex C said the Weekly Bulletin was a most valuable publication and he wished it to continue so long as AC existed.
10. Muster - U.S. Personnel. Ex O (A) stated that a muster had been ordered of all U.S. Army personnel at 1600 hrs, Friday, 14 June.

1. Minutes of Last Meeting.

(a) - 1 (a). Food Situation. Col. Walton (Zoon Seo) said the harvest prospect was the one bright spot in a gloomy picture. Supplementary amassing had produced less than 50% of the Italian target figure. The new amassi decree had been published offering prices for next year's crop which would have the effect of farmers hoarding their remaining stocks to obtain the new prices. There had been an increase in the cost of certain essential items of living. Shipments of wheat from outside sources were less than was anticipated.

(b) - 1 (b). National Elections. Major Temple (Local Government S/C) reviewed the results received to-day. Returns had been received from 9,867 precincts out of a total of 35,236 and just over 5 1/2 million votes were accounted for, roughly one-quarter of the total votes cast. Of these votes, the Communist Party had obtained 1,227,859, the Socialist Party 1,364,742 and the Christian Democrat Party 2,054,338. (e) - 4. C.I.P. Col. Walton said stocks of POL were improving. There was a possibility of another C.I.P. strike but it had been agreed there would be no cessation of work until after 15 June. The Government had made a statement that in the event of a strike materializing essential services would be operated by CC.M.

(f) - 7. Archives. Col. Walton reported that work was being held up because archives branch were not ready to digest further information. Ex C directed him to take this up with Major

MINUTES OF EXECUTIVE COMMISSIONER'S MEETING - 28 MAY 1946.

1. Minutes of Last Meeting.

(a) - 1 (a). Food Situation. Ex C stated that Mr. Keeny and Mr. Lege of UNRRA had visited him and asked for the loan of 25,000 tons of flour from military stocks. Because they had been unable to persuade the Italian Government to reduce the bread ration, supplies would run out completely in certain regions between 31 May and 14 June. The massi and imports might tide them over for about eight days from the latter date, but distribution would present difficulties. AFHQ had been informed by signal.

Mr. Lege had approached the British Ambassador asking for assistance and had been promised that a recommendation would be made to LONDON.

Ex C said it would be interesting to see if political parties made capital out of the food situation and future events might disclose the truth or otherwise of reports that ITALY had hidden and unutilized food reserves. Ex C had sent a DC letter to AC Lia explaining the situation to date.

Col. Walton (Don Sec) stated that crop prospects were excellent and the Government had increased its estimates of the harvest. In terms of grain it was anticipated there would be a two million tons increase over last year's harvest.

The grasshopper blight was a handicap in SARDINIA. Steps to combat it were being taken.

(b) - 1 (c). National Elections. Ex C said the CC would like to have an AC representative in every province to give an overall picture. This was reported for Land Forces S/C and Liaison Officers in the R. ... did borrow from Areas. Officers were available at HQ.

(c) - 1 (e). Coal Situation. Col. Walton said there was no significant change. Deliveries of about 300,000 tons of coal were expected from various sources by the end of June.

(d) - 4. Conservation of Petrol. Ex C (B) stated he had discussed with Ex O (A) the question of instituting a "car-less" day and they were of the opinion that it would not be a great help. Tightening up on present regulations could achieve economy and at the present time there was no waste of

(c) - 1 (e). Coal Situation. Col. Walton said there was no significant change. Deliveries of about 300,000 tons of coal were expected from various sources by the end of June.

(d) - 4. Conservation of petrol. Ex C (B) stated he had discussed with Ex C (A) the question of instituting a "car-less" day and they were of the opinion that it would not be a great help. Tightening up of present regulations could achieve economy and at the present time there was no waste of transport. Col. Pidsley (Land Forces S/C) said a "car-less" day had proved essential to Land Forces S/C. Ex C would consider Ex C (B)'s recommendation.

(e) - 5. Refugee Centres. Col. Findley (Dispers S/C) stated that skeleton military organizations ... provided for the camps taken over, with the exception of AFHQs, where it was hoped to provide permanent housing. He stressed the shortage of Allied radical personnel, none being available for the corps. Ex C suggested that UNRRA could help in this matter and directed Dispers S/C to draft a signal to AFHQ.

2. Situation in MILAN. Ex C had received a report from AG CLO LOMBARDO, of a large Monarchist meeting in MILAN on 26 May, which passed off quietly. A report had been received of a plot by neo-fascists to make trouble by assassinating a British Military Policeman. The Military Commander had taken all necessary precautions.
3. Allied Seaman. Polad (A) said he was being pressed by the State Department for a decision on jurisdiction over Allied seamen. Ex C had written a DO letter to Brig. Low, RAAF, on Allied nationals not subject to military law, but was uncertain how this affected Allied seamen. His personal opinion, with which Polad (A) concurred, was that all Allied nationals not subject to military law should be subject to Italian jurisdiction. Ex C directed that a meeting be arranged with Polads on the return of Lt.Col. Harnsford.
4. C.I.P. Col. Walton stated that discussions had been taking place on the reorganization of C.I.P. AC had persuaded the Embassy's representative to acknowledge that this was an Embassy responsibility but AC was willing to help.
5. Italian Foreign Trade. Col. Walton said that the newly formed committee had held several meetings. As a result of discussions the Italian Government had disclosed the organization for foreign trade and the procedures adopted. An application to send a mission to sell fruit and vegetables in the American zone in GERMANY had been referred to the American Embassy.
6. Civilian Restaurants. Ex C stated that a General Routine Order had been published placing civilian restaurants out of bounds to All Marks. This would be repeated in the Daily Bulletin and the CC had ordered strict observance by all concerned.
7. Archives. Col. Walton said the appointment of a Records Officer was presenting difficulty. Ex C ruled that the appointment must be held by an officer who could, however, supervise the Chief Clerk in each Section.

NOTES ON CONFERENCE AT ANTILOLI - Sunday 24 Feb 46

Present : Brig. Lush  
Lt. Col. White  
Major Harrison

1. Lt. Col. White presented a copy of the draft he had prepared for Brig. Parsons giving the complete history of Phase "J" (Micro-filming) as it applied to Alox records. This was completely agreed by Brig. Lush.

2. Lt. Col. White also stated that he had received a telephoned agreement from Lt. Col. Jackson to set up a section of the Micro Unit in Rome.

3. The figures as presented to Brig. Lush on Saturday (Offs 12, 100s 6, ORs 10, CIVs 37) were considered by him to be too ambitious and referred back for reduction.

Major Harrison revised these to OFFs 10 - S.WOM 5 - ORs 5 - CIVs 27 by transferring the duties of Cardex Officer/NO to a later date in the operations.

4. Major Harrison suggested that reductions could be made by either reducing the amount of files to be screened - i.e. to only clean Regions but to clean and screen Headquarters files (this was not generally favoured) or on the other hand to include the O i/c and Admin Officer in the number of Screening officials.

After discussion it was finally ordered by Brig. Lush that :

a) Major Harrison should telephone to-morrow Morley, if possible, the "all-around" figure required for Archive micro-filming preparation to Lt. Col. White and should attend on Tuesday 26th at his home-outfit meeting and inform Polods (A) and (B) upon the whole matter, in order to obtain their concurrence.

b) That he should review the total staff, not as a chain, but in the light of getting everything up to "micro-film level", so that the NO Unit would have no complaint that Alox were not ready to begin as soon as they had installed the Rome Unit.

c) That every effort should be made to prepare matter for filing, and the Cardex should be done at a much later date.

d) That both he and Lt. Col. White were of the opinion that not more than a total of THIRTY (15 Civilian Italians) would be permitted and that we must work out our operations accordingly.

e) That micro-filming should not be expected to take more than 8-10 months to complete (without Party Control) from the date agreed

2. Lt. Col. White also stated that he had received a telephoned agreement from Lt. Col. Jackman to set up a section of the Micro Unit in Rome.

3. The figures as presented to Brig. Lush on Saturday (Offrs 12, ORAs 10, CIVs 57) were considered by him to be too ambitious and referred back for reduction.

Major Harrison revised these to OFFs 10 - 3, ORAs 5 - ORAs 5 - CIVs 27 by transferring the duties of Cardex Officers/NOO to a later date in the operations.

4. Major Harrison suggested that reductions could be made by either reducing the amount of files to be screened - i.e. to only clean Regions but to clean and screen Headquarters files (this was not generally favoured) or on the other hand to include the O i/o and Admin Officer in the number of Screening officials.

After discussion it was finally ordered by Brig. Lush that:

a) Major Harrison should telephone tomorrow Monday, if possible, the "all-round" figure required for Archive micro-filming preparation to Lt. Col. White and should attend on Tuesday 26th at his Executive Meeting and inform Poles (A) and (B) upon the whole matter, in order to obtain their concurrence.

b) That he should review the total staff, not as a chain, but in the light of getting everything up to "micro-film level", so that the MP Unit would have no complaint that Alcom were not ready to begin as soon as they had installed the Rome Unit.

c) That every effort should be made to prepare matter for filming, and the Cardex should be done at a much later date.

d) That both he and Lt. Col. White were of the opinion that not more than a total of THIRTY (15 Civilian Italians) would be permitted and that we must work out our operations accordingly.

e) That micro-filming should not be expected to take more than 0-10 months to complete (without Pr party Central) from the date agreed by the COG. (Based upon MP Unit only doing 12,000 per day, it will take 540 days to do six million).

f) He asked Lt. Col. White to ask in his cable for approval of Archives to continue to function after the Peace Treaty as well as the closure of Alcom. Simultaneously for the Embassy to support the cable by sending copies to their Governments at the same time.

g) Also to add permission for suitable premises in Rome for Archives should present offices be vacated.

h) In both their opinions, the total staff should not exceed 50, half of which to be Italian Civilians.

5. It was also noted that should American Officers available for the new Establishment not be sufficient, steps should be taken to approach AFHQ for permission to retain British Officers to carry out the work of micro-film preparations and recording.

6. It should be recorded that there was a possibility of R U X files being placed in the custody of HQ Alcom. If these are able to be micro-filmed first, it would permit Alcom more time to bring their files up to KF level.

In his explanations concerning the a/n Section, Major Squair mentioned that a change of premises would disrupt the work of the Foreign Office Italian Archives Section (of which he was CC.), which latter Section had for many months worked alone, and was still so working on the selection etc. of documents and papers held in the name of the Joint Section. Part of FOIAS staff was engaged in examining the very large quantity of files of the former Ministry of Popular Culture that were arranged in certain order in multi-partitioned large wall cabinets.

He further explained that the Italian Undersecretariat of the Press etc., (formerly Ministry of Popular Culture), to which belong a large proportion of documents and other material of interest both to the Joint Diplomatic and Foreign Office Sections, is domiciled in the same building as that of these Sections; that part of such documents and material was gradually being returned to the Undersecretariat and that the balance would remain on the same premises when the Sections' activities had ceased.
