SUBJECT: Disposition of ALCOM Archives.

Memo to: Lt. Col. White, G-5 Policy and Control.

From : Majors Harrison and Maxfield, Alcom Archives.

1. The following general comments and suggestions regarding disposition of ALCOM Archives are offered per your request.
2. It is not believed necessary to summarize and restate the entire case up to this date as all concerned are, I am sure, fully cognizant of the facts.
3. Briefly it seems negotiations have reached this stage:-
 - a. All concerned seemed to be in general agreement that the records should remain in Rome, primarily for use by the Italian Government but subject to certain security and other restrictions. However, it does not appear that the Italian Government has gone on record formally requesting that this be done.
 - b. It was unanimously agreed last November that the records should remain, under nominal control of the Embassies with responsibility rested in the U.S. - U.K. Military Attachés. The main reason for this seemed obvious - the files were of Military origin and should be looked after by someone of military status.
 - c. Evidently the belief still exists that the files should remain for the purpose stated (primary use by the Italian Government). However it appears a stalemate has now been reached regarding provision of funds for salaries and other expenses necessary to maintain the organization. No agency has yet been found which will assume financial responsibility for the project. It is understood that negotiations are now being concluded by the British Military Attaché with

3. Briefly it seems negotiations have reached this stage:-

a. All concerned seemed to be in general agreement that the records should remain in Rome, primarily for use by the Italian Government but subject to certain security and other restrictions. However, it does not appear that the Italian Government has gone on record^a formally requesting that this be done.

b. It was unanimously agreed last November that the records should remain, under nominal control of the Embassies with responsibility rested in the U.S. - U.K. Military Attachés. The main reason for this seemed obvious - the files were of Military origin and should be looked after by someone of military status.

c. Evidently the belief still exists that the files should remain for the purpose stated (primary use by the Italian Government). However it appear a statement has now been reached regarding provision of funds for salaries and other expenses necessary to maintain the organization. No agency has yet been found which will assume financial responsibility for the project. It is understood that negotiations are now being concluded by the British Military Attaché with his American Counterpart to attempt to secure funds, from War Office and War Department sources inasmuch as the Foreign Office has stated they cannot provide funds for this purpose.

4. I believe the following conclusions can be reached:-

a. The records should stay, subject to formal request for them by the Italian Government, and possibly the Embassies if they now have need for them.

b. No one seems anxious to bear the expense incidental to their retention.

./.

e. We (the Military) should take the lead in finding a financial sponsor, not the Embassies of their Military Attachés. I believe it is our responsibility to conduct these negotiations, find the solution and present it to C C S. Separate negotiations between Embassies, Military Attachés, Foreign Offices etc. and excluding C C S, would seem to me to ^{impose} impede the issue and delay the final solution.

5. My recommendations are:-

a. To formally query the Italian Government to ascertain whether or not they desire that the records be kept here for their use. State the annual itemized and cost and number and category of staff and inform them that if their reply is in the affirmative they must bear the cost.

b. Same as in a above for the Embassies.

c. If replies to a and b are both affirmative the cost be pro-rated.

d. If they all accept financial responsibility so notify the C.C.S.

e. If they do not accept financial responsibility so notify the C.C.S. and recommend the funds be provided from sources available to them but if this is not possible or desirable that decision be given as to disposal of the records.

MEMORANDUM TO: Executive Commissioner,
Allied Commission.

SUBJECT: Housing for Allied Commission Archives.

We refer to a letter dated December 26, 1946 to the Presidency of the Council of Ministers from the Intendenza di Finanza, regarding efforts of the latter to negotiate a lease for the premises of the German Archeological Institute. Copy of this letter was provided by Major Harrison on January 3, 1947.

According to our respective files, it was never intended that the Italian Government should pay rent for premises in which Allied Commission archives are to be housed. We feel that such accommodation of British and American property could lead to most undesirable consequences. We also believe that Admiral Stone's letter to Prime Minister De Gasperi, dated July 6, 1946, requesting "that steps be taken to procure a lease for say 10 years, in return for the access to and the free provision of expert staff for protecting and cataloguing these documents" apparently conveyed an impression which should be corrected. POLAD A's files show that a copy of this letter was not received by him until January 6, 1947.

We are constrained to request that the Italian Government be immediately informed that there appears to have been a misunderstanding in the matter of providing long-term housing for the archives of the Allied Commission; that it was not intended that the Italian Government should pay rent for the premises, but should only assist in assuring the availability of housing; that the United States and British Embassies are now giving further consideration to the matter, but without prejudice to the possible use of the German Archeological Institute under

other arrangements; and that meanwhile the Embassies would be grateful to receive urgently precise information on the juridical status of the building, particularly whether the building and/or its furnishings and fixtures have been sequestered by the Italian Government.

We understand that the International Union of Institutes of Archeology, History, and History of Art in Rome has, through its Secretary, been making arrangements with the Italian Ministry of Public Instruction for dismantling and removing the bookshelves now in the Institute, so that they may be used for the library of that Institute, at the Palazzo Vidoni. We understand that the Union expects to pay to the Italian Government as sequesteror a nominal rent for the bookcases. We also understand that the Ministry of Public Instruction has undertaken to defray all expenses involved in moving the bookshelves and in any future re-installation of them in the German Institute.

It has been informally suggested that, subject to agreement of the Italian Government, the archives of the Allied Commission be housed in the Palazzo Vidoni, and the libraries in custody of the Union could be housed in the German Institute. This exchange would obviate the necessities both of removing bookshelves from the German Institute and of involving the archives in the problem of German external assets. We understand that the Italian Government owns the Palazzo Vidoni and is planning to make it available without charge to the International Union. So that our governments may consider the feasibility of using this alternative accommodation, we suggest that your experts informally investigate the premises with a view to determining their suitability as a depository for the A. C. archives.

After reading the Memorandum signed by the Political Advisers of the two Embassies dated 27 Jan. concerning the Housing for Allied Commission Archives, the Executive Commissioner asked if copies of the letter to the Ministry from the Chief Commissioner (on July 6th, 1946) were sent to the respective Embassies. Major Harrison said that according to his information copies were not sent, it apparently being understood that this letter was in conformity with the Minute 4 of the meeting of 11 April. It was regretted that this had not been done, since a misunderstanding had thus occurred.
2. The Executive Commissioner asked whether the two Governments had agreed to pay for the Vidoni premises. It was pointed out that the Embassies were giving this careful attention. Mr. Greene added that his Government had, in late 1945, indicated general approval of a proposal that the Embassies pay rent jointly. As soon as the question had been agreed locally, he will seek confirmation from his Government. Mr. Mackay stated that he had not been informed that his Government would pay rent but since it was obviously desirable that the Italian should not be asked to pay rent, if they were not to be allowed free access to the Archives, the Embassy would, if necessary, recommend to London that rent be paid. 4. Major Harrison brought up the question of security. Executive Commissioner stated that this would be the responsibility of the Archives and also suggested that this be investigated at the same time as the general utility of this accommodation.

5. After the receipt of the report upon the building, Executive Commissioner said that a letter should immediately be sent to the Italian Government informing them of the misunderstanding in the matter of leasing a property for the Archives and, if the report was favourable, requesting the availability of premises at the Palazzo Vidoni.

Subject: Future Accommodation Archives.

To : Executive Commissioner.

In a telephone conversation this morning, Mr. Greene stated that he was in close touch with Mr. Hankey and was sending a memorandum to him upon the matter.

In order to explain how the Italian Government had been asked to rent a building in consideration for access to the Archives, Mr. Greene's attention was drawn by me to the Minutes of 14 April 1945. (Copy herewith).

In this (par. 4) it was requested by the then FOIAD (A) Mr. Wesley Jones that the Italian Government should be approached through AICOM to lease a property, and after some calls under par. 2 of the above Minutes, a letter was sent to the Prime Minister by the Chief Commissioner (through Executive Commissioner) on July 5th, 1945. Copies of this letter were not sent to FOIADs (A/B) which should have been done.

2. It was pointed out by Mr. Greene that in a further report to FOIAD (A/B) I had stated that the building was requested by the Italian Government.

I explained that Father Dahlgren had informed me this was so and it was discovered that the furniture only was requested and that the building was owned by the Evangelic Commission of Berlin (represented by Dr. Dahlgren), in September last.

3. Mr. Greene continued, in reference to (1) that despite the statement in par. (1) of Minutes, Mr. Wesley Jones never entertained any idea that the Italian Government should be asked to pay rent. That, in a subsequent letter from Brig. Lush, it was agreed that the Italian Government be approached to "acquire" a building and that by this was meant that a building should be made available through but not rented by them.

I explained that Earter Dahlgren had informed me this was so and it was discovered that the furniture only was requested and that the building was owned by the Evangelic Commission of Berlin (represented by Dr. Dahlgren), in September last.

3. Mr. Greene continued, in reference to (1) that despite the statement in par. (4) of Minutes, Mr. Wesley Jones never entertained any idea that the Italian Government should be asked to pay rent.

That, in a subsequent letter from Brig. Lush, it was agreed that the Italian Government be approached to "acquire" a building and that by this was meant that a building should be made available through but not rented by them.

4. No such letter appears in Archives file. That a misunderstanding could have occurred through the use of this expression is clear, although no comment or objection to the action taken in this matter has ever been made to me by either Polad (A/B) before your talk with me yesterday.

5. The matter is now in the hand of Polad (A/B).

Le richieste della Commissione Ecclesiastica Evangelica dipendevano dalle pretese del pagamento di un canone in valuta americana (dollari) e del conseguente rapporto all'attuale valore di cambio della lira italiana.

Inoltre la locazione non verrebbe assantita che per la durata di due anni e ciò, come è stato chiarmente esposto dal rappresentante legale dell'ente proprietario, nell'eventualità di un ulteriore rinvilimento della lira.

Non è stata neppure accolta la proposta di stabilire una durata di nove anni con la clausola della revisionabilità annuale del canone in relazione alle disposizioni che regolano e disciplinano le locazioni, e ciò all'grado che è stato fatto presente come il criterio proposto fosse il più equo e come la maggiore durata richiesta era indispensabile a tutela la destinazione che si voleva dare all'immobile.

Sono state richieste anche alcune clausole che si volevano inserire in contratto, e tre queste:

1°) L'obbligo dell'amministrazione italiana di rispettare il custode dello stabile sig. Apollonio Marcucci, e precisamente che lo si lasci nel godimento gratuito dell'alloggio occupato nello stabile stesso, salva la regolazione a parte con la Commissione Alleata (e ciò per impegno preso dal Maggiore Harrison), del rapporto d'impiego del Marcucci quale portiere.

2°) L'atto dovrà essere sottoposto all'approvazione del Consiglio Scussorio in Berlino della Commissione Ecclesiastica Evangelica.

The negotiations carried on between the "Intendenza di Finanza" - in behalf of the Presidency of the Council - and the "Commissione Ecclesiastica Evangelica di Berlino" represented by Pastor Brich Dahgruen and assisted by Avvocato Fiola Caselli - attorney - Office at N° 3, Via Regina Elena, have reached a deadlock on account of the unreasonable demands of the said "Commissione", represented by his lawyer.

The "Ufficio Tecnico Erariale di Roma la" (Technical Office of the Exchequer) estimated a monthly rent of lire 45,000 which is considered a very liberal figure; the abovementioned "Commissione" claims a monthly rent of lire 80,000, however, without any attempt to cut down and reduce it.

To think, Sir, that the yearly rent paid by the German Archeological Institute for the whole building was only 18,000 german Marks !

The high rent claimed by the "Commissione Ecclesiastica Evangelica" is based upon the fact that they estimate the payment of the rent in dollars and a consequent change of dollars into lire at the present rate of exchange.

Besides, they would only agree to a contract of rent for two years, in view of a possible further devaluation of the lira, as clearly stated by the legal representative of the "Commissione" himself.

We even proposed to arrange a 9 years term in the contract with a clause aiming at a yearly revision of the rent. We also notified them that the proposed arrangement of ours seemed to be most just, and that the 9 years term in the contract asked by us was strictly necessary considering the purposes for which we were going to use the building. But all our just reasons and proposals were not accepted.

They also asked us to insert some clauses in the contract, such as:

1st - The Italian Administration should ~~be~~ include provision for the door-keeper, a certain Signor Apollonio Marcucci; this means that the said door-keeper shall have the right to continue to use, without rent, his billet inside the building in question; on the contrary, following an obligation assumed by Major Harrison, the employment of Signor Marcucci as a door-keeper should be arranged separately by the Allied Commission.

2nd - The contract should be passed for approval by the "Consiglio Ecumenico in Berlin of the Commissione Ecclesiastica Evangelica".

3rd - The obligation by the Presidency of the Council to assume responsibility for any possible risk or damage which might occur to the building through the use to which it will be destined.

No persuasion was successful in bringing the said "Commissione" to a good and reasonable basis of agreement; on account of their avaricious demands, we think that it is not advisable at all to make any contracts of rent with the same "Commissione".

We suggest, on the contrary, that the local Prefettura shall take steps for the issue of the decree to sequester the building in question, described in the Survey of the Comune of Rome buildings in Region III, "Mappale 851", "Partita 35588", the property of the said "Commissione" (see also Circular N° 426555 dated 25/10/46 by Ministry of Treasury). Under the conditions of Paragraph N° 3 of Article 295 of the Wartime Law the building can be sequestered because it is not used for Catholic or other religious ~~use~~ ^{purpose} recognised by the Italian Government.

In a short time we will send you the Report of Searches by the "Ufficio Tecnico Erariale" (Technical Office of the Exchequer) regarding the yearly amount of rent.

At CONFERENCE WITH Dr URSO (Instead Pisan)

Dr Urso stated that with reference to the negotiations between his office and the German Lutheran Church, a deadlock was still existing over the price.

The Italians have offered 60,000 Lire per month for a lease of ten years.

The German Church require 80,000 lire per month but ONLY for TWO years, as they are uncertain of the value of the lire after that period !!

A letter was in preparation to be sent to the CONSIGLIO, asking what steps should now be taken and suggesting that the building should be sequestrated, since it is property which is NOT being used for Church purposes, and permission to occupy by Archives be given at once.

He also confirmed that the furniture and shelving in the building was at present sequestrated and that until negotiations were satisfactorily concluded, it should remain so.

At a CONFERENCE WITH Dr URSO (Intend Finan)

Dr Urso stated that with reference to the negotiations between his office and the German Lutheran Church, a deadlock was still existing over the price.

The Italians have offered 60,000 lire per month for a lease of ten years.

The German Church require 80,000 lire per month but ONLY for TWO years, as they are uncertain of the value of the lire after that period !!

A letter was in preparation to be sent to the CONSILIO, asking what steps should now be taken and suggesting that the building should be sequestrated, since it is property which is NOT being used for Church purposes, and permission to occupy by Archives be given at once.

He also confirmed that the furniture and shelving in the building was at present sequestrated and that until negotiations were satisfactorily concluded, it should remain so.

Major HARRISSON:

Here is the story of the Library at Via Sardegna to date.

Captain Cunnings and myself visited the library with Avv. SCUNCIO a day or two after you went away. We visited all the floors and apartments. We assumed you desired the entire building. The Swiss school could remain where it is on the 2nd floor (Captain Cunnings thought you would agree). The UNRRA apartment on the ground floor presents a problem IF you want this apartment as the man there has an agreement for the term of UNRRA here. We found that security can be maintained between the offices, library, and apartment sections of the building.

We then went to see Dott. URSO, the Intendente of Finanza, and they did not yet have the letter from the President of the Concilio authorizing them to draw up a contract. Meanwhile we were confused by the issue of SCUNCIO (who I believe has had a financial interest in rental etc), the German library, and the Pastor. It was difficult for me to determine WHO had the authority to make a contract. SCUNCIO hid the fact that he had ONLY the German Institute's interest at heart. Captain Cunnings and myself could not talk with the Pastor.

We decided to ask for legal counsel here at AC to protect our legal interests when we had further talks with SCUNCIO, the Pastor, Avv Caselli (Avv for the Pastor), Dottore URSO, etc. I asked Col WEBER to give us his best legal adviser. He did, we have been happy to have the advice and close cooperation of the Avvocato FIORE who has labored quite determinedly for us. At last we have found out that the LIBRARY WAS NEVER SEQUESTERED!!! ONLY THE FURNITURE BELONGING TO THE GERMAN LIBRARY WAS. The Pastor, on our next visit, (after a polite note to Capt CANNINGS), decided he DESIRED to contract the place with us a beneficiary. He gave us an agreement in writing to this effect. It is in your file. Since then we have waited the pleasure of the Avv Caselli, who being an able Iti has delayed the whole thing a week now.

Today I have determined, by several phone calls, that the situation is finally clear and that these facts are the only ones yet to be whipped.

1. The Pastor wants a contract (with Iti Govt) for THREE (NOT EIGHT) years, at Lit. 80,000 per month (a reasonable figure). Objection to 8 years being it is too long for that price.

2. Furniture not to be moved. Especially scaffolding.

The representative of the Intendenza di Finanza was unable to trace the correspondence from the Council of Ministers on the matter. We, therefore, arranged for him to see copies of the correspondence and, after lengthy discussion, it appears that the necessary lease or contract for the transfer of the premises can be effected immediately between the Pastor of the Church and the Italian Government.

A further meeting has been arranged for 10.00 hours on Monday October 21st, and I think it would be advisable if one of the Italian Legal experts (two or three of whom Major Chapman states are employed in the Legal Branch) could be permitted to accompany us.



Second Floor - Flat Premises - Entry





- (A) No.28 Vis Gregoriana (German Bibliothek.)
This building is still occupied by the Int;Red Cross Organisation under a Conte de Cassilis. He is away until Monday. Further details have already been obtained. It is understood that this accomodation is however "frozen".
- (b) German Archeological Institute, Vis Sardegna 79.

This is a better proposition; Owners. The Lutheran Church (adjoining) whose Council have leased it to the above Society. No rent has been received for three years. The building is empty but is sequestrated by the Italian Government. Seven rooms at rear have been taken over by UNRRA as an office. The main rooms in the front are self-contained and well equipped with furniture, wooden racks tables etc. all belonging to the Society. They are large, well lit with barred windows and stone floors. Very suitable for Archive Storage and research. There are also two rooms in the basement especially adapted for photography, at present under UNRRA charge but complete with equipment. 1. The "German Bibliothek" in Via Gregoriana is in the Palazzo Zuccari, which housed the Biblioteca Hertziana. This library was returned to Rome recently under custody of the International Union of Academics of Rome, with the consent and approval of the Allied Commission and the Italian Government.

2. The "German Archaeological College", Via Sardegna, occupied premises belonging to the adjacent Evangelical Lutheran Church, of which Dr. Eric SJOGQUIST, Director of the Swedish Academy, and Secretary of the International Union, is the responsible officer. These premises housed the library of the German Archaeological Institute, also recently returned to Rome under the same conditions as for No. 1.

3. At its last meeting on March 16th the International Union voted (a) to return the Hertziana library, as soon as the Palazzo Zuccari was derequisitioned, to its previous state in this Palazzo, with which it has always formed a property unit; and (b) to return the boxes containing the books of the German Archaeological Institute to its former premises in Via Sardegna, but without unpacking the books.

4. Since these dispositions have been taken by the International Union of Academics in pursuance of the responsibility of custody of the libraries above mentioned, conferred upon the Union not only by the Italian Government but also by AC, it would seem to be a reversal of decision for AC to make other disposal of the storage places on which the Union depends for fulfillment of its responsibility of proper custody of the libraries. I say "proper custody", because the boxes cannot remain exposed to leakage as they are at present in their present temporary location in the Galleria di Arte Moderna, and we have as yet found no other place to store them except in their former homes.

At a Meeting with Polads (A) and (B) this morning, the question of Archives accomodation was further discussed.

- (a) Mr Wesley Jones stated he had received information which he was communicating to Mr MALCOLM in which it was suggested that, for some time at least, Alcom Archives should remain in the present building after the Commission closed down. That the Italian Document Branch and the R U K files should also find accomodation here - both Embassies taking charge of their respective portions.
- (b) Since Microfilm Section would enter into this also, a firm proposition of the space required for Archives and Microfilm should be prepared for your approval.
- (c) Microfilm Officers (Major Reynolds/Capt Johnson (A)- will probably be again in Rome towards the end of the week and after discussion with them as to the most convenient disposition of their plant in the building, the proposition at (b) can be placed before you.

To . POLAD (A) and (B)

1. Further to Notes on Meeting of 11 April, the following information is to hand.

- (A) No.28 Via Gregoriana (German Bibliothek.)
This building is still occupied by the Int;Red Cross Organisation under a Conte de Cassilis. He is away until Monday. Further details have already been obtained. It is understood that this accomodation is however "frozen".
- (b) German Archeological Institute, Via Sardegna 79.

This is a better proposition; Owners. The Lutheran Church (adjoining) whose Council have leased it to the above Society. No rent has been received for three years. The building is empty but is sequestrated by the Italian Government. Seven rooms at rear have been taken over by UNRRA as an office.

The main rooms in the front are self-contained and well equipped with furniture, wooden racks tables etc. all belonging to the Society. They are large, well lit with barred windows and stone floors. Very suitable for Archive Storage and research. There are also two rooms in the basement especially adapted for photography, at present under UNRRA charge but complete with equipment. This has not been viewed by me at present, but can be seen on request. Keys can be obtained from the PASTOR who was most obliging. There are living quarters attached and a porter who is on the Society's pay roll.

SUBJECT:- Archives Accomodation.

At a Meeting between Mr Wesley Jones (POLAD A.) and Major N.M. Harrison Archives Branch, the following matters were discussed:

1. Major Harrison briefly outlined the wishes of the Acting Chief Commissioner (Brigdr LUSH) that he should get in touch with the American and British POLAD with a view to discussing the future housing of Archives as and when the present premises are vacated.

2. It was requested by Mr Wesley Jones that discreet enquiries be made as to the present use of the German Archeological College, This apparently is under the control of UHERRA for housing Displaced Persons in transit and may be still required as such.

3. Major Harrison was also asked to obtain the following :-
(a) a near estimate of the cubic capacity of the area required for Archive storage, together with other notes on accomodation
(b) names and addressee of any property which has been already suggested for Archive housing .
