To: Archives Branch, Allied Commission, APO 394.

1. Attached hereto is the Inventory of Files of this Agency to 26 October 1945.

2. In reference to Executive Memorandum No. 7 dated 5 January 1946 attention is directed to the following:

- (1) This organization, up to 26 October 1945, was a sub-section of Finance Sub-Commission. After 26 October 1945 it became a Branch of G-5, AFHQ. However, at no time were the functions or responsibilities of this organization affected by this transfer which was made imperative for reasons of T/O and W/E. It was merely the solution to the problem of maintaining personnel to carry on the accounting work for Allied Commission activities which were not, and could not, be completed before Allied Commission was scheduled to cease activities.
- (2) Compliance with Executive Memorandum No. 7 would necessitate cutting off the Agency files at 26 October 1945 during which period they were records of Finance Sub-Commission. These files would present no history whatsoever inasmuch as the mission of this organization was in no sense fulfilled. The entire record would mean nothing because it would show no results, no conclusion.
- (3) Compliance with Executive Memorandum No. 7 would require that files subsequent to 26 October 1945 be sent to AFHQ. These files at AFHQ would be worthless as they would show only the conclusion to a quantity of records which would not exist in AFHQ archives.

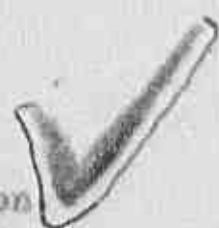
