1. With effect from 31 July 46, all files of this office were closed and a new list of files compiled, as per attached list, to take effect from 1st August 46.

2. To avoid confusion, the functional headings were kept as near as possible to the headings previously used, but it is pointed out that many files held by this office were under separate titles, when they might have been amalgamated under one functional heading, thereby making a continuance of the old files unpractical. In fact so many files were being maintained in this office, that correspondence, which might normally have been in one file, was spread through several different files, all of which were in some way connected with the principle subject.
