1. Owing to lack of proper security in the Press Relations Branch for files and the fact that there is no need to retain such files in the PRB the following action is being taken after conversations between the Executive Commissioner, Lt.Col.Hind-Smith, and the Public Safety Sub-Commission Security Officer and the Acting Press Relations Officer.

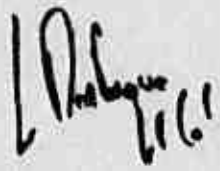
