From examination of various files in Archive Group # 8/V 5, and also in this Archive Group, it appears that the Local Resources Section at one time maintained a file series bearing a numerical sequence LRS/1 upwards. Apparently, at a later date this file series was scattered amongst several offices who merged them into their own file series, or added new files thereby initiating entire fresh series of files. Through this happening, the original file series of the Local Resources Section cannot be reconstructed, and Archives Branch has decided that the best thing to do is maintain the files in the order in which they were received.

When AMU 5 Army first operated, the different branches were allocated blocks of numbers to be used on their file series; these numbers were allocated as follows:-

202 "	Economics and Supply
203 "	Public Safety

214 "	Information. Later they added 210 - 225
1100	Finance

At that time there was also a Public Relations Officer, and a Property Control Section, but owing to shortage of staff and the exigencies of the situation, it was found impossible to maintain these two sections and they were absorbed as follows:-

Public Relations Officer - into Information Section
Property Control - into Finance Section.

Just before the last campaign in Italy it was decided that a section of AMU 5 Army should be up with the forward troops so that the Commander would have Civil Affairs personnel on the spot. This Section was activated and known as G-5 Section. G-5 Section opened its own series of files bearing a numerical sequence from 200 and suffixed with the letter 'y'. Much of the correspondence for the G-5 Section will be found in the Main Files of AMU 5 Army. This as most matters were forwarded to them for information or action before being filed.

Archives Branch has arranged the files in "Functional Order" and ignored the numerical sequence.

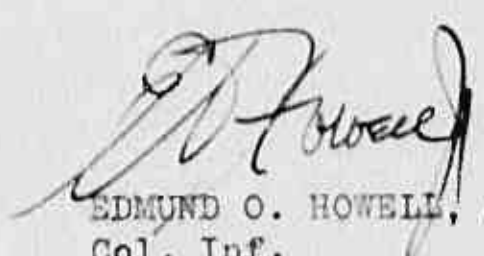

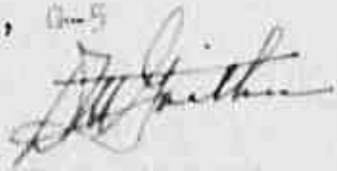
