Report of visit of Capt. TOOMER to Merano *18* to,

The returned cases were duly handed over to ARAR at Merano, a receipt on an official form being obtained for them. ARAR stated that they would probably be opened later and the contents sold if found to be saleable.

No trace of file 117, missing from the Finance archives of Belluno, was found when the office of the Intendente di Finanza at Belluno was visited. Their records showed that this file had arrived there and had later been sent to AMG Liaison Office, 86 Area. A copy of their letter and accompanying list was seen, but no receipt from the AMG office. They stated that they, Intendente di Finanza, had not examined, nor had had need to examine these files, and that the bundle had been sent on as received. AMG, 86 Area also said that they had forwarded the parcel to this HQ unopened. It was suggested to Belluno that perhaps the Bank concerned had taken possession of this file. They replied that nobody had taken any files from them, or in fact asked about them.

There seems little hope of finding this file as it appears to have passed without checking through several hands, and that while at least one receipt had been given for it, this was the result of accepting an accompanying list at face value. The files from Padua have not yet arrived at AMG, 86 Area, a hastener was dispatched that day.

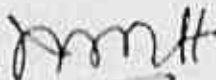
