ATTENTION IS CALLED TO REGION ONE ROAD OFFICIAL ORDER NUMBER 17 OF 10 JANUARY PERMITTING POLITICAL ACTIVITIES. IT OMTS CHIEF'S RESTRICTION IN COS DIRECTIVE, NAMELY PHRASE "WITHIN YOUR DISCRETION", WHICH REFERS TO CINC AND SHOULD HAVE BEEN INCLUDED IN THE ORDER AS "WITHIN THE DISCRETION OF ALLIED MILITARY AUTHORITIES". IT GIVES SICILIANS IMPRESSION CONTROL OF ALL POLITICAL ACTIVITIES WHICH DO NOT LEAD TO PUBLIC DISORDER HAS BEEN REMOVED AND THAT SUCH CONTROL OF PRESS AS HAS BEEN VESTED IN ALLIED PUBLICATION BOARD IS NO LONGER EFFECTIVE.

IT IS FELT HERE THAT IT WOULD BE PSYCHOLOGICALLY AND POLITICALLY INADVISABLE TO AMEND THE ORDER FORMALLY. BUT SUGGEST IT SHOULD BE MADE CLEAR TO THE SICILIANS IN INDIVIDUAL CASES THAT DISCRETIONARY CONTROL IS RETAINED AND THAT PUBLICATIONS REMAIN UNDER THE SAME LICENSING REGULATIONS.

SUBJECT:- Pay of Italian Provincial Officers of Health.

TO :- Acting Director of Economics
(Through Staff Officer to Administrative Director.)

I visited Trapani on November 6th and found what I consider is a very unsatisfactory position as far as the local medical services are concerned. Apparently the Italian Provincial Medical Officer of Health who is working on a whole time basis is receiving 1750 lire a month while Communal Medical Officers working on a part time basis are receiving 500 lire a month.

By November 15th all the duties of the Regional Medical Officers will have been transferred to the local doctors and I consider that if they are so inadequately paid they will devote more time to private practice than is desirable and in consequence the work for which they were originally appointed must suffer.

I fully realize the undesirability of raising wages in general, but I cannot help but feel that the medical men referred to are to some extent outside the general policy.

I am given to understand from those who have experience with these doctors that they are as a rule very well qualified and efficient and are only too anxious to work if given a living wage.

I should be glad of your views on this matter.
