T/5 DEFINO is familiar with the work of the Subcommission and, despite assignment to Co G, has been living with the Hq Co since I have been doubling in brass, waiting for the transfer of ANG API to Caserta and have actually been holding down the Office of the Subcommission.
3. It is therefore requested that T/5 DEFINO, if it be impossible for him to continue with me, be reassigned to Hq. Co so that he may continue on his present job.
4. It is requested that his papers be recovered from Co G in time to allow of his being paid, since he missed his last month's pay because his papers were in transit and neither Hq Co, Co C or Co G could pay him.

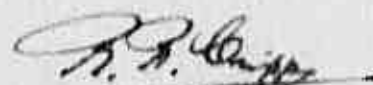
