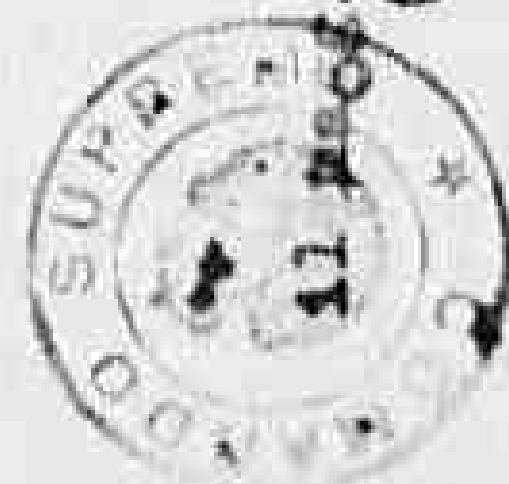

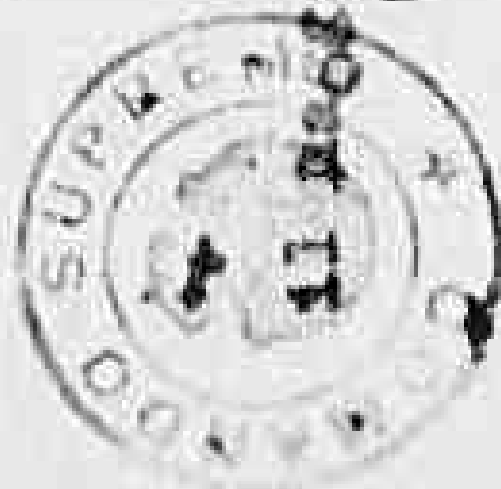

SUBJECT : Interpreter.TO : G-1, HQ ACC APO 394

1 It is desired to employ 2/Lt. GERARDO ZAMPAGLIONE at present employed as an Italian Liaison Officer with 10 Corps as an interpreter. There has been considerable difficulty in obtaining an interpreter capable of translating technical legal terms to the appropriate British equivalent or vice versa.

2 Zampaglione is a Doctor of Law of Rome University and was a practising lawyer. He is the author of several books and speaks English and French as well as Italian. He seems a particularly suitable solution to a long standing difficulty.

3 It is not proposed that he should be carried on this establishment but on the strength of the Italian Liaison Section here as is the case with other Italian personnel.

4 It is also desired that his Batman Gnr. CARLO FRONTI - Arty-Class 1910 may also be re-assigned for service here.

5 The draft of a letter to HQ ACC is submitted for signature, if approved may one copy be returned (if signed) for our files.
