1. In compliance with para 5 of your letter dated 24 October 44, reference AG/3096/PH, the Public Health Sub-Commission submits the following information:

a. This Sub-Commission has 6 assigned requisitioned cars and 11 vehicles.

b. (1) One of the above requisitioned cars is assigned to the Director of the Sub-Commission who also acts in the capacity of Liaison Officer for AGO, AG and the National Agency for the Distribution of Relief Supplies in Italy, as well as Liaison Officer between AG, the American Red Cross, the British Red Cross and the Italian Red Cross. His functions require him to make visits to important persons upon short notice and to attend important conferences upon short notice and a car always on hand is indispensable to the efficient performance of his assigned duties.

(2) Another requisitioned car is assigned to the Public Health Section of this Sub-Commission. There are in this Branch 6 Commissioned Officers, including the Chief, who are dependent for transportation upon this car. This car is used for field trips as well as for emergency local trips that are necessary to be made to hospitals and conferences with officials of the Italian Government in connection with public health matters.

(3) One of the a/a requisitioned cars is assigned to the Veterinary and Welfare Branches of this Sub-Commission for the use of 3 Commissioned Officers and 1 civilian veterinarian, including the chiefs of the branches. It is necessary for one of the Veterinary Branch to visit daily a laboratory 10 miles distant doing essential work in the production of vaccines, as well as other laboratories which require attention 2 days or more each week. Infected livestock in any or all of the liberated provinces have to be inspected, often on the spur of the moment. It is also necessary for the Chief of the Welfare Branch frequently to confer on short notice with members of the Italian Government as well as other national welfare organizations.

(4) One of the assigned requisitioned cars is assigned to the Medical Supply Branch in Rome for the use of 2 Commissioned Officers, including the Chief of the Branch, and an Italian doctor employed by the Branch. The Chief of this Branch is the senior officer next to the Director of the Sub-Commission and he must act for the Director in his absence. In addition, the car is used often to attend urgent conferences with the Italian Government, to visit drug and pharmaceutical plants on short notice in the vicinity of Rome, as well as for field trips.

(5) Another of the a/a requisitioned cars is assigned to the Hygiene Control Unit and is used by the Administrative Officer for this Unit in cases where duties require him daily to spend much of his time in a car.

(6) One of the 40 vehicles (Jeep) is used by the Officer in Charge, Medical Supply Depot, Florence which is situated some distance from the center of the town. It is often necessary at this depot to rent civilian cars to transport civilians having executive positions.

(7) One of the 40 vehicles, as well as 1 of the 40 requisitioned civilian cars, is in use at the Central Civilian Medical Depot in Naples and they are found to be inadequate transportation for the efficient operation of this warehouse.

(8) One of the 40 vehicles (Ford truck) is located at Naples at the 401 Army Clothing Warehouse and is absolutely essential to the operation of this warehouse.

(9) All other 40 vehicles are assigned to the Typing Control and Material Control Units of this Sub-Commission. The Typhus and Malaria problems in Italy are peculiarly coordinated insofar as administrative control is concerned. Both diseases are insect-borne and the primary control method in each instance is by insecticides. The seasonal difference in the prevalence of typhus and malaria makes it possible to utilize the same administrative and supervisory personnel in a year-round program. With the onset of cold weather the malaria problem

recedes because mosquitoes cannot breed, but low temperatures favor the louse thus typhus emerges as the primary problem during the winter months. The personnel, facilities and supplies logically alternate from one to the other of these two diseases.

Throughout the summer the Typhus Control Service has made a determined effort to smother the last lingering sparks of infection that remain in the area open to its staff. These efforts have been only partially successful for on the average there has been about one case per month reported since the end of last season. Our surveys show that the people are probably no less lousey than they were last fall at this time. The continued finding of scattered cases should be warning enough to the responsible authorities to be on the alert and prepared to act promptly whenever and wherever cases are reported. To do this it is of the first importance to have transportation, personnel and supplies ready to dispatch instantly to the place where they are needed. Transportation, personnel or supplies that are promised, on order or in the shop cannot be used. We have deliberately carried over key personnel in the delousing stations during the summer months when there was relatively little work for them to do, and a considerable stockpile of insecticides has been built up, both specifically to take care of the demands of the coming season and to avoid the costly fumbling which preceded the initiation of last winter's control program. It is therefore urgently requested that these preparations not be nullified or jeopardized by the recall of the transportation which it takes to deliver the service at the places where it is required.

1. The Section had two cars allotted to it, one military and one civilian. In the reorganization it obtained a third car which had formerly been allotted to the French. On the basis of one car for four officers, it is entitled to three cars.

2. The military car is essential for the CP who, as the CMO, have frequently to make long journeys for the purpose of attending conferences. The CP and his Staff officers have almost daily to make visits to the various Ministries. Not only has the CP to make many official visits and very other conferences and appointments in this capacity, but the section is responsible for refueling and the staff officers concerned have daily visits to the offices of the High Commission and to various Ministries for which a taxi is quite unsuitable. With the military car away for several days at a time, as it is so infrequently in, a second car is essential for these purposes.

3. The Section is also responsible for mine clearance and a third car is necessary to carry engineering and other officers to minefields both for planning and supervisory purposes, for attending conferences, arranging supplies, etc.

4. Our experience of wear and of repairs is that even with our full complement of three cars it is difficult to keep two always on the road. We cannot do with less.
