SUBJECT : Explosion of Allied ammunition depots

The Prefect of Caserta has informed us that in a locality 876 yards far from Aversa, an explosion of explosive gelatine belonging to the Allies has taken place. Damages have reached 100 million lire and a great number of persons have become homeless.

Since in these last days it has been brought to our notice that also in other provinces many explosions of ammunitions depots have taken place in localities situated near inhabited centres, we strongly beg the Allied Commission to take steps in order to examine the possibility of adopting such measures as may be deemed necessary to avoid such accidents.

We would be very obliged if the Allied Commission would give us assurances in this connection.
