1. With reference your telegram 4748, June 3, 1944, to which I have replied, I am enclosing a copy of the most recent report received from the High Commissioner. While the Committees are functioning, the returns are not complete.

2. The results of the action taken prior to February 11, 1944, by AMG are as follows:

(a) Investigations completed.

A total of 3671 individuals were investigated of which 3466 were recommended for retention, 94 recommended for dismissal and 111 dismissed. A list of the names of these dismissed and recommended for dismissal are attached.

It is requested that no action be taken on these cases without collaboration with ACC.

(b) Investigations not completed.

A total of 7234 investigations were pending on February 11th. In each of these cases a Scheda personale has been completed and will be held in the possession of ACC.

This report has been submitted by Public Safety to the Public Safety Sub-Commission.

3. Weekly reports will be submitted hereafter.
