The Central Commission for war crimes has been instituted in the Ministry of Occupied Italy by Ministerial Decree for the purpose of investigating the atrocities, looting, the fires, deportations, killings and other crimes committed by the Germans and the fascists since 25 July 1943 against the Italian civilian population.

At present the Commission is composed of the following members:

H.E. Aldobrando Medici Torquini, President, Under Secretary of State.

H.E. Saverio Brigante, section president of Cassation.

Prof. Concetto Marchesi, rettore of the Padova University.

Dr. Antonio Cottafavi, first secretary of Legation, of the Ministry of Foreign Affairs.

Dr. Francesco Ferrante, councillor 2nd class, of the Ministry of the Interior.

Lt. Col. Luigi Soranzo, of the Ministry of War.

AVV. Arturo della Scala, representing the Central Committee of National Liberation.

Prof. Attilio Ascarelli, director of the scientific Police school.

AVV. Claudio Bettinei, Journalist.

Dr. Piero Berretta, Tribunal Judge.

Judge Dr. Piero Berretta acts as secretary.

Steps are being taken to complete the Central Commission with the appointment of H.E. Alfredo Lamitti Pirromallo, section president of Cassation, representative of the Ministry of Freedom and Justice, of Judge Dr. Rubino Italo, representative of the High Commission for sanctions against Fascism, of Prof. Ferussi, diplomat of the legal Department in the Ministry of Foreign Affairs.

Following the Central Commission's resolution of 16 March 1945 it was ordered that in every province a Commission composed of one representative of the Prefecture, one of the Civil and Penal Tribunal and one of the Committee of National Liberation be formed with the object of collaborate with the Central Commission in the investigation of crimes committed in each province.

Since the liberation of Northern Italy has been effected only recently these local commissions are still in the organizational phase. as soon as they are completed we shall communicate with the Allied Authorities in regards to the general prospectus of these provincial Commissions with the name of their members and main offices.

1. Attached for your information are copies of Dr SCOCCHIMAPPO's letter of 1 June and this Headquarters reply of 27 June from which it will be seen that the Italian Central War Crimes Commission will henceforth assume full responsibility for investigation of atrocities committed by Germans and Italians against the Italian civilian population.
2. It will be noted that
 - a. The Italian commission's function are at present limited to investigation only.
 - b. There is no authority yet for the handing over of any person desired by the Italians who is in British or U. S. custody.
 - c. Offences committed by Germans and Italians against British or U. S. forces will be investigated by the respective force.
3. The question of the action to be taken by the Italians on completion of their investigation is being taken up by the appropriate branches of this Headquarters. A small STB detachment has been attached to the Italian Commission to assist in explanation of the cases handed over and to insure continuity.
4. Any cases of War Crimes by Germans or Italians against the Italian civilian population which come to you notice in the future should be referred by you direct to the Italian Central War Crimes Commission unless you have reason to believe that Allied interests are concerned or a General or other high ranking person is involved, in which case the papers should be forwarded through this Headquarters.

As a member of the Italian Government and as head of the Ministry for occupied Italy, which includes the Central War Crimes Commission, I wish to express my whole-hearted approval of the enclosed document, drawn up by you and Judge Peter Berretta, Secretary of the Central Commission. On behalf of Italy, I accept it without reservation.

I agree that the Italian Central War Crimes Commission is to assume full responsibility for the verification of atrocities committed by the Germans (and the Fascist bands under their control) against the Italian civilian population. Accordingly, I ask the Allied authorities kindly to submit any pertinent documents in their possession, whether formal indictments or such other evidence as may be of use to the Commission in preparing its cases.

I am most grateful for the cooperation of the Allied authorities and trust that they will continue the verification of the atrocities which the Germans and Fascists have committed in Italy.

I am further grateful to the Special Investigation Branch which has offered the services of liaison officer to work with the Central Commission on the identification of individuals and groups of Germans responsible for the crimes.
