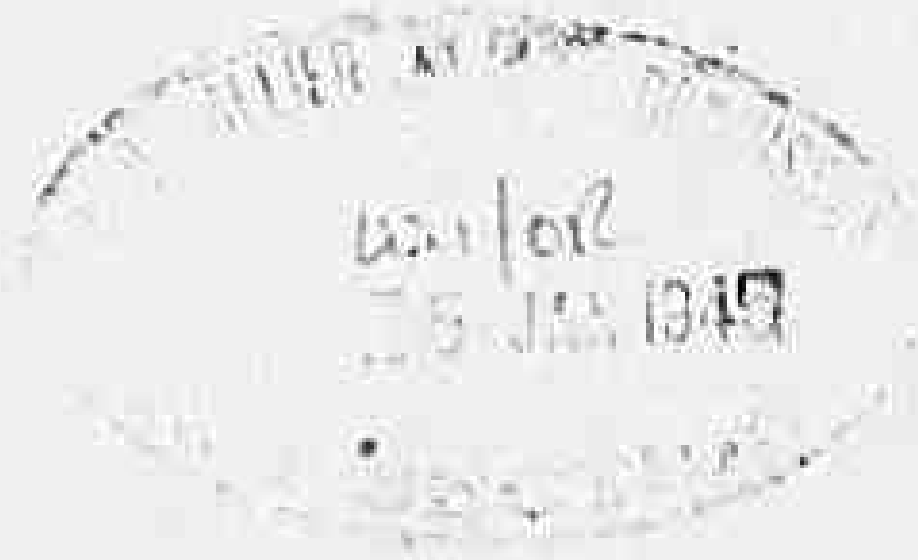

The enquiries are now complete. Para (b) refers to "no report from the PP30 other than that obtained from CCRR".

Apart from the CCRR, there is no other channel through which such enquiries can be made.

With reference to HQ No. 3 District letter, it would suggest a belief that AC Officers were to be found in all parts of a province, whereas in fact there is one PP30 for these three Provinces and one P.O. for each Province.

Another point is that many of the places are well off the beaten track and communications take days, operating on the CCRR foot patrol. However, it is noted that these enquiries are duplicated through Corps of Military Police, which is in the main, mobile.

In the past, under A.M.G. practically all communes were under the control of a C.A.O. coupled with a C.A.P.O. Transport did not present a problem and personal interest by one or the other could be taken during a visit to a commune.

Circumstances now are such that it is more often than not impossible to comply with the suggestion put forward in the No.3 District letter.

To assist as far as possible, a letter was drafted to Group Commanders, CCRR, some four weeks ago on the necessity for stringent enquiries and complete detailed reports in connection with enquiries under "Marriage Regulations".

1. Reference your AP/1/29-32, dated 9 Dec.44, and AP/1/29-39, dated 22 Dec.44 the 9 Appendix "C" to IRO 162/44 and attachments are returned with the following observations.

- (a) CC.RM. reports on marriages are not considered sufficient. It is essential that a Police Officer report on the civilian parties to the marriages.
- (b) A separate report is required from the Police Officer for each of the marriages. A single report covering all 9 will not suffice - a report in each case is required by higher authority.

2. Particular importance is attached to these reports, this HQ has recently been written regarding the importance of full enquiries into all these proposed marriages.

3. The attached appendix "C" and those returned under this office letter of even number of 20 December 44, are now urgently required in order that the ex POWs may be repatriated with the least possible delay.

A copy of the report which is a translation on the "Other party" and Form "C" are returned to you for clarification. The report states that the girl is pregnant and married to the "English soldier Rightin ale Jakob". In Form "C" the applicant L/Cpl KRAMER is asking permission to marry GRENSTEIN Cyla but if she is already married to another soldier then this should clearly be stated. It should definitely be stated that the girl is not in a position to marry L/Cpl Kramer if this is so, but this is not clear as "Rightingale Jakob" may be the person who interviewed her. Your Excellency,

It has been reported to this Headquarters that there was a case recently in which an Italian civilian official at Bari performed a marriage ceremony between an English soldier and an Italian woman and that the soldier had not obtained consent from the Army authorities for the marriage.

It is requested as a measure of protection for Italian civilians that you should be aware of this regulation and that all officials, civilian and ecclesiastical, who are authorized to solemnize marriages should be informed of it.

The regulation is "designed" not merely to prevent hasty marriages but to ensure that no impediments exist. Under Army regulations members of the Allied Forces who marry without the required permission might be subject to discipline. Their wives would not be entitled to claim financial support from the Service.

It is suggested therefore that you inform the pertinent authorities of the risks involved to Italian civilians who marry members of the Allied Forces who do not have military permission.

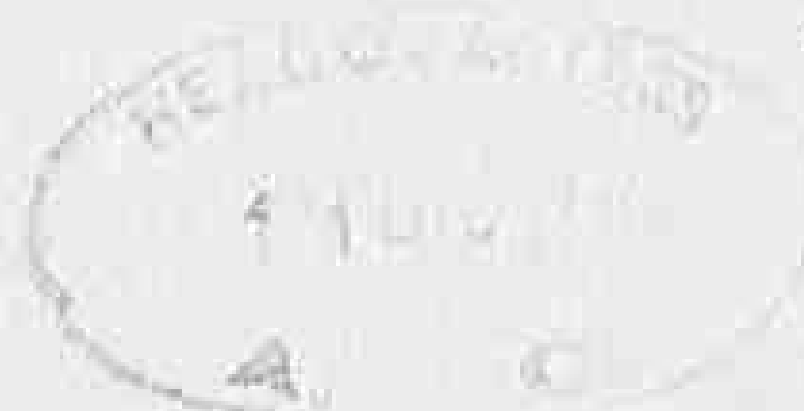

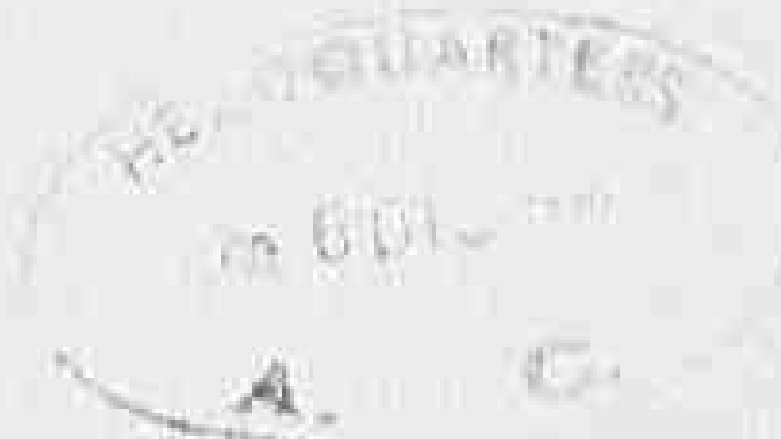
