2. The absence of any objection by the Allied Authorities to such marriages is not to be construed as in any way purporting to validate a marriage otherwise illegal or invalid.

3. Such marriages do not necessarily confer any additional privileges on the parties concerned. For example, they will only be permitted to occupy married quarters in a camp subject to such quarters being available and then at the discretion of the Camp Commandant.

4. Notification of marriages will be made to the following authorities in order that the name of the woman concerned may be altered in their records :

- (a) HQ which authorised internment.
- (b) A.C. of S., G.2., A.F.H.Q.
- (c) G.H.Q., 2nd Echelon.

NOTE : (c) is not applicable if documentation on AF W.3000 has not previously been carried out.

Commission contained in letter 4/36.1/CA of 21 Dec 44, this Ministry, with telegraphic circular addressed to the Prefects of the dependent Provinces, has drawn immediately the particular attention of the competent offices of civil status and of the ministers of religion on the obligation of the previous formal consent of the Allied Military Authorities in the cases of marriage to be celebrated between Allied soldiers and women of Italian nationality.

At the same time it has been pointed out that this obligation is prescribed for purpose of avoiding disciplinary measures against the soldiers concerned and, above all, for the protection of the women in order to prevent hurried marriages without the guarantee of lack of difficulties.

For this purpose it has been ordered that the competent offices must present, upon the request of the marriage publications, the regular military permission above mentioned, warning the persons concerned of the responsibility and risks which they are liable to if they do not comply with the prescribed formalities and warning them that, in case of non authorised marriages, all right to financial assistance from the Allied Military Authorities is excluded..
