1. Following from officer administering Government PALESTINE. Nr 681.

Your telegram 11 and my telegram 681 in reply thereto. JEWS in ITALY and NAHON. Following is text of my telegram 1399 to Secretary of State for Colonies on subject.

"NAHON is still in JERUSALEM and Allied Forces Hq in ITALY have informed Hq Allied Control Commission in ITALY that it has no knowledge of NAHON'S application to enter ITALY having been received. I have informed Allied Control Committee "it is most desirable that until NAHON arrives no immigrants for PALESTINE be permitted to proceed apart from those already in possession of immigration authorities." In view of allocation of a figure of 900 persons for immigration of JEWS in ITALY to PALESTINE I consider it most desirable that NAHON should arrive in ITALY as soon as possible in order to assist in selecting suitable immigrants. I shall be grateful for your assistance in securing authority for his admission to ITALY at an early date." Ends.

SECRET. Following from Officer administering Government of PALESTINE. Number 681. Message begins:-

Your telegrams numbers 10 and 11. Immigration of JEWS in ITALY to PALESTINE. Important. Number of JEWS who may be admitted to PALESTINE from ITALY under arrangements notified in my former telegram number 681 in answer to Heathcote-Smith's telegram number 8 is 900 persons as an overall figure and not rpt not 900 persons per month.

2. All JEWS in liberated ITALY are eligible for selection within the overall figure of 900 not rpt not solely JEWS from YUGOSLAVIA.

3. JEWISH Agency proposes to send HAHON as its representative in ITALY. He will be mainly responsible in consultation with you for selection of suitable immigrants to PALESTINE within the overall figure of 900 which is subject to increase or decrease as described in my former telegram number 681. It is most desirable that until HAHON arrives no rpt no immigrants for PALESTINE be permitted to proceed apart from those already in possession of Immigration Authority. Suggest that BENTON'S previous experience may be of assistance.

4. It is essential that JEWS permitted to proceed to PALESTINE should be in possession of valid travel documents preferably valid national passport upon which VISA for PALESTINE has been affixed.

5. Further telegram will be sent on subject of HAHON. Message ends.
