In accordance with your instructions I attended the Conference held by GOC 2 District at LIDO DI ROMA on 6/7 April, after having previously spoken with General NARES.

On 6 April GOC opened the Conference with an appreciation of the military situation in North Italy and outlined the possible developments that the battle might take. He emphasized the fact that in event of a general surrender nearly a million Germans would become dependent on the Allied authorities for maintenance. GSO 1 then outlined the IV Corps operational plans, explaining the alternatives prepared to meet the situation. A talk followed by Major Gibson and Captain McKenna of No. 1 Special Force who gave details of the location and activities of Partisans in N.W. Italy and the conditions that we might expect upon entry. Statements by Area Commanders terminated the first day's proceedings.

On 7 April, after giving a message from Director, Labour Sub-Commission, concerning the proposed policy to be adopted for Wage Scales, whereby the minimum rate will be paid without bonus, I made a brief outline of the political situation obtaining in N.W. Italy as far as we know it. I drew attention to the arrangements made between the Supreme Allied Commander and the Italian Government with the CINAI, and the opinion of the Acting President as to conditions we may find in the North. A discussion then followed on Civil Affairs, at which various general questions were raised and answered. No. 2 District were particularly anxious to know the policy towards Price Control and anti-inflation.

CE 2 District talked on the Engineering aspect of N.W. Italy and foresaw little shortage of engineering equipment to repair damaged installations. Gravity would assist in the Genoa water supply, even if mains were broken. AD Claims and Hirings terminated the Conference with a statement on the various directives governing Requisitions and the procedure that is being followed in the settlement of claims.

SUBJECT: Northern Italy Planning - Frontier Control.

TO : G-5, AMHQ.

1. Reference your P/381-34 of 28 Jan 45.

2. Further to our AC/14080/6/PS of 21 Feb 45 we wish to submit the following amendments and additions. From an economic and financial point of view we suggest that para 1 of the draft directive should read:

"1. All travel and movement of goods across the pro-1933 Italian-French and Italian Swiss frontiers will be prohibited and prevented by AMG and by Headquarters 15th Army Group immediately the progress of operations enables this to be done. Absolute closure of the Italian French frontier for a prolonged period may be found to cause severe hardship to border populations dependent for their food supplies or livelihood on contiguous areas across the border. Should it become necessary to prevent unrest, minimum transfrontier movement of approved civilians and foodstuffs sufficient only to counteract the immediate hardship, may be permitted subject to verification of the bona-fides of each case and to stringent control of movement. Directions should be sought from Headquarters 15th Army Group if similar conditions are found to exist on the Italian-Swiss frontier."

3. In connection with security control of the Italian-French frontier, it is felt that the services of the Customs personnel would be advisable to make any necessary examination of civilians for the detection and prevention of smuggling of goods, prohibited articles, currency and valuables and to advise the GG.FF and other security forces. Their services will be essential when restrictions on travel and merchandise are relaxed, particularly for the operation of trade and finance controls.

4. Skeleton forces of Customs officials are in readiness to go north to reorganise their border services. Their strengths are:

- French frontier - 20 officials
- Swiss " - 40 officials
- Senior officials are included.

As the Customs found on the spot may be unreliable, disorganized and lacking leaders and authoritative direction it is suggested that skeleton forces should be called forward in stages by Headquarters, 15th Army Group, a few senior officials being sent forward with the first draft of GG.FF.

5. Amendments to the draft directive necessary to implement these suggestions are as follows:

Para 2 (b) of the Draft: Cancel and substitute: "The fixing of responsibility, by AIG and Headquarters 15th Army Group, on such Italian Military (including CC.RR), GG.FF and Customs personnel as may be found exercising control, for the enforcement of the closing of the frontiers":

Para 4 of the Draft:

Add after fifth line:
"60 Customs Officials."

Delete ninth line "(including CC.RR) ... frontiers,"
and substitute:
"(including CC.RR.) :GG.FF. and Customs personnel found engaged in control of frontiers."

Para 5 Delete last sentence, and substitute:

"The CC.RR., GG.FF. and Customs personnel referred to in para 4 above will continue under the operational control of the Frontier Control Detachment CIC."

Para 6 Amend as follows:

Sub-para (a). Delete and substitute:

"a. Assemble the 350 CC.RR., the 600 GG.FF. and 60 Customs officials referred to in para 4 above, providing the CC.RR. and GG.FF. with all necessary equipment, and arrange transportation in readiness for their calling forward by Headquarters 15th Army Group."

4. It should be clearly understood that any movement of stores and personnel via France will necessitate AFHQ obtaining SHAEF's agreement for such a move.

SUBJECT: D.P.R.S.C. Centres on Franco-Italian Frontier. **11 MAR 1945**
TO : Civil Affairs Section, HQ.AC.

Reference DPR/1-3/ADM dated 28 February, 1945.

1. This Sub-Commission has two proposed Refugee Centres at BORDIGHERA and GRIMALDI in LIGURIA Region. In view of the fact that refugees will be crossing the Frontier on foot or by any means available at the first possible opportunity, it is considered desirable to set up some form of refugee control at the two above-mentioned Centres as soon as possible.

2. The mountainous nature of the country makes it easy for the main road from Genoa to the North to be impassable. It is therefore requested that the following points be given consideration:-

- (a) Organisation to be set up for the transport of personnel and/or stores for the proposed Centres by sea to SAN REMO.
- (b) That personnel, transport and stores for the required Camps be sent to the South of France, ready to move as far into Italy as possible when the Germans move out. Rations presumably could be obtained from the South of France.

3. I have discussed the above with the Provincial Commissioner, Imperia who, I understand, has discussed it with the Regional Commissioner, Liguria.

SUBJECT : Northern Italy - Planning - Frontier Control.

TO : AFHQ, G-5.

Reference your P/301-34 of the 20th January, 1945.

1. The draft letter on the control of frontiers, enclosed with the letter referred to above, is not entirely in accord with the views of the Public Safety Sub-Commission of this Headquarters as regards the provision of Italian Police. The two principal amendments suggested are:

- i) A reversal of the decision not to make use of Agents of Public Security, and
- ii) A modification of the policy of automatically suspending personnel found at the frontiers.

2. The whole organisation of frontier control in Italy is based on zones under the jurisdiction of the Ministry of the Interior. Each zone is controlled by a Public Security Commissario, responsible through the Prefect, to the Police Department of the Ministry. The Commissario has a staff of Agents of Public Security and exercises control over the Carabinieri and Finance Guards. The Commissari and their staffs are the most experienced personnel in Italy for this kind of work. It seems unwise not to take advantage of existing machinery and trained staffs, which can be effectively supervised by the CIC Detachment. Moreover, when Allied Military Control is eventually relaxed, the Italian Government must inevitably revert to the original system of frontier control under the Ministry of the Interior.

3. It is pointed out that Public Security Agents have been used throughout territory already occupied and have given valuable service. Indeed, it would have been almost impossible to have controlled crime in Italy without their cooperation.

Accordingly it is strongly recommended that the services of Public Security Agents be retained.

4. With regard to the suspension of police found at the frontiers, past experience has shown that the Italian Police have always cooperated loyally with the Allies on their arrival. Other things being equal, it is always preferable, in the police service, to take advantage of the local knowledge of the man on the spot. As far as Public Safety Sub-Commission and the Italian Ministry of the Interior are aware, there is no reason to suppose that the police in Northern Italy will be any more disaffected than those who have been used to such good effect in the South. It is therefore recommended that the local police be retained unless they are found to be unsatisfactory, in which case they can easily be removed.
5. No draft proclamation is annexed as Appendix A, and therefore no comments thereon are possible. It is requested that the draft be forwarded as soon as possible. In accordance with the invariable practice in such matters the exact form of such proclamation and its final terms will be the entire responsibility of this Commission acting on the advice of the Legal Sub-Commission.
6. Two other minor amendments are suggested:
 - i) In paragraph 1, of the draft letter it is thought advisable to state specifically that the transport of merchandise across the frontiers will be prohibited;
 - ii) With regard to paragraph 6 b) it will not be feasible to designate four Allied Officers for attachment to the Frontier Control Detachment CIO, owing to the shortage of officers. It is therefore suggested that Public Safety Officers designated for frontier provinces should be instructed to maintain the closest liaison with the Frontier Control Detachment CIO.
7. For clarity and convenience a revised draft letter, incorporating the above amendments, is enclosed for your consideration. 3929
8. Paragraph 2 b) of the draft contemplates the use of military personnel found exercising frontier control but you may consider it desirable to use additional personnel from the Italian army. It is the opinion of this Commission that in

This is a matter you will no doubt consider.

SUBJECT : Control of Italian-French and Italian-Swiss Frontiers.
TO : See Distribution.

1. All travel across the pre-1919 Italian-French and Italian-Swiss frontiers and also the transport of all merchandise will be prohibited and prevented by AMG and by Headquarters 15th Army Group, immediately the progress of operations enables this to be done.
2. Means to be employed include:-
 - a. Publication by AMG of a Proclamation substantially in accordance with the draft attached as Appendix A.
 - b. The fixing of responsibility, by AMG and by Headquarters 15th Army Group, on such Italian Military (including CC.MB, CC.PP and Agents of Public Security, as may be found exercising frontier control, for the enforcement of the closing of the frontiers.
 - c. The immediate suspension from such functions, by AMG, of any Frontier Militia personnel found participating in frontier control.
 - d. The employment by Headquarters 15th Army Group, as a temporary measure, of Allied troops as frontier guards, if this should prove to be advisable and feasible.
 - e. The employment under Command of Headquarters 15th Army Group of the Italian Frontier Control Detachment CIC, whose functions during this period are outlined in paragraph 4 below.
3. The closure of the frontiers will remain in force until an adequate Allied Military Control has been established by the Italian Frontier Control Detachment CIC, and until the Detachment has reverted to under command of AFHQ as laid down in paragraph 5 below. After this stage has been reached, permitted traffic across the frontiers will be permitted according to conditions to be laid down by AFHQ.
4. The Italian Frontier Control Detachment CIC will be

assisted by the following bodies of Italian personnel drawn from that part of Italy at present liberated:-

350 CC.RR
600 GS.FF

This personnel will be called forward in stages by Headquarters 15th Army Group, and will come under the operational control of the Italian Frontier Control Detachment CIC. It is intended that all Italian Military (including CC.RR) GS.FF and Agents of Public Security, found engaged in the control of frontiers should continue to perform their duties under the control of the Italian Frontier Control Detachment CIC. They will be screened without delay in conjunction with selected officers from their Headquarters who will accompany the CIC Detachment for this purpose. All unsatisfactory personnel will be removed and replaced. AMF will be prepared to assist in this process during the period of the total closure of the frontiers.

5. After the initial period, which will be terminated by AFHQ in consultation with Headquarters 15th Army Group, the Frontier Control Detachment CIC will revert to the direct operational control of AFHQ, but Headquarters 15th Army Group or the District Headquarters concerned will continue to provide necessary accommodation, supplies and communications. The CC.RR., GS.FF., and Agents of Public Security referred to in paragraph 4 above will continue under the operational control of the Frontier Control Detachment CIC.

6. A.G., will:

a) assemble the 350 CC.RR and the 600 GS.FF referred to in paragraph 4 above, provide them with all necessary equipment, and arrange transportation in readiness for their calling forward by Headquarters 15th Army Group.

b) Instruct Public Safety Officers designated for frontier provinces to maintain the closest liaison with the Frontier Control Detachment CIC.

c) Submit to AFHQ, G-2 Section, and to Headquarters 15th Army Group, nominal rolls of 6a and b above.

d) Arrange for the CC.RR., GS.FF., and Agents of Public Security to be provided by AMF/C, within the Army areas, with all necessary accommodation, supplies and transport. This arrangement will continue throughout the initial period of 15th Army Group Command of the Frontier Control Detachment CIC, and subsequently. It is necessary that adequate preliminary arrangements be made for the personnel to arrive, and commence

1. Reference your Progress Report HWI/CONF/1A dated 11th February 1945, para 3(a) "Frontier Control".

2. Enclosed for your information are copies of:

- (A) Letter 13062/F of 6 Jan. 1945 to AFHQ, G-5 Section.
- (B) Lists of the principal frontier crossings.
- (C) Sketch map of pre-Armistice French-Italian frontier indicating pre-war and post-Armistice Customs stations.
- (D) Memo of Political Section, 4th November 1944 approving reversion of the pre-war French-Italian frontier in the initial period of AMG occupation.
- (E) List of normal Customs staffs employed on the French-Italian frontier.
- (F) Letter 6510/23/COS dated 14th November 1944 from Acting Chief of Staff to AFHQ, G-5 Section.

3. This Sub-Commission is concerned, inter alia, with the re-establishing of Customs control of the frontiers for the collection of import and export duties, the prevention of smuggling of dutiable and prohibited goods and the enforcement of import and export, trading with the enemy, censorship and exchange controls. Questions of security control are under the aegis of Public Safety Sub-Commission on whom falls the onus of the disposition of the Carabinieri (CC.RR.), agents of the Pubblica Sicurezza (PSA) and, in so far as they may be used for security purposes, the Regia Guardia di Finanza (RGF). The principal duties of the RGF along the frontier, in peacetime, are the prevention of smuggling and evasion of the various controls and the diversion of persons and traffic to the authorised routes across the frontier.

4. To assist and co-ordinate the efforts of the various State departments in their planning for the re-establishment of frontier controls an inter-departmental "Frontier Committee" was formed under the chairmanship of the Director-General (Reggente) of the Customs, at the Ministry of Finance. This committee, in conjunction with the Public Safety and Finance Sub-Commissions, has earmarked skeleton staffs of Customs officials, R.G.F., CC.RR., and P.S.A., to be ready at short notice to proceed to the frontiers. The Customs and R.G.F. "squads" include senior officials who will be sent to North Italy as soon as it is liberated to ascertain and report on the

condition of staffs, offices and equipment and to call forward reinforcements as required. They will carry minimum quantities of essential office supplies for the initial stages.

5. The assistance of AMI may be necessary in the early stages to house and feed the skeleton staffs.

6. The copy of letter 6510/23/008 of 14th November 1944 at enclosure F indicates several points on which directions from AFM, G-5 Section are awaited. Directions are also being sought as to whether the existing Customs tariffs are to be applied without modification.

Policy. Major Bennett of G-2 AFHQ gave an outline of Frontier Actual plans were being discussed by Public Safety.

Plans for Northwest Italy.

1. In general the plans of the Education Subcommittee for Northwest Italy are the same as those in successful use in Toscana and Emilia.
2. Directives, in detail, have been mimeographed (in English and Italian) for each region, and are complete except for filling in the name of the Region and signature of the Regional Commissioner. (Appendix A).
3. General HUME has agreed to take the Regional Education Officers in with the Army as Army Education Officers so that they can begin their work and protect school and university buildings.
4. 1st Lieutenant SIMONI will move up from Marche-Abruzzi to Liguria; Captain NOE from Toscana to Piemonte, Captain PRATT from Emilia to Lombardia. All these men have had extensive experience in opening schools in regions as they are liberated and know well both the problems and the way to meet them.
5. Because of the small personnel each will immediately obtain the services of one or more experienced civilian school officials to act as full time assistants.
6. The Minister of Public Instruction has supplied for each Regional Education Officer a list of suitable candidates for the key university and school positions. Supplemental lists of persons who could be sent up from the already liberated parts of Italy in case of necessity are being prepared.

1. I attended the meeting called to fix the Agenda for discussion and read over to the meeting your letter of the 19th. The points of this letter are being incorporated into the Agenda.

2. The bulk of the time was taken up with discussion of economic problems, particularly with regard to roads, railways, etc. The matter of fixing the priorities for repair was discussed. One point raised in connection with your letter was "Aid to Civil Power". It was thought that this should come under Public Safety. I pointed out that all Public Safety would want to know was where and how civil aid could be obtained. The question is one for AFHQ and to some extent, probably for MMIA. The matter will be raised, however, under the question of strikes.

3. Patriots - it was pointed out that during the first 30 days of occupation the handling of patriots is a question for MMIA and not Patriots Branch.

4. Displaced Persons and Refugees, etc. A question was raised as to ~~whether~~ providing soup kitchens &c in places like Milan, etc., for the benefit of the civil population. This matter could be taken up with Public Health and through them with the Italian Government.

5. The Agenda is being issued in the beginning of the week and the Committee would like Sub-Commissions to prepare their appreciations on the points raised in the Agenda. They feel that Sub-Commissions should consult their Regional Officers (which they probably have done) before completing their appreciations. Economic Section will get their Sub-Commissions to write reports on the points raised in the Agenda and I said that Civil Affairs would do the same with their Sub-Commissions.

6. The Committee knew that you had already written ³⁹⁰⁰ an appreciation and were getting in reports.

7. As soon as the Agenda comes out Sub-Commissions should be asked to submit their appreciations, dealing in particular with the points raised in the Agenda.

The phrase "maximum delegation to the Regional Commissioners on the spot" in paragraph 5 of the memorandum is intended to mean that Regional Commissioners should have delegated to them the maximum powers which this Headquarters considers safe to delegate. It may be that full powers are already delegated and in Civil Affairs Sub-Commission I think this is probably the case. Regional Commissioners, as far as this side of the Commission goes, probably have all the powers they require through the Proclamations and General Orders. With regard to Economic Section, however, it may be that the Regional Commissioner will not consider himself capable of dealing with some of the complicated industrial problems arising. This may be due either to lack of powers or to lack of suitable technical advisers. In any case Sections are asked to review the powers already delegated to Regional Commissioners so as to determine whether in their opinion they are sufficient.
3. Will addresses please be prepared to discuss this matter again at the next Chief of Staff's Meeting on Tuesday, 2 January 1945.
