Certain statements have been attributed to Pietro Nenni in his interview given to the London press. According to reports received here, Nenni stated

- (a) that the Italian Government should be free to reorganize its internal administration;
- (b) that nearly all the Prefects to whom the administration of liberated provinces is entrusted are still career officials of the Fascist period;
- (c) Canevari, Undersecretary for the Interior, proposed 57 anti-fascist prefects, of whom only 3 were approved by the A.C.

These statements are, in the opinion of the A.C., misleading. Following are the facts :

- (a) An Italian commission is now sitting to consider the re-organization of Italian internal administration. The A.C. takes no part in this and does not propose to interfere in it. Nor has the A.C. ever opposed such re-organization : on the contrary, it has urged it.
- (b) In territory under Allied Military Government, prefects are appointed by AMG and the Italian Government is consulted, though it has no right of veto. In no case has the Italian Government raised objections to any such appointment.

In territory under Italian jurisdiction, Prefects are appointed, transferred or dismissed by the Italian Government, with the approval of AFHQ. All prefects are investigated by the Espionage Commission of the Italian Government and suspended if necessary. Of the 52 provinces liberated, 27% have non-career Prefects. Of the 20 provinces liberated since the fall of Rome 40% have non-career Prefects.

- (c) It is untrue that 57 names were proposed to A.C. to replace Prefects. Never has either an official list or separate names of proposed non-career Prefects been submitted to the A.C. for replacement of career Prefects.

Memorandum on Pietro NENZI's statement in the London Press  
18 December 1944

The procedure as to the appointment of Prefects is as follows:

Military Government Territory

1. The initiative as to the appointment of the Prefect comes from the senior officer in the field, i.e. the SCAO 5th and 8th Armies in areas under Army control, and the Regional Commissioners in areas under Regional control. He may either (a) decide to appoint a local man or (b) request ACHE to send him a suitable candidate. In either case, the formal appointment is made by the SCAO or RC.
2. If the SCAO or RC wish to appoint a local man, he sends up particulars of him to Local Government Sub Commission. It is the practice of the Sub Commission to ask the Italian Government for their observations in such cases. The Government have no right of veto: the appointment is approved or disapproved by AC, but due weight is given to any representations the Government may make. The policy followed is to accept the recommendation of the SCAO or RC, unless there are obvious reasons against it. In no case has the Italian Government objected to such an appointment. In no case has this HQ had occasion to demur the recommendation of the SCAO or RC.

  6. With regard to the attitude of the Allied Commission toward non-career persons who might be available as Prefects, the policy of AC has been to encourage this as much as possible.
  7. In the early days in Sicily, most appointees were non-career officials. As more and more territory became liberated, and was returned to the Italian Government, the Government became concerned about having non-career officials in the Prefectures. They wanted to assume full responsibility of internal administration and consequently AC agreed to cooperate with the Government as much as possible in the fulfilment of that objective. It was the Government's insistence that the best assurance of good administration was by having career Prefects in charge of the Prefectures. AC never accepted this as a fundamental principle, but agreed to give the Italian Government as much a free hand as possible. The extracts from interviews which are appended to this note confirm the position

taken by AC.

8. With the advance of the Allied Armies north, it became apparent that many provinces would be liberated all at once, instead of one at a time, and that consequently it was necessary to provide a pool of Prefects from which officials might be drawn for Provinces as they were liberated. We pointed out to the Italian Government that a shortage of trained personnel made it imperative that non-career officials be appointed, possessing the necessary integrity and competency, in lieu of career officials. This idea was accepted grudgingly by the Government, but wholeheartedly when it was agreed by us that the title of the non-career man would be "Prefetto Reggente" instead of "Prefetto del Regno".

9. When the AC and the Italian Government moved to Rome, AC continued to press the idea of having non-career officials appointed as Prefects. In order to ensure the maintenance of competent administration, so far as details of procedure were concerned, the AC proposed the appointment of trained Vice Prefetti Vicari in the cases where such non-career men were appointed Prefects. This is the agreed policy of AC and the Italian Government and represents the attitude of AC long before CANEVARI became a member of the first BOMONI Government. Never has the AC refused the proposal to appoint a non-career official for the position of Prefect on either the grounds that he was not a career man or because of his politics. Furthermore, never has the Italian Government refused an AC proposal of a non-career Prefect in AMG territory.

10. Taking the statements of NEMMI seriatim:

Statement No. 1

11. "But it is our opinion that 15 months after the conclusion of the armistice, the Italian Government should be free to reorganize her interior administration."

The AC has never opposed this. On the contrary, it has given the Italian Government every encouragement to do that. In instances where it has been called in, it has always been in the position of an advisor and has always attempted to have the Italians assume full responsibility. Further, it should be pointed out that at the present time there is a commission composed of Italians which is now considering the whole matter of re-organization of the Italian administrative structure. In this instance, the AC has not interfered in the slightest, and as a matter of fact knows nothing about the work that is being undertaken. The position of AC here is simply that "the Italian Government should be free to reorganize her interior administration".

Statement No. 2

12. "Nearly all the Prefects to whom the administration of the liberated provinces is entrusted are still career officials of the Fascist period."

The wording of this statement is calculated to lead to the inference that career officials were appointed by the Fascists because of their Fascist activities. As a matter of fact, all the career officials who were appointed in liberated territories were persons who started their administrative careers

10. Taking the statements of NENNI seriatim:

Statement No. 1

11. "But it is our opinion that 15 months after the conclusion of the armistice, the Italian Government should be free to reorganize her interior administration."

The AC has never opposed this. On the contrary, it has given the Italian Government every encouragement to do that. In instances where it has been called in, it has always been in the position of an advisor and has always attempted to have the Italians assume full responsibility. Further, it should be pointed out that at the present time there is a commission composed of Italians which is now considering the whole matter of re-organization of the Italian administrative structure. In this instance, the AC has not interfered in the slightest, and as a matter of fact knows nothing about the work that is being undertaken. The position of AC here is simply that "the Italian Government should be free to reorganize her interior administration".

Statement No. 2

12. "Nearly all the Prefects to whom the administration of the liberated provinces is entrusted are still career officials of the Fascist period."

The wording of this statement is calculated to lead to the inference that career officials were appointed by the Fascists because of their Fascist activities. As a matter of fact, all the career officials who were appointed in liberated territories were persons who started their administrative careers at the lowest rank when they were very young men and by a series of promotions according to the Italian civil service law, they eventually were promoted to the rank of Prefect. Many of them were promoted to the rank of Prefect after the liberation of part of Italy and were promoted by the Government supported by the Allies. Furthermore, never has the politics of the Prefect been inquired into except his Fascist politics, if any. In that case, he was rejected. It is to be noted further that at the present time all Prefects are undergoing investigation and trial by the Spuration Commission in the Ministry of Interior, and those found unworthy because of Fascist activity are being suspended by the Italian Government.

13. Of the 52 provinces liberated to date, 14 have non-career Prefects about 27%. It is interesting to observe that of the 20 Provinces liberated since the fall of Rome, including the northernmost one of Lucca, 8 Prefects are non-career. In other words, 40% of the recently liberated Provinces have non-career Prefects. It should be emphasized that even in this case, as in the case of career Prefects, the Allies have never been interested in advancing or rejecting a nominee on the grounds of his politics (except of course Fascist and anti-Allies views).

Statement No. 3

14. "During the first Bonomi Government, the Socialist CANEVARI, Undersecretary for the Interior, proposed 57 anti-fascists, accurately chosen, to substitute these Prefects. At the time of his resignation only three of the proposed substitutions have been approved by the Allied Commission, without the approval of which no such substitution of this kind can take place."

This statement, because of its vagueness and ambiguity, also implies that the AC has refused to approve 57 proposed nominees. It begs several questions. Did CANEVARI propose them to the Government of which he was a part, or to the AC? The first part of the question we are unable to answer, but it is certainly not true that 57 names were proposed to AC to replace these Prefects. Never has either an official list of proposed non-career officials or separate names been submitted to the AC by the Italian Government for re-

Statement No. 4

Minister stated he was anxious to replace Fascist officials but referred to difficulty of finding suitable alternatives. Lt. Col. DECLARATIONS OF NENNI TO THE LONDON PRESS

Pietro Nenni before leaving London made the following declarations:

"I came to London for two reasons:

As an Italian I wanted to call the attention of the British to the situation that has developed in my country, to the difficult conditions in which Italian democracy finds itself in its first steps and to the need we have of finding support in the trust of the European and American democratic movements. As a socialist I came to explore the problem of the reconstruction of the "International".

On the lines of my first mission, I succeeded in gathering flattering promises; in the second the first moves are already being made.

Naturally the economic problems of Italy are extremely difficult and it will take some years before a solution can be reached. SUBJECT: Additional Officer for Interior Sub-Commission

TO : Vice President, Administrative Section

1. The Interior Sub-Commission is now working under a considerable handicap owing to manifest inadequate officer personnel.

2. I have every hope that on Captain S. D. Elliott's return from his temporary assignment at AFHQ, the position will be better, but I wish to state emphatically that his return will not lessen the firmness of this, my present application.

3. For some reason best known to the then ruling authorities and to G-1, this Sub-Commission has been persistently starved of personnel and of competent personnel who have the knowledge and the ability to deal with the intricacies of local government which require considerable study, research, and detailed application.

3. I have previously applied for Captain Dollard (A), now assigned to Region 3. I have met him personally, and was impressed by, (a) his personality, (b) his knowledge of Church affairs, and Italian language, and (c) his grasp of the problems of local government administration.

4. My application in his personal respect was, however, blocked for some reasons which were never conveyed to me, and which were entirely confused with the departure of Captain S. D. Elliott, which has, in effect, no bearing on this application.

5. The work of this Sub-Commission is growing in volume and importance daily, particularly since the restoration of Royal Italy, frequent contacts with the Ministry of Interior, and the question of appointments or removals of local government officials. The question of release of prisoners of war required for local government by the Royal Italian Government, is another problem which requires, and will require increasingly, the services of a competent, intelligent and reliable officer, which I believe Captain Dollard to be. 7159

6. This Sub-Commission is working under a serious handicap and I cannot conceive that Captain Dollard could be better fitted into any position than in the position which I should assign him to in this Sub-Commission.

7. I make this specific application, therefore, in the hope that it will be given full support.

(A) Mission.

The recreation of an efficient and honest administration of the country's internal affairs to be carried out by the Ministry of the Interior having regard to the general functions of the Allied Control Commission and in particular to

- (1) the abolition of the fascist system
- (2) the enforcement of the Armistice terms and of the surrender agreements or other arrangements relating thereto.

(B) Major Functions

1. (1) To review as and when deemed necessary all appointments made to, and the conditions of service under the Central, Provincial, and Communal administration.
  - (2) To determine whether the organization and control of services which function under the Ministry are adequate for and in accordance with the purposes and conditions of A. above.
  - (3) To ensure, where there is departure from or failure to observe such conditions that the necessary steps are taken to effect compliance therewith.
- II. To ensure that an efficient system of Provincial and Communal administration is organized and conducted in such form as is necessary to give effect to A. above, together with any amendments or alterations of such system which may be required for that purpose.

III. To secure uniformity throughout all areas in regard to the system of local government referred to in II above.

IV. To take all necessary action in regard to the financial policies and plans of local government, regardless insofar as they concern the Ministry.

V. To ensure that the Ministry of Interior adopts an impartial and proper relationship with regard to religious bodies and to secure the just distribution of government funds connected therewith.

VI. To consider and report on applications for the release of such Italian prisoners of war as are necessary and required for special work connected with Communal, Provincial, Regional, or Allied Control Commission Administration.

APPENDIX 1

General Functions Allied Control Commission

- 4. The general functions of the Allied Control Commission, as laid down in the directive of the Combined Chiefs of Staff, are as follows:

  - (b) To insure that the conduct of the Italian Government conforms to the requirements of an Allied Base of Operations, especially transportation and communications.

APPENDIX 2

Functions and General Duties of ACC Officers in the Field

- 9. Particulars as to the nature of the duties of ACC field officers will be specified by the submissions to which they are assigned. However, the following guides are applicable to all:
  - (a) The primary function of ACC officers in the field will be to give assistance and guidance to and to supervise the local Italian officials and to convey such instructions to them as may be authorized either in specific instances or generally under this and further directives.
  - (d) Particularly during the transition stage and until the authority of the Italian Government is fully established and the administrative machinery is functioning smoothly, the Italian officials will probably require considerable advice, information and assistance from ACC officers. It is entirely proper in this way to support the authority of the Italian Government.

APPENDIX 1

General Functions Allied Control Commission

4. The general functions of the Allied Control Commission, as laid down in the directive of the Combined Chiefs of Staff, are as follows:

- (a) To enforce and execute the instruments of surrender under the orders and general directives of the Allied Commander-in-Chief.
- (b) To insure that the conduct of the Italian Government conforms to the requirements of an Allied Base of Operations, especially transportation and communications.
- (c) To be the organ through which the policy of the United Nations towards the Italian Government is conducted and the relations between the United Nations and the Italian Government are handled.

APPENDIX 2

Functions and General Duties of ACC Officers in the Field

9. Particulars as to the nature of the duties of ACC field officers will be specified by the Subcommittees to which they are assigned. However, the following guides are applicable to all:

(a) The primary function of ACC officers in the field will be to give assistance and guidance to and to supervise the local Italian officials and to convey such instructions to them as may be authorized either in specific instances or generally under this and further directives.

(d) Particularly during the transition stage and until the authorities of the Italian Government is fully established and the administrative machinery in functioning smoothly, the Italian officials will probably require considerable advice, information and assistance from ACC officers. It is entirely proper in this way to support the authority of the Italian officials. Care should be taken, however, not to interfere directly or to give the appearance of interfering directly in or with the local administration except in real emergency.

10(e) Generally there will be no ACC field officers in the command or in a position comparable to that of the CAO or CASO under AEC. General administration will, therefore, be subject to ACC control at the provincial level. Such local inspection as may be required will be worked out from ACC regional or provincial HQ.

(b) In the transition stage and until the Italian administration is functioning satisfactorily ACC personnel will, subject to subparagraph (a) above, be disposed on a basis approaching that of AMB, an effort will be made to reduce numbers as quickly as conditions permit.

APPENDIX 3

Regional Organization

11. It is understood that the Italian Government intends to appoint Italian Regional Commissioners in certain areas to function until the Italian Government can effectively communicate with and maintain control of the provinces, in other areas to be turned over, the Italian Government may communicate directly with the provincial officials. In either case, ACC will initially appoint a Regional Control Commissioner. In regions in which there is an Italian Regional Commissioner the ACC will, under directives of ACC headquarters, establish control at the regional level and work with his Italian counterpart. In regions where there is no Italian commissioner the ACC will serve as channel for communication with ACC personnel in the field and as a regional representative of ACC HQ.

APPENDIX 4

Attitude toward Italian officials

12. The members of the Commission, whether acting officially or otherwise, should maintain a correct attitude toward members of the Italian Government, neither egotistic on the one hand nor familiar on the other.

It must be emphasized that the Allied Control Commission occupies a position in relation to the Italian Government which is quite different from that of Allied Military Government. The Commission advises and supervises; it does not govern. This fundamental difference must be thoroughly understood by all officers who will adjust accordingly their attitude toward Italian officials and agencies, allowing them to develop their functions without undue interference.

If basic differences arise between officers of this Commission and the corresponding representatives of the Italian Government, the matter at issue will be submitted to the Chief Commissioner for adjustment with the head of the Italian Government.

MEMORANDUM

TO: Liaison Officers, Interior Sub-Commission

1. The following instructions are to be noted and carefully adhered to by all Liaison Officers of this Sub-Commission who are detailed to Regions.
2. Your duty as a Liaison Officer has a dual capacity
  - (a) You will report to this HQ in accordance with orders laid down, e.g. this HQ's instructions of 6 January 1944.
  - (b) You will assist the RCAG(RCC) of the Region at his request in all matters appertaining to the sphere of this Sub-Commission.
3. You are herewith given copies of
  - (a) The Directive of this Sub-Commission.
  - (b) A copy of Administrative Instructions issued to Regions in regard to the structure of local Government.
4. You will make direct investigations when called upon to do so by this HQ, in regard to matters and personalities arising from the new duty entrusted to this Sub-Commission, via "requests for information relative to Prisoners of War and Internees".
5. On no account will you personally take any direct action or issue any order in your Region except through and with the full permission of the RCAG(RCC).
6. Your main duty is to maintain a close and detailed study of the position, activities, organization, and development of local government at all levels and in all provinces within the Region to which you are assigned. Information as to the names and dates of appointment of local government officials will be obtained and submitted on forms issued to you for this purpose. These will be supplemented by commentaries on particular officials and by subsequent reports showing replacements and new appointments.
7. At this stage, a complete survey and report of local government organization, as now existing, in all the provinces of the Region to which you are assigned is an immediate field of work to which your energies should be directed. Attached is a pro-forma which will clarify the field which you are expected to cover.
8. Copies of all your reports, with the exception of your weekly reports, should be submitted to your RCAG(RCC). 7151
9. You may be required to make personal contact with this HQ and may be called in for that purpose. In each case you will notify your RCAG/RCC of your departure and of the estimated period of absence.

10. Your post is one calling for diplomacy, tact, and smooth working. It will not be possible for you to achieve the best results unless you bring these qualities to bear on your work.

11. It is hoped that by your work in the field you will relieve the HGOAC(HGO) and his officers of a considerable amount of work in connection with the sphere of this Sub-Commission, and that you will earn his appreciation of your activities, your advice when needed, and relief of his officers from the particular problems assigned to Interior.

12. Your contact with the various Provinces must be continuous, and further development must be reported promptly. This will not be obtained by remaining at HQ but only by going out to Provinces, and where necessary, Communes, personally, if necessary.

13. Transport is not an easy factor in the situation. But here again it becomes a question of real liaison. You must seek the opportunity of accompanying Regional officers who are making tours in the same direction as you are, and of using ingenuity and natural common sense in procuring transport for your return journey.

It is certainly not possible at present to elicit any vehicle to you from this HQ. I can here end the paragraph by stating "where there is a will, there is a way".

14. There is, as yet, no directive in regard to your work in regard to Prisoners of War and Internees' release. They will be forwarded when ready, but in each individual case in the interim, full specific instructions will be sent.

15. Your whole success in your appointment lies in two main factors

 SUBJECT : RELATIONS OF THE CENTRAL ADMINISTRATION WITH THE ITALIAN AUTHORITIES IN THE PROVINCES UNDER DIRECT ALLIED CONTROL.

Instructions of a general or particular nature are, on occasions, being sent by branches of the Central Administration directly to the Italian Authorities in the Provinces at present under Allied Control. These instructions cannot be carried out since, as you know, by agreement with the Allied Military Command, A.M.G. is the controlling authority in these Provinces as long as military exigencies prevail over civil.

As regards matters of a general nature (whether laws or ministerial instructions) it is opportune that they should be applied uniformly to all liberated territory. In order to conform to the spirit of the existing agreements, however, it is necessary that your Excellencies should from time to time represent to the A.M.G. the desirability of instructions and laws of the Italian Government being adopted by the Allied authorities and put into force in the Provinces not yet under direct Italian administration.

In this way, not only will further proof be given of the Italian Government's spirit of loyal co-operation but it will certainly result in furthering the collaboration which the Allied authorities are demonstrating.

On the other hand, as regards matters of a particular nature (e.g. the transfer of personnel), I remind your Excellencies that communications should be addressed to the Officers in charge of A.M.G. who have jurisdiction over the territories concerned, as shown on the attached list.\*

Acknowledgement of these instructions is requested.

It will be found that local officials consent with the legislation and procedure in regard to local government bodies, and, upon issuance of the attached General Order (Appendix A), can proceed with its immediate execution.

3. The top position in provincial administration is that of Prefect. Next in order come the Vice-Prefect and Vice-Prefect Inspector (Vice Prefetto Ispettore). When the post of Prefect is vacant, and a suitable civil service career official of the necessary grade and qualifications is not available, a person must be nominated to the position who, beside the requisite executive ability, should have a suitable political background. The same principle applies when a vacancy exists for a Vice-Prefect and no suitable career official is available for appointment.

6. A table of administrative grades of civil service career personnel in the Prefecture is attached for information (Appendix B), together with a chart outlining local government organization in relation to the Ministry of the Interior (Appendix C).

7. The principal organs of provincial government which are to be revived in consultation with the Prefect are the following:

a) CONSIGLIO DI PREFETTURA ("Prefectural Council"): It is normally composed of the Prefect or his substitute, who presides, and two senior Councillors ("Consiglieri") of the Prefecture. Its powers

and

and functions are principally advisory and are regulated by specific laws, although the Prefect may request the opinion of the Council on any matter. It also has certain functions relating to the approval of accounts of communes and certain institutions, in which capacity its composition is enlarged to include additional officials.

b) GIUNTA PROVINCIALE AMMINISTRATIVA ("Provincial Administrative Board"): The formation and functions of this body are regulated by a series of laws and regulations which date from 1865. present emergency conditions, the Giunta Comunale is to be nominated by the Mayor with the concurrence of the Senior Civil Affairs Officer or local Civil Affairs Officer, and the appointments confirmed by the Prefect of the Province. 9. In the selection of members of the above agencies, consideration should be given to various shades of political opinion. Labor and agriculture, including the small farmers, must be adequately represented.

10. For the purpose of securing a proper understanding and a uniform application of these instructions, as well as other matters affecting local government, meetings of all Senior Civil Affairs Officers will be held at regular intervals. Similar meeting of all Prefects will also be held in order to assure a uniform application of the attached General Order (Appendix A) which is being issued to all Prefects in this Region.





6. A table of administrative grades of civil service career personnel in the Prefecture is attached for information (Appendix B), together with a chart outlining local government organization in relation to the Ministry of the Interior (Appendix C).

7. The principal organs of provincial government which are to be revived in consultation with the Prefect are the following:

a) CONSIGLIO DI PREFETTURA ("Prefectural Council"): It is normally composed of the Prefect or his substitute, the president, and two senior Councillors ("Consiglieri") of the Prefecture. Its powers

and functions are principally advisory and are regulated by specific laws, although the Prefect may request the opinion of the Council on any matter. It also has certain functions relating to the approval of accounts of communes and certain institutions, in which capacity its composition is enlarged to include additional officials.

b) GIUNTA PROVINCIALE AMMINISTRATIVA ("Provincial Administrative Board"); The formation and functions of this body are regulated by a series of laws and regulations which date from 1865. It is composed of ten members with the Prefect or his substitute as President of the Board, and includes the following officials of the Prefecture: a Vice-Prefect Inspector, two Councilors, the Chief Accountant ("regionali Capo") and the Intendant of Finance ("intendente di Finanza"). The remaining four members are citizen appointees chosen from experts in legal, administrative or technical matters, nominated by the Prefect and approved by the Senior Civil Affairs Officer acting for Allied Military Government.


