SUBJECT: Defascistisation

TO : Administrative Section

1. With reference the A/CC letter 250 of July 15.
2. The Ministry of Industry, Commerce and Labour has now set up its committees for the purpose of the defascistisation of its personnel.
3. In order to expedite matters it has been considered advisable by the Ministry to appoint sufficient members to constitute three boards.
4. Appended below are the names of the Ministry's nominees. It will be noted that there are three Judges, nine Ministry officials and only one appointment by the High Commissioner for Defascistisation. A request has been forwarded by the Ministry to the High Commissioner for the appointment of two further members in order to complete the three boards. Their names will be communicated to you as soon as we are notified.
