As a result of certain enquiries concerning the Italian Military personnel employed in the Distretti Militari of TRIESTE, GORIZIA and POLA which were set up by A.M.G. for the purpose of dealing with the families and dependents of Italian Army personnel, this H.Q. approached the Italian Ministry of War with a request for more precise information. A translation of their reply is attached.

In reply to your INT/102 of 31 Aug 45 and further to letter 122546/1/1 of 29 Sept 45.

The enquiries which have been carried out following the information given in the letter to which we reply have shown the following results:

TRIESTE DISTRICT: Personnel listed hereunder served as sworn adherents for the whole of the Republican period. From 1st May 45 they passed to the control of the Yugoslav authorities from whom they have received identity cards with the title of "Comrade".

All the a/a personnel have been retained in service by the Allied authorities and thinking therefore that have evaded epuration, they behave impudently to their colleagues, who are not compromised with the fascist pseudo Republic and are still waiting to be re-employed, in such a way as to cause feelings of just resentment.

This Ministry can take no action in the matter as a result of instructions given by M.M.I.A. in letter SD/34 dated 6 Oct 45; it is felt, however, that it would be advisable if all personnel, compromised in any way whatsoever, were discharged and replaced as soon as possible.

Your reply on the matter would be appreciated.
