Dear Sir,

I am in receipt of your letter of the 20 Nov.

Certainly the Delegates and Commissions can get to work at once, but until DL 702 is implemented in the North they can only work under DL 159 which, since the latter is in general wider in its powers, will cause them little inconvenience since they need only work within the narrower sphere of DL 702. They must only be careful not to do anything which is not permissible under DL 159.

ROME, 20 November 1945

Dear Colonel,

Reference our conversation of 15 inst. in which I expressed the advisability that the Allied Government should implement in the territory still under its jurisdiction, D.L. No. 702 of 9 November 1945 and D.L. No. 159 of 27 July 1944 mentioned in the former, will you kindly advise me, should my request be accepted, if the delegates and the Commissions appointed by the legitimate bodies of the ROME Government, in pursuance of the provisions set out by the above-mentioned decrees, may assume their office beginning from the effective date in question, without awaiting any further communication from the Allied Government in regards to the appointments already made.

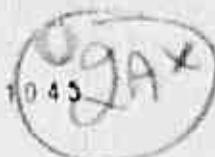
